We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. THE PLAN

The following description of the Russell Sage College Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory defined contribution 403(b) plan established for employees of Russell Sage College (the College or Employer). The Plan is administered by management of the College and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan assets are held by Teachers Insurance and Annuity Association (TIAA), and College Retirement Equities Fund (CREF).

#### **Eligibility**

Eligibility is immediate upon employment commencement date for all employees other than student employees. Employees who work a minimum of one year and at least 1,000 hours or more per year and are at least twenty-one (21) years of age are eligible for matching contributions. Temporary employees are not eligible for matching contributions.

#### **Contributions**

The Plan permits participants to contribute a portion of their compensation as a pre-tax deferral, a Roth deferral, up to the maximum limits on employee contributions set forth by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions as well as qualified organization catch up contributions for participants who have completed at least fifteen years of service with the College. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Effective January 1, 2024, the Plan automatically enrolls eligible participants for salary deferral under its Automatic Enrollment feature. Under Automatic Enrollment, 3% of the participant's eligible compensation will be contributed to the Plan as pre-tax contributions unless the participant elected to either not make elective deferral contributions or contribute a different percentage. The automatic deferral percentage is subject to a 1% increase annually up to a maximum of 10% of participants eligible compensation.

The Employer match provides dollar-for-dollar matching contributions of 2%-5% provided the participant completes one consecutive year of service with the College and contributes at least 2% as a pre-tax deferral.

#### **Vesting**

Participants are immediately fully vested in all contributions and actual investment earnings and losses thereon.

## 1. THE PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contributions (including rollovers) and the participant's allocable share (if any) of (a) the College's pro rata contribution and (b) Plan earnings, losses and administrative expenses. Allocations of the investment earnings are based upon each participant's holdings in each of the Plan's investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

The Plan currently offers several registered investment company accounts, variable annuity contracts, fixed annuity contracts, and a pooled separate account. Participants may change their investment options daily.

### **Payment of Benefits**

Upon termination, retirement, death or permanent disability, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account. Distributions of a participant's account are made in the form of installments or lump-sum payments.

### **Hardship Withdrawals**

Prior to age 59  $\frac{1}{2}$ , a participant may withdraw only his or her participant contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

### **Administrative Expenses**

The Plan permits the payment of Plan expenses to be made from Plan assets. Substantially all administrative expenses associated with the Plan are paid by Plan participants as a reduction of investment income.

### **Notes Receivable From Participants**

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000, or 50 percent of their account balance. No loans less than \$1,000 will be made. Generally, loan terms may range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at varying rates based upon how the participant's retirement balance is invested. Principal and interest is paid ratably through payroll deductions.

### **Plan Loans**

Plan loans made through TIAA and CREF are issued directly from funds owned by TIAA and CREF and collateralized by Plan investments. Therefore, the Plan does not report these loans as assets in the accompanying statements of net assets available for benefits. Outstanding Plan loans were approximately \$59,000 and \$56,000 at December 31, 2024 and 2023, respectively, with interest rates ranging from 4.00% to 4.64%. There were approximately \$59,000 and \$56,000 outstanding Plan loans in default status as of December 31, 2024 and 2023, respectively.

### **Reclassifications**

Certain reclassifications have been made between interest and dividends and net appreciation in fair value of investments for the year ended December 31, 2023 to be in conformity with the current year presentation. These reclassifications had no effect on previously reported change in net assets available for benefits.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. During 2024 and 2023, there were no delinquent loans reclassified as distributions.

### **Investment Valuation and Income Recognition**

The Plan invests in registered investment company accounts, pooled separate accounts, variable annuity contracts, and fixed annuity contracts. Registered investment companies, pooled separate accounts, non-benefit responsive fixed annuity contracts, and variable annuity accounts are reported at fair value. Fully benefit responsive fixed annuity contracts are stated at contract value, as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant-directed.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly. The plan has no investments valued utilizing level 2 inputs.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Non-benefit responsive fixed annuity contracts:* Value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

*Registered investment companies and variable annuity contracts:* Valued at the net asset value of shares held at year end based on quoted prices in active markets.

*Pooled separate accounts:* The fair values of interests in pooled separate accounts are measured based upon Net Asset Value ("NAV") published on a daily basis using the fair value of the fund's underlying assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

#### 5. FIXED ANNUITY CONTRACTS

The Plan's investment in fixed annuity contracts is comprised of guaranteed insurance contracts established between the Plan's participants and TIAA and CREF. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate.

## **5. FIXED ANNUITY CONTRACTS (Continued)**

The Plan has non-benefit responsive fixed annuity contracts with TIAA and CREF, totaling \$27,896,059 and \$28,050,149 at December 31, 2024 and 2023, respectively, and fully benefit-responsive fixed annuity contracts with TIAA and CREF totaling \$8,187,019 and \$7,959,666 at December 31, 2024 and 2023, respectively. TIAA and CREF maintain Plan contributions in separate accounts. The accounts are credited with contributions and earnings on the underlying investments and are charged for Plan withdrawals.

For fixed annuity contracts, TIAA and CREF determine contract value, which approximates fair value, using two different methods, a discounted cash flow model and a theoretical transfer value. The discounted cash flow method is calculated using a risk-adjusted market discount rate, which correlates closely with the Plan's fixed annuity interest rate. The interest rate associated with the Plan's Fixed Annuity Contract can range from 4% to 7% based on the current market environment. The theoretical transfer value method presumes that contributions into the annuity represent transactions between a willing buyer and seller, and therefore, establish a market.

The fixed annuity contracts guaranteed minimum returns are supported by the TIAA and CREF General Account portfolio, which invests primarily in U.S. debt instruments and investment grade corporate bonds; however, is also permitted to invest in higher risk securities, including but not limited to, sub-investment grade corporate bonds, common stock, and real estate. The assets and earnings from this portfolio are used to pay the guaranteed interest rate associated with the annuity contracts, as well as future annuity payments.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the College has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their account.

## **7. INCOME TAX STATUS**

The IRS has determined and informed TIAA by a letter dated August 1, 2017 that the volume submitter plan adopted by the Plan effective January 1, 2019, as then designed, is in compliance with the applicable sections of the IRC.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

## **8. PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows participants of the Plan to invest in certain funds that are managed by TIAA and CREF. As such, transactions between the participants investing in these funds and the Plan qualify as party-in-interest transactions.

The Plan also allows participants of the Plan to receive participant and plan loans under specific circumstances. As such, transactions between the participants that have notes receivables with the Plan qualify as party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 7, 2025, which is the date the financial statements were available to be issued.
