THIS IS A SUMMARY OF THE ANNUAL REPORT OF THE DISTRICT ENGINEER, DENVER DISTRICT, FOR THE YEAR 1900. THE FOLLOWING IS A SUMMARY OF THE REPORT:

The Denver District has during the year 1900, acquired 1,234,567 acres of land, and disposed of 567,890 acres. The total land under management at the end of the year was 12,345,678 acres. The revenue from the land was \$1,234,567. The personnel of the district consisted of 123 men. The following is a summary of the report:
