INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
New Glarus Brewing Company 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of New Glarus Brewing Company 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Notes to Financial Statements

December 31, 2024 and 2023

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - New Glarus Brewing Company 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through July 8, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - New Glarus Brewing Company is the plan sponsor, employer and the plan administrator. Principal Life Insurance Company is the custodian that holds the plan's pooled separate accounts and guaranteed option. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the custodian that holds the plan's mutual funds. The two Principal entities are collectively referred to as "Principal". Principal is the recordkeeper, third party administrator and tax counsel. Prior to July 8, 2024, Northwestern Mutual was the plan's investment advisor. Effective July 8, 2024, Commonwealth Financial Network assumed the responsibilities of the plan's investment advisor. The president of the plan sponsor is the plan trustee.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in the fair values of investments bought, sold or held during the years is reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Pooled separate accounts - These investments are direct filing entities valued at the net asset value ("NAV") as provided by Principal. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the pooled separate account would sell the investment for an amount different than the reported NAV.

Mutual funds - Valued at the daily closing price as reported by the funds. Mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

Investment at contract value - The Principal Guaranteed Option is a guaranteed general account backed group annuity contract issued by Principal. A rate of interest is contractually guaranteed by Principal. The interest rate is reset at least semiannually.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value in accordance with GAAP. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. The plan sponsor can request a lump sum distribution subject to either a 12-month irrevocable advance notice or 5% surrender charge, whichever the employer chooses. An additional 5% surrender charge will also result from the occurrence of certain other events as more fully described in the investment contract. The contract will continue in full force until all assets have been distributed or no further payments are due.

The plan's ability to receive amounts due is dependent on Principal's ability to meet its financial obligations. Principal's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with Principal. As of the date these financial statements were available to be issued, the plan sponsor is not aware of any events that are probable of occurring that might limit the ability of the plan to transact at contract value with Principal or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on January 1, 2009 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to the plan once they have completed one month of service and have reached age 18. An employee can enter the plan the month following meeting the eligibility requirements. Employees are eligible to receive employer contributions once they have completed one year of service (defined as 1,000 service hours) and have reached age 18. An employee will receive employer contributions at the start of the quarter following meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 4% of compensation withheld as deferral contributions, unless they otherwise opt-out or update their deferral percentage. Participants who were auto enrolled then automatically have their deferral percentages increase by 1% each year until they reach a maximum of 8%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer safe harbor matching contributions are made equal to 100% of the first 6% of employee compensation contributed to the plan as elective deferral contributions. All employer safe harbor matching contributions are remitted to the New Glarus Brewing Company Employee Stock Ownership Plan ("ESOP"), another qualified defined contribution plan sponsored by the employer, on an annual basis.
- d. Nonelective contributions may be made at the employer's discretion. No such contributions were made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions, rollover contributions and an allocation of any employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each payroll.

Vesting - Participants are always 100% vested in their employee elective deferral contributions, rollover contributions and employer safe harbor matching contributions and related earnings. Participants are not vested in any discretionary nonelective contributions and related earnings until they are credited with three years of service, at which time they become 100% vested. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Distributions are generally required to be in the form of a single lump sum. In addition, hardship withdrawals are permitted under certain circumstances and in-service withdrawals can commence upon attaining the age of 59½.

Administrative fees - Certain fees and expenses of the plan are paid by the plan sponsor. Certain other plan expenses are paid with plan assets and recorded by the plan as administrative expenses in the accompanying financial statements. Such expenses are generally participant directed fees paid for distribution and loan processing costs.

Notes receivable from participants - Participants can take out loans against their accounts with approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term cannot exceed 5 years. Participants may not have more than five loans outstanding at any given time. As of December 31, 2024, loans outstanding had various repayment schedules through July 2029, with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Principal. Principal also provides certain administrative services to the plan pursuant to service agreements between the plan sponsor and Principal. Principal receives indirect compensation from mutual fund service providers for services Principal provide to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan to Principal for its administrative services to the plan. Direct fees paid by the plan to Principal were insignificant in 2024 and 2023. Transactions between the plan and Principal qualify as party-in-interest transactions.

Employer contributions related to the plan remitted to the plan sponsor's ESOP and notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in any discretionary nonelective employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan with CODA that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY PRINCIPAL

Management has obtained certifications from Principal, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held, and the fair and contract values of such, and notes receivable from participants as of December 31, 2024 and 2023;
- b. Dividend and interest income from investments, net appreciation (depreciation) of investments and interest on notes receivable from participants during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases and sales of investments and interfund transfers between accounts during 2024 and 2023.
