### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Delta Defense, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

**NOTE 1 - Description of Plan**

The following description of the Delta Defense, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan, as adopted effective June 1, 2012 and restated January 1, 2022, covering substantially all full-time employees that are not part-time, union, or leased of Delta Defense, LLC (the "Company"). An employee becomes eligible to participate in the Plan and receive an allocation of the Company safe harbor match contributions on the first entry date (first day of the month) following completion of two months of service, provided they have reach the age of 18. The Company may also make discretionary nonelective contributions to eligible participants, subject to limitations. To receive an allocation of the Company discretionary nonelective contributions, an employee must have completed 1,000 hours of service during the Plan year and been employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Participants may elect to contribute a portion of their annual compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service ("IRS"). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default set at 5%. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For 2024 and 2023, the Company made a safe harbor match of 100% of the first 5% of base compensation that a participant contributed to the Plan. The Company's safe harbor matching contribution is also invested based on the participant's direction and is remitted after each payroll.

The Company may also contribute a discretionary nonelective contribution at the option of the Company. The participants direct the Company discretionary nonelective contributions into the various investment options. In 2024 and 2023, the Company did not make a discretionary nonelective contribution.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe harbor match contribution, (b) the Company's discretionary nonelective contribution, and (c) Plan earnings (losses), and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting** - Participants are immediately vested in their voluntary contributions, the Company's safe harbor match contributions, and rollover contributions, if any, plus actual earnings (losses) thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service. Participants who are employed on or after their normal retirement age (59 1/2), or are terminated due to death or disability, are automatically 100% vested in all employer contributions.

**NOTE 1 - Description of Plan - Continued**

**Participant Loans** - The Plan includes a provision allowing eligible participants to borrow, from their fund accounts, a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, if the loan is for the purchase of a principal residence, longer repayment terms may be permitted. The loans are secured by the balance in the participant's account and bear a commercially reasonable rate of interest. Interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payments of Benefits** - Upon retirement, death, disability or termination of service, participants with an account balance exceeding \$5,000 may elect to receive the value of his or her vested account balance in a lump-sum distribution, a series of substantially equal periodic installments not to exceed the participant's life expectancy, or partial withdrawals, as described in the Plan's provisions. Participant accounts with a vested account balance that does not exceed \$5,000 are paid in a lump sum as soon as feasible. If an account balance exceeds \$5,000, a participant's consent must be obtained before a distribution may be made. In-service and hardship distributions are also available, subject to certain limitations.

**Administrative Expenses** - All administrative expenses may be paid by the Plan unless paid by the Company. During 2024 and 2023, both the Plan and Company paid expenses.

**Forfeited Accounts** - Forfeitures arise as a result of participant's who terminate service with the Company before becoming 100% vested in the Company's discretionary nonelective contributions. The forfeitures are used to pay Plan expenses or Company contributions. The Company has yet to make a discretionary nonelective contribution, therefore, there have been no forfeitures.

**NOTE 2 - Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedules are as follows:

**Basis of Accounting and Presentation** - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

**Notes Receivable from Participants** - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**NOTE 2 - Summary of Significant Accounting Policies - Continued**

**Contributions** – Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through July 22, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - Concentrations**

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Money Market Fund: Valued at cost which approximates fair market value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - Information Certified by the Plan Trustee**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends earned thereon for the years ended December 31, 2024 and 2023, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the trustee of the Plan. Notes receivable from participants and related interest income were not certified by the custodian.

**NOTE 6 - Tax Status**

The Plan sponsor became a participating employer in the Wipfli LLP Volume Submitter Profit Sharing Plan with CODA effective June 1, 2012, and is relying on its determination letter dated June 30, 2020. The Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 6 - Tax Status - Continued**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 - Transactions with Parties-in-Interest**

Fees for legal and professional services rendered to the Plan may be paid by the Plan sponsor at its discretion. The Plan invests in a money market fund and cash account that are managed by the trustee. Additionally, the Plan allows participants to take out loans against their account balances. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan**

Amounts owed to participants who had elected to withdraw from the Plan, but had not been paid totaled \$37,412 and \$0 as of December 31, 2024 and 2023, respectively.

**NOTE 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 10 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested with all rights to any funds in the participants' accounts.
