**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Halloran & Sage LLP Retirement and Deferred Salary Plan (the “Plan”), sponsored by Halloran & Sage LLP (the “Company”), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution profit sharing plan and trust with a deferred 401(k) arrangement, established by the Company as of January 1, 1969. Participation in the Plan’s 401(k) arrangement is discretionary for all employees as of their employment commencement date. Employees are eligible to share in the Company’s contributions upon completion of two years of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** - The Company contributes an amount equal to 3.5 percent of the pre-tax compensation earned by each eligible participant, other than partners and Chief Operating Officer, as defined in the Plan.

The Company makes contributions on behalf of the partners and Chief Operating Officer of the Company in amounts calculated using the estimated income allocated to each partner or the Chief Operating Officer, not to exceed \$345,000 and \$330,000 for the years ended December 31, 2024 and 2023, respectively. The contributions range from 3.5 percent to 10.5 percent, based on the age attained by the partner or the Chief Operating Officer as of each year-end.

Additionally, eligible participants and partners who elect to participate can make pre-tax contributions to the Plan in an amount up to 100 percent of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Total participant and partner contributions are subject to limitations imposed by the Internal Revenue Code.

The Plan includes an auto-enrollment provision whereby all employees and partners are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. Effective January 2021, the Plan provides for an auto escalation of the automatic deferral percentage of 1 percentage point per year to a cap of 10 percent of eligible compensation.

***Participant Accounts*** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's profit sharing contribution, if any, and (b) Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting*** - The Plan provides that participants shall be fully vested in their account balances at all times.

***Payment of Benefits*** - Participants or their beneficiaries are entitled to receive the entire amount of their interest in the Plan upon retirement, death, disability, employment termination, reaching age 59 ½ or qualifying for a "Hardship Distribution" as defined in the Plan. Upon termination of service, a participant may elect in writing to defer benefit payments until a date no later than his/her normal retirement date. A terminated employee may elect to receive the balance in his/her account in the form of a single lump-sum payment, a direct rollover, or a series of installments over a specific period of time. For accounts with less than \$5,000, the Company can pay the participant in a lump sum at any time after the participant leaves the Company.

***Investment Options*** - Upon enrollment in the Plan, a participant may elect a number of various investment options consisting mainly of pooled separate accounts. The Plan also offers the Guaranteed Income for Life product which includes an insurance component and is intended to provide participants with a steady stream of secure retirement income. All investment transactions are participant directed. As such, participants may make transfers among investment funds at their discretion in whole percentages. In addition, participants may elect to change their investment options up to a maximum of twice per month for assets invested with John Hancock.

***Hardship Withdrawals*** - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan.

***Plan Expenses*** - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. The Company pays administrative expenses when there is insufficient funds in the John Hancock plan expense reimbursement account. Investment related expenses are included in net appreciation of fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

*Notes Receivables from Participants* - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum payment term for any loan is fifteen years. The minimum loan is \$1,000. The loans bear interest at rates commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements are presented on the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recognized when paid.

Retiring participants invested in the Guaranteed Income for Life product can receive a guaranteed annual income amount, which is calculated based on participants' vested benefit base in the Guaranteed Income for Life product upon satisfying both an age and holding period requirement. The annual income amount is secured with insurance contracts and is guaranteed for life, even if the participant's balance in the Guaranteed Income for Life product becomes exhausted during retirement. Withdrawal from the Guaranteed Income for Life product reduces the benefit base and will reduce the future income amount. Fees associated with this investment product are charged to the invested participants and were \$34,540 during the year ended December 31, 2024.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

**Risks and Uncertainties** - The Plan provides the participants with various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Fair Value Measurements** - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

**Disclosure of Subsequent Events** - Plan management has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company ("John Hancock"), the Custodian for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock:

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

During 2024, there were transactions involving the investment of Plan assets in accounts maintained by John Hancock, a party-in-interest, as defined under Section 3(14) of ERISA.

John Hancock receives revenue from fund service providers for services John Hancock provides to the funds. This revenue is used to offset certain amounts owed to John Hancock for its administrative services to the Plan. John Hancock shares a portion of the revenue generated from such fund service providers with the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there was \$10,352 of revenue sharing which will be allocated to participant accounts during 2025.

**NOTE 5 - INVESTMENTS MEASURED AT NAV USING THE PRACTICAL EXPEDIENT**

The Plan's pooled separate accounts are measured at NAV as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

Investments measured at NAV, which represents investments at fair value were \$44,126,955 and \$42,765,740 at December 31, 2024 and 2023, respectively. Participants can redeem their investments in pooled separate accounts daily without notice. There are no unfunded commitments.

As the plan invests in pooled separate accounts for which there is no Form 5500 filed as a direct filing entity, the Plan must provide the following description of significant investment strategies:

- Bonds - Seeks to provide high level of current income with potential for capital appreciation.
- Stable value - Seeks to preserve capital by investing in benefit responsive contracts offered by insurance companies and banks.
- Small cap - Seeks to provide long-term growth of capital by primarily investing in companies with small market capitalizations.
- Lifestyle - Seeks long-term growth of capital by primarily investing in equity securities and fixed income securities with allocations differing based on the profile of the fund (i.e. balanced, aggressive, etc.)
- Target funds - Seeks to provide capital appreciation and current income with an asset allocation designed for those planning to retire and leave the workforce within a few years of the target date.
- Mid cap - Seeks to provide long-term growth of capital by primarily investing in companies with mid-market capitalizations.
- Large cap - Seeks to provide long-term growth of capital by primarily investing in companies with large market capitalizations.
- International - Seeks to provide long-term growth of capital by primarily investing in common stocks of foreign issuers.
- Select - Seeks current income and growth of capital, while seeking to both manage the volatility of return and limit the magnitude of portfolio losses based on the profile of the fund.
- Specialty - Seeks to provide capital appreciation by primarily investing in stocks of issuers that are being traded at a discount, real estate trusts, and precious metals.

**NOTE 6 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 - TAX STATUS**

During 2022, the Plan sponsor adopted a Dataair Employee Benefit Systems Inc. standardized prototype plan which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2020.
