Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of California Bank of Commerce Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 13, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period ended January 13, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of California Bank of Commerce Profit Sharing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 13, 2025 and December 31, 2024, and for the period ended January 13, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter – Plan Merger

As further discussed in Note 6, on November 7, 2024, the Plan's governing body approved a merger into California Bank of Commerce, NA 401(k) Profit Sharing Plan, an Empower Retirement, LLC Defined Contribution Pre-Approved Plan. Accordingly, the Plan's assets were transferred into the surviving Plan on January 13, 2025. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about California Bank of Commerce Profit Sharing 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following description of California Bank of Commerce Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of California Bank of Commerce (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established on January 1, 2008.

As discussed in Note 6, the Plan was amended and subject to a merger effective January 1, 2025. All Plan provisions in this report pertain to Plan activity prior to this amendment and merger.

Administration

CBIZ, Inc. serves as the third-party administrator and investment advisor for the Plan. American United Life Insurance Company is the recordkeeper and custodian of the Plan's participant-directed investments.

Eligibility

An employee is eligible to participate in the Plan, for all contribution types, upon attaining age 21 and completing 3 months of service. The Plan excludes union employees, non-resident aliens, interns, and temporary and seasonal employees. The Plan entry date is the first day of the month coinciding with or following the date eligibility requirements are met.

Contributions

Eligible employees ("participants") may contribute a portion of their annual compensation subject to certain limitations as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Company makes a safe harbor non-elective contribution equal to 3% of compensation. There were no safe harbor contributions made during the period ended January 13, 2025.

The Company may make a discretionary matching contribution. The Company may also make a discretionary profit-sharing contribution. Participants are not required to make contributions to the Plan to be eligible for an allocation of the discretionary profit-sharing contribution. Participants must be employed on the last day of the plan year to receive the profit-sharing contribution. There were no discretionary matching or profit-sharing contributions for the period ended January 13, 2025.

Rollover contributions

The Plan provides for rollover contributions, which represents contributions by participants from other tax-qualified retirement plans. The maximum amount of a participant's rollover contribution is not affected by the limits otherwise applicable to participant contributions.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution, and plan earnings, and charged with an allocation of administrative expenses. The contributions are allocated within each participant account based upon the participant's investment elections. Allocations of expenses are based on investment earnings or account balances, as defined. All amounts in participant accounts are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is credited with a year of service upon completion of 1,000 hours of service during the plan year. A participant is fully vested in the Company's contributions after 3 years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear a reasonable rate of interest, which is 1 percentage point over prime interest rate and are determined at the time the note is made. Note transactions are treated as transfers to (from) the investment funds from (to) a participant's note receivable. Principal and interest are amortized and repaid through payroll deductions over the repayment term of five years unless the purpose of the note is to acquire the principal residence for the participant, in which case the repayment term is 15 years.

Payment of benefits

Benefits are payable to participants or designated beneficiaries upon retirement, termination, death, disability, or in-service if the participant has attained age 59 1/2. Distributions may be paid in a lump-sum amount equal to the value of the participant's vested interest in his or her account, payments over a fixed period, or they may be rolled over into another plan or an Individual Retirement Account.

The Plan has a mandatory cash-out provision for account balances up to \$7,000. Benefits are recorded when paid.

Hardship withdrawals

Participants may withdraw their elective deferral contributions in the event of hardship as defined by the Plan agreement.

Administrative expenses

Substantially all the recordkeeper fees for the period ended January 13, 2025 were paid by the Plan Sponsor. All other administration costs are paid directly by the Plan.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Upon termination of employment, the unvested portion of a participant's employer contribution account is forfeited. Forfeitures of employer contributions are available to reduce future Company matching contributions or to pay administrative expenses. During the period ended January 13, 2025, no forfeitures were used to reduce Company matching contributions or to pay administrative expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the period ended January 13, 2025 are reported in net depreciation in fair value of investments in the statement of changes in net assets available for benefits. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes receivable from participants

Principal and interest are paid ratably through payroll deductions. Notes to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document. Plan management has evaluated the collectability of notes receivable from participants and, because they are secured by the participants' accounts, an allowance has not been recorded.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of benefits

Benefits are recorded when paid.

Subsequent events

Management evaluates events occurring subsequent to January 13, 2025, in determining the accounting for and disclosure of events that affect the financial statements. The Plan has no subsequent events that required recognition or disclosure in the financial statements for the period ended January 13, 2025. Subsequent events were evaluated through July 24, 2025, which is the date the financial statements were available to be issued.

NOTE 3. INFORMATION CERTIFIED AND PREPARED BY CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company ("AUL"), the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of January 13, 2025 and December 31, 2024.
- Net depreciation in fair value of investments reflected on the accompanying statement of changes in net assets available for benefits for the period ended January 13, 2025.

NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled separate accounts ("PSA"): PSAs with underlying mutual fund investments are valued based on the observable Net Asset Value ("NAV") of the underlying investment. There are no restrictions on the redemption of these investments. There are no unfunded commitments and redemption may be daily.

The following table set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024:

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

American United Life Insurance Company Stable Value Account

The Plan has a fully benefit-responsive investment contract with American United Life Insurance Company ("AUL"). The contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract value of the investment at January 13, 2025 and December 31, 2024 was \$0 and \$923,841, respectively.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The contract is included in the financial statements at contract value, which approximates fair value, as reported to the Plan by AUL. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6. PLAN MERGER

On November 7, 2024, the governing body of the California Bank of Commerce Profit Sharing 401(k) Plan met and approved a plan merger effective January 1, 2025. The Plan was amended and restated to facilitate a plan merger and plan assets, including outstanding participant notes receivable as well as an employer safe harbor non-elective contribution receivable under the Plan were transferred into California Bank of Commerce, NA 401(k) Profit Sharing Plan (the "Receiving Plan") provided by Empower Retirement LLC.

All plan assets were transferred to the Receiving Plan before the close of business on January 13, 2025. Following the merger, the California Bank of Commerce Profit Sharing 401(k) Plan ceased to exist as a separate plan.

NOTE 7. INCOME TAX STATUS

The Plan document is a CBIZ Benefits & Insurance Services Non-Standardized Defined Contribution Pre-Approved Plan with CODA with an Internal Revenue Service (IRS) opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 13, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan's annual return/report of employee benefit plan filings for the past three years are subject to examination by tax authorities, and may change upon examination.

NOTE 8. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contribution accounts.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 10. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
