**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Cobalt 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Cobalt 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or the *Summary Plan Description* for a more complete description of the Plan’s provisions, which is available from the Plan administrator.

#### A. General

The Plan is a defined contribution plan covering all full-time employees of Clarity Performance Solutions, LLC (the “Company”) or its Affiliates, who have at least one month of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### B. Contributions

Participants may contribute up to 100% of pretax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch up contributions as defined in the Plan.

The Company may, at its discretion, make contributions to the Plan on behalf of the participants. Contributions are subject to certain limitations. The Company matched 100% of the first 1% and 50% of the next 8%, of eligible compensation contributed to the plan, for the year ended December 31, 2024.

#### C. Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### D. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become vested in the matching contributions according to the following schedule:

#### E. Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or one half of their vested account balances. The loan is secured by the balance in the participant’s account and bears interest at rates of 4.25% to 9.5%, which is commensurate with local prevailing rate as determined by the Plan administrator.

#### F. Payment of Benefits

A participant’s interest in the Plan becomes distributable upon his or her termination of employment due to death, retirement, resignation or dismissal, permanent disability, or at such time as the Plan is terminated. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his/her account or a joint and survivor’s annuity.

#### NOTE 1: DESCRIPTION OF THE PLAN (continued)

##### F. Payment of Benefits (continued)

Notwithstanding the foregoing, if the vested value of the participant's account does not exceed, or at any time prior to distribution did not exceed \$5,000, his or her vested account will be distributed in a single lump-sum payment to the participant without the consent of the participant or his or her spouse.

Additionally, the Plan allows for withdrawals to be made from a participant's account once he or she reaches age 59½ or is able to demonstrate financial hardship. A participant may withdraw all or a portion of his or her account balance upon a written request to the Plan administrator.

##### G. Forfeitures

Forfeitures for the year ended December 31, 2024 were \$14,602 and \$9,250 was used to pay Plan expenses. The forfeitures' account balance as of December 31, 2024 and 2023, was \$109,304 and \$100,713, respectively.

#### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit loss has been recorded as of December 31, 2024 or 2023.

##### E. Payment of Benefits

Benefit payments to participants are recorded when paid.

##### F. Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of change in net assets available for benefits. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included with net appreciation of fair value of investments.

##### G. Subsequent Events

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through July 14, 2025, the date of financial statement issuance.

#### NOTE 3: FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include –

- quoted prices for similar assets or liabilities in active markets,
- quoted prices for identical assets or liabilities in inactive markets,
- inputs other than quoted prices that are observable for the asset or liability, and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts

The fair value of participation units held in the Reliance Trust Stable Value Fund (MetLife Series 25053, Class 0), a common/collective trust (CCT) is based on net asset value, as reported by the manager of the collective trust fund, Reliance Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The CCT invests in the MetLife Group Annuity Contracts 25053, which consist of separately managed investment portfolios directed by Reliance Trust. The CCT provides for daily redemptions by the Plan at reported net asset value, with no advance notice requirements.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of the investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, the Trustee.

#### NOTE 6: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the trustee as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to John Hancock Retirement Services for the investment management and administration amounted to \$36,820 for the year ended December 31, 2024.

The Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged. All of these party-in interest transactions are exempt from the prohibited transaction rules of ERISA.

#### NOTE 7: PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue all contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### NOTE 8: PLAN TAX STATUS

The Internal Revenue Service has determined and informed the company by a letter dated May 18, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

#### NOTE 8: PLAN TAX STATUS (continued)

Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for tax periods in progress.

#### NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
