Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Venterra Realty Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Change in Record Keeper and Trustee

As further discussed in Notes 2 and 7 to the financial statements, the Plan Sponsor changed the Plan's recordkeeper and custodian effective March 1, 2025 and adopted a pre-approved defined contribution plan document, also effective March 1, 2025. My opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of the Venterra Realty Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General — The Plan is a defined contribution plan covering substantially all employees of Venterra Realty Management Company, Inc. (the “Company”) upon each employee’s completion of one month of service and are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions — Each year, participants may contribute up to 100 percent of their pretax annual compensation as elective deferral contributions as defined in the Plan. The Plan also permits participants to make catch-up contributions as defined. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan provides for a discretionary matching contribution. The “Matching Contribution” is a percentage of elective participant contributions as determined each year at the sole discretion of the Company. Eligible participants will share in any Matching Contributions if they are in employment on the last day of the plan year and have completed at least 1,000 hours of service and is subject to a six-year vesting schedule, as defined. For 2024, the Company approved a Matching Contribution of 50% of participant’s annual elective deferral contributions up to 5% of the participant’s annual compensation, as defined by the Plan. The Company’s 2024 Matching Contribution of \$402,441 was allocated to eligible participants on January 10, 2025, of which \$399,733 was funded in cash from the Company and \$2,708 was funded from forfeited nonvested accounts.

Effective January 1, 2025, the Plan was amended and will become a safe harbor 401(k) plan, as defined. The discretionary Matching Contribution will be removed and replaced with a safe harbor matching contribution. Each payroll period, the Employer will make a safe harbor matching contribution equal to 100% of a participant’s elective deferral that do not exceed 3% of eligible compensation plus 50% of a participant’s elective deferral between 3% and 5% of eligible compensation. Eligible employees hired on or after January 1, 2025 will become eligible for the safe harbor matching contribution on the first of the month following date requirements are met. The safe harbor matching contributions will be 100% vested.

All contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Vesting — Participants are immediately vested in their elective deferral contributions, rollover contributions, and catch-up contributions. Vesting in employer Matching Contributions is based on years of continuous service. A participant becomes 100% vested after six years of credited service.

Participant Accounts — Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s elective deferral contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments — Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a group annuity contract called the Transamerica Stable Value Option and several pooled separate accounts (defined below) as investment options for participants.

Participant Loans — Participants may borrow from their fund accounts with a minimum loan amount of \$1,000. The loans are secured by the balance in the participant's account and bear interest at prime plus 1.0%, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits — Upon termination of service due to retirement, death, or disability, a participant may elect to receive the value of the participant's vested interest in his or her account, in the form of a lump-sum. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Other payments may be permitted for financial hardship, as defined by the IRC.

Forfeited Accounts — Forfeited accounts are used to reduce any employer contributions or to pay Plan expenses, in accordance with the plan document. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$2,848 and \$1,589, respectively. During 2024, participant forfeitures amounted to \$5,411, of which \$4,191 were used to 2024 administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Presentation — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits — Benefits are recorded when paid.

Administrative Expenses — Under the group annuity contract entered with Transamerica, the contract asset charges are assessed each month based on the actual combined balance of all separate accounts and the stable value fund. These charges are presented as administrative fees in the Statement of Changes in Net Assets Available for Benefits. The Company pays for all other administrative costs of the Plan.

Use of Estimates — The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Market Risk Factors — The Plan provides for various investment options in a stable value fund and in pooled separate accounts with underlying assets consisting of any combination of stocks, bonds, fixed income securities, mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Subsequent Events — The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

Effective March 1, 2025, the Plan Sponsor changed the Plan's recordkeeper and custodian from Transamerica Retirement Solutions, LLC and Transamerica Life Insurance Company to Fidelity Workplace Services LLC and Fidelity Management Trust Company, respectively and adopted a pre-approved profit sharing plan document sponsored by FMR LLC. As a result of the migration to Fidelity (and its affiliated companies), a blackout period commenced February 22, 2025. During this period, recordkeeping services transferred to Fidelity and participant investment options were mapped and transferred to the new investment fund lineup with Fidelity. The conversion process was completed on March 18, 2025. Generally, the provisions and features under the former plan document carried over to the Fidelity plan document.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Separate Accounts — Investments in the separate accounts with Transamerica Life Insurance Company (“Transamerica”) are stated at fair value as reported to the Plan by Transamerica, based on quoted market prices of the underlying mutual funds. The unit value of the separate account is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value, or price per share of the underlying mutual fund. The mutual fund calculates its’ net asset value by dividing the mutual fund’s net assets by the outstanding number of shares of the mutual fund. Those separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets for identical assets. Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

The Separate Accounts are measured at net asset value per share as the practical expedient and have not been classified in the fair value hierarchy in accordance with US GAAP.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Stable Value Fund

Stable Value Fund — The stable value fund is considered to be a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The stable value option is valued at contract value, as reported by Transamerica. Contract value is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement which approximates fair value.

There are no reserves against contract value for credit risk of Transamerica or otherwise. This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U. S. Treasury bills. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and with no set maturity. The effective credited interest rate is set monthly and effective on the first day of the month. Contract charges may reduce this return. The Transamerica Stable Value Option is not a separate account investment choice—it is an investment in Transamerica’s general account. The average yield of the stable value fund based on actual earnings and interest credited to participants yielded 2.45% for the year ended December 31, 2024.

Certain events limit the ability of the plan to transact at contract value with Transamerica. The plan administrator does not believe that any events which would limit the plan’s ability to transact at contract value with participants are probable of occurring.

5. Related-Party Transactions

Plan investments are shares of pooled separate accounts and shares of the stable value option managed by Transamerica Life Insurance Company. Transamerica is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for contract administrator services were \$36,145 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees and/or officers of the Company, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100 percent vested and nonforfeitable.

7. Tax Status

The Plan adopted a pre-approved plan document sponsored by Transamerica Retirement Solutions LLC. Transamerica Retirement Solutions LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code IRC. The Plan itself has not received a determination letter from the IRS; however, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Effective March 1, 2025, the Plan adopted a pre-approved defined contribution plan document sponsored by FMR LLC, a related party to Fidelity. FMR LLC received an opinion letter from the Internal Revenue Service (the “IRS”), dated June 30, 2020, which states that the volume submitter document satisfies the applicable provisions of the Internal Revenue Code (IRC).

8. Certified Investment Information

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Transamerica Life Insurance Company and furnished to the Company.

The Company has obtained certifications from Transamerica Life Insurance Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
