Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The FIRST 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of The FIRST 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document and Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Foundation for Inspiration & Recognition of Science & Technology (FIRST). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Trustee

The trustee to the Plan is Capital Bank and Trust Company (CBT).

Plan Eligibility and Participant Contributions

Plan employees who are scheduled to work more than 1,000 hours a year are eligible to participate in the Plan on the first day of the month following the hire date. Each participant may contribute up to the maximum allowable under law. Participants may also invest amounts representing distributions from other qualified defined contribution plans (rollover).

The Plan has a Roth 401(k) feature which allows the participants to contribute a portion of their annual after-tax compensation to the Plan. Annual limitations on employee contributions apply to pre-tax and after-tax (Roth) contributions in the aggregate.

FIRST Contributions

FIRST may contribute at its discretion, matching and surplus benefit contributions to participants who worked at least 1,000 hours during the year. In 2024, FIRST matched 100% of the first 2% of participants' eligible compensation contributed to the Plan and 50% of the next 3% of participants' eligible compensation contributed to the Plan not to exceed 3.5% of the participants' eligible compensation. In addition, FIRST made a surplus benefit contribution in January 2025, of \$294,500 (\$1,500 per eligible employee) for 2024.

Contributions are subject to certain limitations.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participants' Accounts

Each participant's account is credited with an allocation of the participant's contributions, the FIRST's matching contributions and any surplus benefits or other FIRST discretionary contribution, and Plan earnings (losses). Allocations are based on participants earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures of terminated nonvested account balances from employer discretionary matching and surplus benefit contributions may be used to reduce the amount of future matching and surplus benefit contributions made by FIRST or pay reasonable plan expenses. Unallocated forfeiture balances as of December 31, 2024 and 2023 were \$6 and \$22, respectively. Forfeitures used to reduce company contributions for the year ended December 31, 2024 were \$680.

Vesting

Participants are immediately vested in their contributions, plus actual earnings or (losses) thereon. For FIRST discretionary matching and surplus benefit contributions, participants are vested after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account, and bear interest at the prime rate plus 1%. Principal and interest are paid ratably via payroll deductions. The interest rate on the outstanding loans at December 31, 2024 and 2023 were 9.50% with various maturities through September 2028.

1. Description of the Plan (continued)

Payments of Benefits

Upon reaching the age of 59.5, participants, who are 100% vested, may elect to receive the value of their vested accounts by a lump-sum payment. Participants may also withdraw amounts in the event of financial hardship, in accordance with safe harbor withdrawal rules, death, and disability. In the event of termination of service, if no distribution election is made, the participant's vested account balance will be paid in a lump-sum distribution if the account balance is less than \$1,000; if the account balance is between \$1,000 and \$5,000, the participant's account balance will be rolled into a qualified individual retirement arrangement; and if the account balance is greater than \$5,000, the balance can remain in the Plan.

Plan Termination

Although it has not expressed any intent to do so, FIRST has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of

2. Significant Accounting Policies

December 31, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by FIRST, while others are paid directly by the Plan. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the investment fund to which the expenses relate. Expenses that are paid by FIRST are excluded from these financial statements.

Subsequent Events

Management evaluated subsequent events for the Plan through July 17, 2025 the date the accompanying financial statements were available to be issued.

3. Certification by the Trustee

Information presented in the accompanying statements and schedule for investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived, from information certified to be complete and accurate by Capital Bank and Trust Company, the trustee, as of December 31, 2024 and 2023, and for the year ended December 31, 2024 as permitted by the election made by the plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based upon the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in methodologies used at December 31, 2024 and 2023.

4. Fair Value Measurements (continued)

Mutual funds and money market mutual fund: Valued at the net asset value of shares held by the Plan at year-end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Related Party Transactions and Party-in-interest Transactions

Capital Bank and Trust Company (CBT), as the trustee, holds and manages the Plan's assets and makes distributions in accordance with the instructions of the plan administrator. Capital Bank and Trust Company and American Funds are part of the Capital Group. Certain of these investments are shares of funds managed by CBT. In addition, certain disbursements made by CBT are in the form of loans to the Plan's participants. These transactions are considered to be party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

7. Income Tax Status

The underlying non-standardized pre-approved profit-sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
