## Independent Auditors' Report

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### **1. Description of Plan**

The following description of the LiveWire EV, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan, with an effective date of March 1, 2022, was a spin-off from the Harley-Davidson Retirement Savings Plan for Salaried Employees ("Harley-Davidson Plan").

The Plan is a defined contribution plan covering all eligible employees of LiveWire EV, LLC and other participating employers (the "Company" or "Employer"). Participating employers include StaCyc and LiveWire Labs, LLC. Leased employees and temporary and seasonal employees (less than 1,000 hours of service) are excluded from participating in the Plan. There is no age or service requirement to participate in the Plan. Eligible employees may join the Plan on the first day of the month coinciding with or next following their date of hire.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Eligible participants may defer up to 50% of eligible compensation, as defined by the Plan, up to the maximum allowed by law as a pre-tax or Roth contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Once employees are eligible to enroll, and unless the employee opts out, automatic enrollment will take effect with an initial 4% pre-tax contribution.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Employer makes a matching contribution equal to 75% of a participant's elective deferrals not to exceed 6% of the participant's eligible compensation. The Employer may make a discretionary non-elective contribution to the Plan in an amount to be determined by the Employer. For the year ended December 31, 2024, \$986,780 of non-elective contributions were made to the Plan.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of Employer contributions and Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan's investments are participant directed.

### 1. Description of Plan *(continued)*

#### ***Vesting***

A participant is 100% vested in their contributions plus allocated earnings thereon at all times. Vesting in the Employer matching and nonelective contributions of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants will become fully vested in their accounts upon death or total and permanent disability. All employees that were hired prior to March 1, 2022 and were transferred from Harley-Davidson to the Company prior to March 4, 2022 as part of the separation of the electric motor division, including all StaCyc, Inc. employees, from Harley-Davidson, Inc. and its subsidiaries to the Company shall be 100% vested in their account balance at all times.

During the year ended December 31, 2024, a substantial number of employees of the Company were terminated due to a Company initiated reduction in workforce. The Company has determined that this constitutes a partial termination and, therefore, affected participants became 100% vested in their accounts.

#### ***Payment of Benefits***

Benefits are paid upon retirement, age 59 ½, death, or other termination of employment. Upon termination of service, a participant's balance will be paid in a lump-sum amount equal to the participant's account balance. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such hardship distributions are considered withdrawals. Upon termination, if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

#### ***Forfeitures***

If a participant terminates employment and is less than 100% vested in their Employer contributions, the participant will forfeit the non-vested portion of their account. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,124 and \$28. These accounts may be used to pay Plan expenses or to reduce future Employer contributions. During 2024, no forfeitures were used to pay Plan expenses and \$83,578 of forfeitures was used to reduce Employer contributions.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts, a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years. Loans for the purchase of a principal residence may not extend beyond 10 years from the date of the loan. A participant may have no more than two loans outstanding at any one time.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan’s investments were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

The Plan’s investments are stated at fair value. The mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 23, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

### 4. Tax Status

The Plan's prototype plan document preparer, ADP, LLC, has obtained an opinion letter dated October 6, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 5. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
