We have audited the financial statements of the Texas Mutual Insurance Company Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years ended December 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Texas Mutual Insurance Company Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution plan covering all employees age 18 or older of the Texas Mutual Insurance Company (the Company) except employees that are a resident of Puerto Rico, covered by a collective bargaining agreement, or a leased employee. The Plan was originally established by the Company effective March 8, 2008, and was amended and restated effective October 25, 2021 to comply with the latest rules and regulations.

The Plan was amended effective January 1, 2023 to allow for the participation of employees of TXM Holdings, LLC (a participating subsidiary of the Company). The Plan was further amended effective October 9, 2023, to permit hardship withdrawals. Effective January 2, 2024, the Plan was amended to include auto enrollment provisions and exclude interns from participating in the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In addition, effective January 1, 2024, the Company provides for matching contributions on student loan repayments.

Administration

The Plan is administered by the Management Investment Committee, which is composed of employees of the Company with oversight by the Board Investment Committee (collectively, the Committee). The Committee is responsible for the operation and administration of the Plan and the management of the Plan's assets. Fidelity Management Trust Company (Fidelity) is the trustee for the Plan and Fidelity Workplace Services LLC is the record keeper of the Plan.

Contributions

Each year, participants may contribute up to 75 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also designate some or all of their contributions as after tax contributions to a Roth 401(k) option. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective in 2024, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at six percent of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes a non-discretionary match equal to 100 percent of the first six percent of eligible compensation that a participant contributes to the Plan. The matching Company contribution is invested as directed by the participant. The Company also provides participants with a nonelective employer contribution of four percent of the participant's eligible compensation per payroll period plus an amount equal to the participants eligible compensation in excess of the Social Security Taxable Wage Base times four percent. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. An active participant is entitled to 100 percent of his or her account balance upon retirement, death or disability.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service, defined as 1,000 hours of service during the Plan year. A participant vests 20 percent after each year of continuous service and is fully vested after five years.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance in the available contribution sources or \$50,000 less the participant's highest outstanding loan balance immediately prior to the loan. Loan terms cannot exceed five years (ten years for the purchase of a primary residence). The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by plan administrator. Principal and interest is paid ratably through payroll deductions.

Effective January 1, 2018, a participant may have no more than one participant loan outstanding at any given time. Participants who had two outstanding loans as of the January 1, 2018 will be allowed to maintain and repay those existing loans until they are paid off.

Payment of Benefits

Upon separation of service due to death, disability, retirement or termination of employment, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account, adjusted for any portion of the Company's contributions not fully vested. For terminated participants with balances under \$1,000, the plan administrator may distribute the entire amount in a lump-sum without the participant's consent. If the participant's account balance exceeds \$1,000, the participant may choose to keep the funds in the Plan.

Participants over 65 years of age may make withdrawals prior to termination of employment for all or any portion of their account. In addition, participants may make withdrawals prior to termination of employment for an amount not greater than the balance of the participant's frozen employee after-tax contributions and/or rollover contributions included in the participant's account but not more frequently than once per calendar year.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$38,174 and \$33,875, respectively. The Plan permits the use of forfeitures to either reduce future employer contributions or Plan administrative expenses for the Plan year. During 2024 and 2023, Company contributions and Plan expenses were reduced by \$278,969 and \$278,184, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

The Plan participates in an expense offset arrangement whereby certain third-party expenses are paid with rebates received by the Plan from investment managers. During the years ended December 31, 2024 and 2023, the Plan received investment manager rebates of \$210,000 which was offset against recordkeeper fees. The net rebates are included in net appreciation of fair value of investments in the statement of changes in net assets available for benefits.

Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through June 26, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of interest-bearing cash accounts, common stocks, preferred stocks, mutual funds, corporate bonds, and short-term investments, are valued at the closing price reported on the open market.

Note 4. Related Party Transactions and Party-in-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company, and certain others. The Plan holds investments that are provided by the trustee and, therefore, these transactions qualify as party in interest transactions. Certain administrative fees related to the administration of the Plan are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA. All investment fund earnings or losses posted to each participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 5. Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

Note 6. Tax Status of Plan

The Plan adopted a non-standardized pre-approved defined contribution profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
