Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following description of the Island Peer Review Organization, Inc. Tax Deferred Annuity Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The Plan was originally established by Island Peer Review Organization, Inc. (“IPRO”) and was effective as of July 1, 1989. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

IPRO is the plan administrator. Transamerica Financial Life Insurance Company (“TFLIC”) is the insurance company. State Street Bank and Trust Company (“SSBT”) is the trustee of the Plan.

Eligibility

Employees of IPRO, except for excluded employees as defined by the Plan, are eligible to participate in the Plan by making pre-tax salary deferral and/or post-tax (“Roth”) salary deferral contributions upon employment.

Contributions

Each year, participants may contribute from pre-tax or after-tax earnings, under a salary reduction agreement, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts from other eligible retirement plans, as defined in the Plan document. The Plan also adopted provisions allowing the Plan to accept Roth 403(b) deferrals made on behalf of the participants, which are allocated to a separate account maintained for such deferrals. Contributions are subject to certain annual limitations as imposed by the Internal Revenue Code (the “Code”). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2020 all new employees will have elective deferrals contributed to the Plan in the amount of 3% of their eligible compensation unless they elect to not be enrolled. For employees enrolled under this automatic enrollment provision there is an automatic escalation of elective deferrals in the amount of 1% each year thereafter not to exceed 8% of eligible compensation.

Prior to January 1, 2020, the Plan provided for a non-elective employer contribution.

Participant Accounts

Each participant's account is credited with their contributions and IPRO's non-elective contributions, if any, and the related net earnings and losses thereon and are charged for withdrawals and certain administrative expenses.

Vesting

Participants are 100% vested in their pre-tax salary deferral contributions, Roth contributions, catch-up contributions, and any income or loss thereon.

Expense Budget Account

The Plan and Transamerica Retirement Solutions Corporation ("TRS") have entered into a revenue sharing arrangement whereby a portion of the revenue earned by TRS from certain funds is passed through to the Plan for payment of permitted Plan expenses or allocation to participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, IPRO created the Expense Budget Account. The Expense Budget Account is an account within the Plan and is used to record keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Expense Budget Account balance was \$196 and \$45 at December 31, 2024 and 2023. During 2024, \$6,639 was used from the Plan credit account to reduce Plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime rate published in The Wall Street Journal plus 2%. Loans are repaid in substantially equal quarterly payments or through payroll deductions over a period not to exceed five years, except loans that were used for a principal residence and may be repaid over a period not to exceed 10 years. Participants are allowed a maximum of three outstanding loans at a time. Upon termination with IPRO, a participant may either repay the outstanding balance immediately or continue to repay the balance directly with Transamerica Retirement Solutions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the vested value of their account or installment payments payable in accordance with the Plan. Under the terms of the Plan, a participant may make a withdrawal for reasons of economic hardship due to an immediate and heavy financial need and only when other financial resources are exhausted. Upon a participant's attaining age 59 ½, in-service withdrawals of their elective deferrals (both pre-tax and Roth) contributions, and the earnings thereon) are available.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by IPRO and are excluded from these financial statements. These include legal, audit, and trustee fees. Other administrative expenses, such as investment consulting and individual participant transaction fees, are paid for by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurement

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

Investments in shares of mutual funds are stated at fair value as determined by quoted market prices, which represent the net asset value of shares held by the Plan at year end. The Insurance Company General Account is a guaranteed investment contract and is valued at contract value and represents contributions made under the contract, plus interest credited, less benefits paid and expenses. The Government Fixed Fund is a separate account and is valued at contract value, which represents the fair value of the underlying portfolio, accrued interest on the underlying portfolio assets, the fair value of the contract, and the adjustments to contract value.

Purchases and sales of investments are recorded on a trade date basis, interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 24, 2025.

3. Information Certified (unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in value of investments, and interest on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by SSBT and TFLIC, qualified institutions.

5. Guaranteed Investment Contract

The TFLIC Insurance Company General Account (“Fixed Fund”), which is an investment option under the Plan, is provided under a group annuity contract issued by TFLIC. The Fixed Fund seeks to provide maximum yield consistent with a guarantee of principal. The Fixed Fund provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Fixed Fund is supported by TFLIC’s general account. The general account of TFLIC invests in investment grade fixed income securities, including US government, agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements.

No monies may be transferred by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Fixed Fund for 90 days. Monies transferred back to the Fixed Fund or withdrawn within the 90-day period are subject to a 5% charge. Monies withdrawn or transferred by the employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

The credit risk of TFLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A since January 2025), Moody’s Investors Service (A1 since December 2024), and Standard and Poor’s (A+ since March 2025).

The Fixed Fund represents approximately 15% and 20% of the Plan’s total assets as of December 31, 2024 and 2023.

6. Separate Account

The TFLIC Government Fixed Fund is an actively managed guaranteed separate account of TFLIC. Both principal and interest are guaranteed by TFLIC. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

No monies may be transferred from the TFLIC Government Fixed Fund by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the TFLIC Government Fixed Fund for 90 days. Monies transferred back to the TFLIC Government Fixed Fund or withdrawn within the 90-day period are subject to a 5% charge. Monies withdrawn or transferred by the sponsor and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge. Participants are generally permitted to make benefit distributions at contract value because the TFLIC Government Fixed Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the TFLIC Government Fixed Fund. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

The TFLIC Government Fixed Fund represents approximately 1% of the Plan's total assets as of December 31, 2024 and 2023.

7. Party-in-Interest Transactions

Certain Plan investments are managed by TFLIC; therefore, these transactions qualify as party-in-interest transactions. Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. Employees performing certain duties also qualify as party-in-interest transactions. No such officer or employee receives compensation from the Plan.

8. Tax Status

The Plan was formed using a prototype plan document which the IRS has determined and informed the applicant by letter dated March 31, 2017 that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Plan management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

9. Risk and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

10. Plan Termination

Although IPRO has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA.
