Independent Auditor's Report

To the Audit Committee of
The Maryland Zoological Society Savings and Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Maryland Zoological Society Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Maryland Zoological Society Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Maryland Zoological Society Savings and Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1: Description of Plan

The following description of The Maryland Zoological Society Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established July 1, 1984 by The Maryland Zoological Society, Inc. (the "Organization") under a prototype plan sponsored through Matrix Trust Company. The Plan was last amended October 1, 2023. The Plan generally covers all employees, excluding leased employees, who completed at least six months of service. Eligible employees may participate in elective deferrals with monthly Plan entry dates. The Plan qualifies under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: Each year, participants may elect to make pre-tax contributions up to the maximum allowable contribution amount under the Internal Revenue Code (IRC). Effective October 1, 2023, participants may elect to make after tax contributions to a Roth account. Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants additionally may contribute amounts, representing distributions from other qualified plans permitted by the Internal Revenue Service (IRS). Participant contributions are made through payroll deductions. Each participant designates the percentage of their contribution which is to be invested in one or more of the available investment fund options. Participants have the opportunity to change their investment options daily.

Employer Contributions: The Organization has elected to operate the Plan as a Safe Harbor 401(k) Plan. The Organization will make a safe harbor matching contribution based on the amount the participant chooses to contribute to the Plan. Participants' contributions are matched 100% by the Organization for the amount of their elective deferrals up to 3% of their eligible compensation. For deferrals over 3%, the Organization matches 50% of the participants' elective deferral amount that exceeds 3%, but not more than 5% of their eligible compensation. The Organization may also make discretionary profit-sharing contributions for any active participants employed on the last day of the Plan year, however, there were none made for the years ended December 31, 2024 and 2023.

Participant Accounts: Each participant's account is credited with the participant's contributions, allocations of Organization's contributions, and an allocation of Plan earnings and losses and administrative expenses. Plan earnings and losses are allocated based on participant account balances. The benefit to which a participant is entitled is that which can be provided from the participant's vested account balance. All accounts are entirely participant directed. All Plan assets as of December 31, 2024 and 2023 have been allocated to participant's accounts.

Vesting: Participants are immediately vested in all of their contributions and investment earnings, thereon and the employer safe-harbor matching contributions. Vesting in the Organization's discretionary profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant becomes fully vested in his account after three years of service. A participant also becomes fully vested upon retirement, death, or disability.

Payment of Benefits: In-service withdrawals are permitted for participants who have attained 59 1/2 years of age. Hardship withdrawals are also permitted under the Plan for participants who have experienced a qualified hardship under specific guidelines as set forth in the Plan. Upon termination of employment, a participant may elect to have vested Plan benefits distributed as a lump-sum. Balances less than \$5,000 will be distributed in a lump sum amount or be rolled over. Participants are generally required to take minimum distributions upon reaching the age of 72 (73 if the participant reaches age 72 in 2023 or later).

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan administrator. Principal and interest are paid through payroll deductions. The participant is only allowed to have one loan outstanding at any given time.

Note 2: Summary of Significant Accounting Policies

Following is a description of significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are reclassified as distributions based on the terms of the Plan document.

Contributions: Contributions from participants, including any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from Plan participants. Employer profit sharing contributions are recorded in the period approved by the Organization's management and collectability is reasonably assured.

Payment of Benefits: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 21, 2025, the date the financial statements were available to be issued. During the period from January 1, 2025 through July 21, 2025, the Plan did not have any material recognizable subsequent events.

Note 3: Fair Value Measurements

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the assets or liabilities.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for Plan assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on the closing price at year end as reported by the fund. Mutual funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodology used at December 31, 2024 and 2023.

Note 4: Information Certified by the Plan Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the Plan administrator has instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by Matrix Trust Company, trustee of the Plan, except to compare such information to information included in the Plan’s financial statements and supplemental schedule.

Certain information reported in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was derived from information certified as complete and accurate by Matrix Trust Company.

Note 5: Notes Receivable from Participants

As of December 31, 2024 and 2023, 10 participants were indebted to the Plan in the total amount of \$91,498 and \$50,430, respectively, as the result of loans made to them by the Plan. The loans are evidenced by a promissory note bearing interest at rates varying from 5.25% to 10.50% interest per annum, and are payable in installments, the latest of which is due in December 2029. The notes are fully secured by the participants’ vested account balances.

Note 6: Plan Termination

The Organization has the right under the Plan agreement to discontinue their contributions and to terminate the Plan, subject to applicable statutory provisions of ERISA. In the event of termination, all Plan participants will become fully vested. The Organization has not indicated any intention to terminate the Plan.

Note 7: Income Tax Status

The Internal Revenue Service has ruled, in a letter dated June 30, 2020, that the Prototype Non-Standardized Profit Sharing Plan with CODA, as amended, qualifies under applicable sections of the Internal Revenue Code (the Code). An employer who adopts this plan is generally considered to have a plan that is also qualified. The Plan's administrator and the Plan's sponsor believe that the Plan is designed and currently operating in compliance with the applicable requirements of the Code. The Plan's federal exempt tax returns are subject to examination by the Internal Revenue Service (IRS) generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8: Administrative Expenses

The Plan's expenses are paid either by the Plan or the Organization, as provided by the Plan document. Expenses paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits. The Plan has a revenue sharing agreement with their trustee. The Plan received \$39,200 and \$37,755 of shared revenue during the years ended December 31, 2024 and 2023, respectively, which was offset against recordkeeper fees and included in other income in the statements of changes in net assets available for benefits.

Note 9: Parties-in-Interest

The Plan offers various investment options to the participants which are managed by Matrix Trust Company, the trustee of the Plan; therefore, transactions with Matrix Trust Company qualify as party-in-interest transactions. In addition, NWPS provides various recordkeeping services for which it is compensated. During the years ended December 31, 2024 and 2023, the Plan incurred administrative expenses of \$43,199 and \$41,030, respectively. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. Certain officers and employees of the Plan sponsor are administrators of the Plan acting as fiduciaries and as trustees and are also participants in the Plan.

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
