**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of The Dime Bank 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023; the related statement of changes in net assets available for benefits for the year ended December 31, 2024; and the related notes to the financial statements (collectively, the financial statements).

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of The Dime Bank 401(k) Plan (the “Plan”) is provided for general information purposes only. Interested parties should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering the employees of The Dime Bank (the “Company”) who have completed 1,000 hours of service. The service hours begin accumulating on date of hire. The Plan includes a 401(k), before-tax savings feature, which permits all employees to defer compensation under Section 401(k) of the Internal Revenue Code. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors of the Company is responsible for oversight of the plan. The 401(k) Committee determines the appropriateness of the Plan’s investment offerings, monitors the investment performance and reports to the Board of Directors.

**Contributions**

Employees may elect to contribute, through the 401(k) feature, 1 percent to 80 percent of their base salaries each period, to the annual maximum amount permitted by the Internal Revenue Code. The Company matches up to 100 percent of the employee’s first 3 percent contribution and 50 percent of the next 2 percent.

Additionally, the Company can make discretionary profit-sharing contributions. Each participant’s profit-sharing account is credited with an allocation of the Company’s contributions and Plan earnings. Allocations are based upon units accumulated by each participant’s account. Units are apportioned based upon participant earnings. The benefit to which each participant is entitled is that which can be provided from the participant’s account.

**Participants’ Accounts**

In accordance with the terms of the Plan, the account of each participant is maintained on a fair value basis. Participants’ accounts consist of the contribution made on their behalf by the Company, their employee elective deferral contributions, their employee rollover contributions, and their share of investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Vesting in the Plan is based on periods of service under the elapsed-time method. A period of service is determined by time worked under the Company. Only whole years of service will be counted as a period of service. For profit sharing contributions, employees become vested as follows: 0 percent before 2 years, 25 percent after 2 years, 50 percent after 3 years, 75 percent after 4 years, and 100 percent upon completion of 5 years of service. For employer matching contributions, employees become 100 percent vested immediately. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

## NOTE 1 - DESCRIPTION OF PLAN (continued)

### **Administrative Expenses**

Administrative expenses of the plan relating to investment management, recordkeeping, accounting fees and miscellaneous administrative expenses are paid by the Company.

### **Payment of Benefits**

On termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account, an eligible rollover distribution, or a combination of a lump-sum and rollover distribution. Benefit payments to participants are recorded when paid.

### **Forfeitures**

Forfeitures can be applied to reduce the Company's contributions and pay Plan expenses. At December 31, 2024, and 2023, forfeited accounts totaled \$0 respectively. Forfeitures of \$10,482 were used in 2024 to reduce profit sharing contributions.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting and reporting policies applied in the presentation of the accompanying financial statements follows:

### **Basis of Accounting**

The accounting principles followed by the Plan and the methods of applying these principles conform to U.S. generally accepted accounting principles. The financial statements of the plan are prepared on the accrual basis of accounting.

### **Accounting Estimates**

In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ significantly from those estimates.

### **Investments Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

The net appreciation in fair value of investments includes gains and losses on investments purchased, sold, and held during the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### NOTE 3 - INVESTMENTS

The Plan investments are administered by Fidelity Management Trust Company (the “Trustee”) under an agreement dated January 1, 2004.

The following is a summary of the investment information as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedules, related to the following investments:

Fidelity Management Trust Company also certified to the completeness and accuracy of \$1,730,489 of net appreciation in fair value of investments and \$874,462 of dividends related to the aforementioned investments for the year ended December 31, 2024.

### NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their employee contributions.

### NOTE 5 - TAX STATUS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan had taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designated, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan’s tax counsel believe that the Plan was designated and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

## NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds that are managed by Fidelity Management Trust Company, the defined trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. The Company absorbs certain costs incurred in relation to the administration of the Plan. Such costs include accounting fees. These costs amounted to \$13,000 for the year ended December 31, 2024.

## NOTE 7 - FAIR VALUE OF FINANCIAL INSTRUMENTS

Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract which creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the fair value would be calculated based upon the market price per trading unit of the instrument.

Mutual funds, common collective trust and employer contribution receivable would be considered financial instruments. At December 31, 2024, and 2023, the carrying amounts of the mutual funds, common collective trust and employer contribution receivable approximate fair values.

## NOTE 8 –FAIR VALUE MEASUREMENTS

The plan follows a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described below:

- Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level II: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 8 –FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust* - Valued at net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common collective trust held by the Plan requires twelve months’ notice for a complete liquidation, however the trustee, at their discretion, may waive the twelve-month waiting period. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

#### NOTE 9– RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits. As of December 31, 2024, the Plan had investments of \$4,382,677 that were concentrated in American Funds 2025, \$3,377,267 that were concentrated in the American Funds 2030, \$3,584,020 in American Funds 2035 and \$2,627,408 that were concentrated in American Funds 2040. As of December 31, 2023, the Plan had investments of \$4,380,844 that were concentrated in American Funds 2025, \$3,341,935 that were concentrated in American Funds 2030 and \$2,929,138 that were concentrated in American Funds 2035.

#### NOTE 10 –SUBSEQUENT EVENTS

Management has reviewed events occurring through July 24, 2025, the date that the financial statements were issued, and no subsequent events occurred requiring disclosure.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of The Dime Bank 401(k) Plan (the “Plan”) is provided for general information purposes only. Interested parties should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering the employees of The Dime Bank (the “Company”) who have completed 1,000 hours of service. The service hours begin accumulating on date of hire. The Plan includes a 401(k), before-tax savings feature, which permits all employees to defer compensation under Section 401(k) of the Internal Revenue Code. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors of the Company is responsible for oversight of the plan. The 401(k) Committee determines the appropriateness of the Plan’s investment offerings, monitors the investment performance and reports to the Board of Directors.

**Contributions**

Employees may elect to contribute, through the 401(k) feature, 1 percent to 80 percent of their base salaries each period, to the annual maximum amount permitted by the Internal Revenue Code. The Company matches up to 100 percent of the employee’s first 3 percent contribution and 50 percent of the next 2 percent.

Additionally, the Company can make discretionary profit-sharing contributions. Each participant’s profit-sharing account is credited with an allocation of the Company’s contributions and Plan earnings. Allocations are based upon units accumulated by each participant’s account. Units are apportioned based upon participant earnings. The benefit to which each participant is entitled is that which can be provided from the participant’s account.

**Participants’ Accounts**

In accordance with the terms of the Plan, the account of each participant is maintained on a fair value basis. Participants’ accounts consist of the contribution made on their behalf by the Company, their employee elective deferral contributions, their employee rollover contributions, and their share of investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Vesting in the Plan is based on periods of service under the elapsed-time method. A period of service is determined by time worked under the Company. Only whole years of service will be counted as a period of service. For profit sharing contributions, employees become vested as follows: 0 percent before 2 years, 25 percent after 2 years, 50 percent after 3 years, 75 percent after 4 years, and 100 percent upon completion of 5 years of service. For employer matching contributions, employees become 100 percent vested immediately. Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

## NOTE 1 - DESCRIPTION OF PLAN (continued)

### **Administrative Expenses**

Administrative expenses of the plan relating to investment management, recordkeeping, accounting fees and miscellaneous administrative expenses are paid by the Company.

### **Payment of Benefits**

On termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account, an eligible rollover distribution, or a combination of a lump-sum and rollover distribution. Benefit payments to participants are recorded when paid.

### **Forfeitures**

Forfeitures can be applied to reduce the Company's contributions and pay Plan expenses. At December 31, 2024, and 2023, forfeited accounts totaled \$0 respectively. Forfeitures of \$10,482 were used in 2024 to reduce profit sharing contributions.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting and reporting policies applied in the presentation of the accompanying financial statements follows:

### **Basis of Accounting**

The accounting principles followed by the Plan and the methods of applying these principles conform to U.S. generally accepted accounting principles. The financial statements of the plan are prepared on the accrual basis of accounting.

### **Accounting Estimates**

In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ significantly from those estimates.

### **Investments Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

The net appreciation in fair value of investments includes gains and losses on investments purchased, sold, and held during the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### NOTE 3 - INVESTMENTS

The Plan investments are administered by Fidelity Management Trust Company (the “Trustee”) under an agreement dated January 1, 2004.

The following is a summary of the investment information as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedules, related to the following investments:

Fidelity Management Trust Company also certified to the completeness and accuracy of \$1,730,489 of net appreciation in fair value of investments and \$874,462 of dividends related to the aforementioned investments for the year ended December 31, 2024.

### NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their employee contributions.

### NOTE 5 - TAX STATUS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan had taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designated, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan’s tax counsel believe that the Plan was designated and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

## NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds that are managed by Fidelity Management Trust Company, the defined trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. The Company absorbs certain costs incurred in relation to the administration of the Plan. Such costs include accounting fees. These costs amounted to \$13,000 for the year ended December 31, 2024.

## NOTE 7 - FAIR VALUE OF FINANCIAL INSTRUMENTS

Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract which creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the fair value would be calculated based upon the market price per trading unit of the instrument.

Mutual funds, common collective trust and employer contribution receivable would be considered financial instruments. At December 31, 2024, and 2023, the carrying amounts of the mutual funds, common collective trust and employer contribution receivable approximate fair values.

## NOTE 8 –FAIR VALUE MEASUREMENTS

The plan follows a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described below:

- Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level II: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 8 –FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust* - Valued at net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The common collective trust held by the Plan requires twelve months’ notice for a complete liquidation, however the trustee, at their discretion, may waive the twelve-month waiting period. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

#### NOTE 9– RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits. As of December 31, 2024, the Plan had investments of \$4,382,677 that were concentrated in American Funds 2025, \$3,377,267 that were concentrated in the American Funds 2030, \$3,584,020 in American Funds 2035 and \$2,627,408 that were concentrated in American Funds 2040. As of December 31, 2023, the Plan had investments of \$4,380,844 that were concentrated in American Funds 2025, \$3,341,935 that were concentrated in American Funds 2030 and \$2,929,138 that were concentrated in American Funds 2035.

#### NOTE 10 –SUBSEQUENT EVENTS

Management has reviewed events occurring through July 24, 2025, the date that the financial statements were issued, and no subsequent events occurred requiring disclosure.
