Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of J.M. Equipment Company, Inc., Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN

The following description of J.M. Equipment Company, Inc., (“the Company”) Profit Sharing 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a participant-directed defined contribution plan covering all full-time employees of the Company. Employees of any age and at least 3 months of service are eligible for salary deferral or matching portions of the Plan. Having met eligibility requirements for profit-sharing contributions, employees may enter the Plan on the first day of the quarter in the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Each year, participants may contribute up to the annual federal tax law limit of annual compensation, as defined in the Plan. Participants may elect to make both pre-tax deferrals and Roth 401(k) deferral contributions. Those who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

For each plan year, the Company may contribute to the Plan an amount of matching contributions determined by the Company at its discretion. Participants who have made salary deferrals to the Plan are eligible to share in matching contributions. Matching contributions were \$90,596 and \$82,932 for the years ended December 31, 2024 and 2023, respectively.

Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. Eligible participants that have been working at least one year and have 1,000 hours of service may participate in the profit-sharing contribution. Profit-sharing contributions were \$122,500 and \$122,500 for the years ended December 31, 2024 and 2023, respectively.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution (if applicable) and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in their contributions to the Plan, plus actual earnings thereon. Vesting in the Company's profit sharing or matching contributions, plus actual earnings, are based on years of continuous service. A participant is 10%, 20%, 40%, 60%, and 100% vested after one, two, three, four, and five years of credited service, respectively.

PAYMENT OF BENEFITS

On termination of service for any reason, a participant may elect to receive a lump sum, partial withdrawal, or installment distribution of all vested amounts.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

FORFEITED ACCOUNTS

During the year ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,841 and \$14,720, respectively. These accounts may be used to increase future additional employer profit-sharing contributions, reduce future employer contributions, restore forfeited account balances of rehires that are eligible for restoration, or to reduce administrative expenses of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by the plan custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by John Hancock Trust Company, LLC. As custodians of the Plan, any transactions with them qualified as party-in-interest transactions. Direct fees paid by the Plan for contract administration, trustee services, and compliance reporting services, totaled \$38,262.

Also, certain administrative functions have been performed by the plan sponsor. There has not been a value calculated for these costs, and therefore the Plan has not been charged for these costs.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants would receive benefits under the Plan based on their vested account balance accumulated to the date of the termination of the Plan. Termination of the Plan could occur before attaining normal retirement age.

NOTE 6 – TAX STATUS

The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified.

The company's income tax returns are subject to examination by the appropriate tax jurisdictions. The company's tax returns generally remain open for at least the last three years.

NOTE 7 – RISKS AND UNCERTAINTIES

Investments consist primarily of pooled separate accounts. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – INFORMATION CERTIFIED BY PLAN TRUSTEE AND CUSTODIAN

John Hancock Trust Company, LLC, the plan trustee and custodian, has provided certifications that the following information, which is contained in or used to develop the financial statements, is complete and accurate:
