### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Vernon Company 401(k) Plan for Administrative and Affiliated Company Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

### **NOTE 1 — DESCRIPTION OF PLAN**

The following description of The Vernon Company 401(k) Plan for Administrative and Affiliated Company Employees (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all home office employees of The Vernon Company (the Company and Plan Administrator) and all employees of the Company's operating subsidiary. Participants are eligible for entry into the Plan on January 1 or July 1 following the completion of 6 months of service and reaching 19 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participation is voluntary.

In February 2023, certain participants and their accounts from the Plan were transferred to The Vernon Investment and Retirement Plan for Field Salespersons.

#### **Plan Administration**

The Company has contracted with Principal Life Insurance Company and Principal Trust Company (collectively, Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

#### **Contributions**

Participants may contribute up to 100% of their eligible income as defined by the Plan, subject to certain limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% (increasing annually by 1% up to a max of 10%) of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company matches 25% of participant deferrals up to 6% of the participant's eligible salary. The Company may also make a discretionary contribution in an amount determined by the Company. To receive the discretionary contribution, the employee must be employed on the last day of the previous Plan year-end. During the year ended December 31, 2023 the Company made discretionary contributions of \$83,795 to the Plan. There were no discretionary contributions made during the year ended December 31, 2024. The Plan allows catchup contributions up to the amounts allowed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing rollovers from other qualifying plans. Participants direct the investment of their contributions into the various investment options offered by the Plan. The Company contributions can be directed to different investment options by the participant.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of discretionary contributions and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investment options daily.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution to their accounts, plus actual earnings thereon, is based on a rate of 25% for each year of service after one year of service. A participant is 100% vested after five years of credited service. Participants become vested immediately in the Company's contributions and earnings thereon if employed by the Company on the date they qualify for normal retirement (age 65), become totally disabled or die.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum, annuity payment option, or allow the funds to be rolled over into another qualifying account. If no election is received from the participant, amounts which are less than \$1,000 will be paid to the participant and amounts between \$1,000 and \$5,000 are rolled into an Individual Retirement Account. In certain circumstances, the withdrawals are allowed from the participant's account.

**Forfeited Accounts**

During the years ended December 31, 2024 and 2023, forfeitures totaled \$7,996 and \$1,153, respectively, and were used to reduce Company contributions. At December 31, 2024, the forfeiture account had a balance of \$18. There was no balance in the forfeiture account at December 31, 2023.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates

**Investment Valuation and Income Recognition**

Investments are reported in the financial statements at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Investments held in Principal Fixed Income Guaranteed Option (PFIGO) are reported separately at contract value within net assets available for benefits, as this investment is considered to be fully benefit-responsive (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Contributions**

Contributions from participants are recorded in the year in which they are withheld from compensation.

**Administrative Expense**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment-related expenses are included within net appreciation (depreciation) in fair value of investments.

**NOTE 3 — INFORMATION CERTIFIED BY PRINCIPAL**

**NOTE 4 — FAIR VALUE MEASUREMENTS**

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority):

Level 1, defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2, defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and

Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.
- *Pooled separate accounts*: Valued based on quoted redemption values, also known as net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days. Other than the Principal U.S. Property Separate Account, there are no limitations on redemptions.

The NAV of the Principal U.S. Property Separate Account is based on the underlying real estate assets, which are valued using discounted cash flow valuation models that utilize public real estate market data such as transaction prices, market rents, vacancy levels, leasing absorption, market cap rates and discount rates. In addition, each property is appraised annually by an independent appraiser. Principal has the ability to apply a contractual limitation, which delays the payment of withdrawal requests (Withdrawal Limitation). At December 31, 2024, the Withdrawal Limitation was in effect and the Plan had outstanding distribution requests of \$120,183. There were no outstanding requests as of December 31, 2023.

- *Guaranteed interest account:* Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. This fair value represents contract value adjusted to reflect surrender charges applied upon withdrawal. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and less funds used to pay administrative expenses.

**NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

During the year ended December 31, 2024, the Plan entered into a fully benefit-responsive group annuity contract issued by Principal with a fixed rate of interest, PFIGO. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract.

Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semiannual basis. The key factors that influence future interest crediting rates for the investments include the level of market interest rates; the amount and timing of participant contributions, withdrawals, and transfers into or out of the fund; the investment returns generated by the investments; and the duration of the investments.

PFIGO has a guarantee backed by the assets in the multi-billion-dollar general account of Principal. The general account consists of over 6,000 investments, which include corporate bonds, asset-backed securities, commercial real estate mortgages, government bonds, and short-term cash equivalents.

**NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)**

Benefit payments are made at contract value, with no market value adjustments or surrender charge adjustments for Plan benefit events, including retirement, death, disability, termination, loans, withdrawals, or Plan termination. An employer-level liquidation or employer-initiated transfer of the Plan's interest in PFIGO will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge, whichever the Plan would choose at the termination event. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. Plan management believes that the occurrence of an event that would cause the fund to transact at less than contract value is not probable.

**NOTE 6 — TAX STATUS**

The Plan was created from a prototype plan developed by Principal. The Internal Revenue Service (IRS) has issued an opinion letter, dated June 30, 2020, that the prototype plan is qualified, and the trust established under the Plan is tax-exempt under Section 401 of the IRC. Although the Plan has been amended since receiving the letter, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC under the prototype.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. Plan management has not identified any uncertain tax positions.

**NOTE 7 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 — PARTY-IN-INTEREST TRANSACTIONS**

During the years ended December 31, 2024 and 2023, the Plan invested in various investments managed by its custodian, which qualify as party-in-interest transactions. These transactions are exempt and are not prohibited by ERISA.

**NOTE 9 — SUBSEQUENT EVENTS**

As of January 1, 2025, the Plan was amended to permit monthly entry dates instead of semiannual.

The Plan's management has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.
