Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Family Guidance Center for Behavioral Healthcare Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

NOTE A – DESCRIPTION OF PLAN

Family Guidance Center for Behavioral Healthcare (FGC) is the sponsor of the Family Guidance Center for Behavioral Healthcare Profit Sharing Plan and Trust (the Plan). The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Effective January 1, 2004 the Plan was restated by adopting a prototype. The Summary Plan Description of the Plan is updated by the sponsor annually with no significant changes to the Plan provisions in 2024.

General. The Plan is a defined contribution 401(k) profit sharing plan covering substantially all full-time employees of FGC who have completed one year of service (requiring at least 1,000 hours of service during the year) and have attained the age of twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Eligible participants under the Plan may designate a portion up to 75% of their annual compensation to be deferred pursuant to the Plan provisions up to the maximum permissible amount allowed by law for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2010 FGC offers a safe harbor match of 100 percent of employee contributions up to four percent of the employee's gross salary. FGC will contribute the match each pay period. FGC also has the option to make a discretionary profit-sharing contribution.

Employer and employee contributions for the years ended December 31, 2024 and 2023 are participant directed.

Participant Accounts. Each participant's account is credited with the participant's contribution, FGC's contribution, Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant's compensation or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions plus actual earnings thereon.

Participants are vested in FGC's nonelective contributions plus earnings thereon based on years of service. A participant is 20% vested after one year of credited service, increasing 20% each year until the participant is 100% vested after five years of service.

Payment of Benefits. Upon termination of service due to death, disability, or retirement, a participant with an account balance exceeding \$5,000 may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount, or in installments (annually, quarterly or monthly) over a period that is less than the participant's remaining life expectancy. If the account balance is less than \$5,000, a lump sum distribution is required. Hardship distributions as well as in-service distributions are permitted.

Participant Loans. Participant loans are not allowed.

Forfeited Accounts. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$169 and \$0, respectively. These amounts will be used to reduce future employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates. The preparation of financial statements in conformity with GAAP requires the Plan sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ significantly from those estimates.

Investments Valuation and Income Recognition. The Plan's investments are stated at fair value based on quoted market prices, as determined by John Hancock Life Insurance Company, the Plan custodian and trustee, at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Operating Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by FGC. Expenses that are paid by FGC are excluded from these financial statements.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, FGC has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant shall be 100 percent vested and have a non-forfeitable interest in their employer contributions.

NOTE D – RELATED PARTY TRANSACTION

Certain Plan investments are shares of funds managed by John Hancock. John Hancock is the trustee and custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by FGC for the investment management services amounted to \$1,879 and \$2,171 for the years ended December 31, 2024 and 2023, respectively.

NOTE E – TAX STATUS

The Plan terms were drafted using a prototype plan designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is required to be operated in conformity with the IRC to maintain its tax-exempt status. The Plan Sponsor has not received an IRS determination letter in relation to the Plan. However, Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include, quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The pooled accounts held by the Plan are deemed to be actively traded.

NOTE H – RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE I – PLAN FINANCIAL INFORMATION CERTIFIED BY TRUSTEE
