Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Salem Stone Savings Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Salem Stone Savings Plan & Trust's financial statements performed in accordance with ERISA, Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Note 1 – Plan Description

The following description of the Salem Stone Savings Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a multiple-employer defined contribution plan covering all employees of Salem Stone Corporation (the “Company”), Sisson & Ryan Quarry, L.L.C., Southside Materials, L.L.C., Cardinal Realty Virginia, L.L.C., Cardinal Quarries, L.L.C., Holston River Quarry, Inc., and Rocky Gap Quarry, L.L.C. who are at least 18 years of age and have completed one year of service, excluding those employees whose employment is governed by a collective bargaining agreement. Effective January 1, 2024, the Plan document was amended to modify eligibility requirements for Plan entry to age 18 and 60 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a portion of their compensation as a pre-tax or Roth deferral as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Effective January 1, 2024, the Plan document was amended to automatically enroll new participants at 3% pretax deferral with 1% annual automatic increases, up to 15% of compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will match half of the employee’s contribution, up to 7% of the employee’s eligible compensation, for a maximum employer contribution of 3.5%. The Company did not elect to contribute a profit-sharing contribution for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, an allocation of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. A participant is vested after six years of credited service in the Company’s matching and profit-sharing contributions, plus earnings thereon. In addition, upon death, disability, or reaching normal retirement age, participants become fully vested in employer contributions.

Payments of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution, partial payments, installment payments, or annuity payments equal to the value of the participant’s vested interest in his or her account.

Administrative Expenses

The Plan's administrative expenses, which include custodial, investment management, and professional fees for services, are paid by either the Plan or the Company, as provided in the Plan agreement.

Forfeitures

Forfeitures of terminated non-vested account balances may be used to pay administrative expenses, reduce employer contributions, or allocated to participants, as defined. Forfeited non-vested accounts at December 31, 2024 and 2023 were \$3,464 and \$2,424, respectively. During 2024 forfeited non-vested accounts totaling \$14 were used to pay administrative expenses, as defined by the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investments. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts which are required to be reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through July 17, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments, except for fully benefit-responsive contracts, are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available.

The Plan held investments in YourPath active Collective Investment Trust at December 31, 2024 and 2023. The investments are composed primarily of a mix of mutual funds and other investments that correspond to specific risk profiles and investment time horizons that includes the year (target date) in which participants are expected to retire. Each portfolio also includes the Lincoln Stable Value Fund to help reduce market volatility. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Note 4 – Investment Contracts

Fully Benefit-Responsive

The Plan holds an investment contract with The Lincoln National Life Insurance Company (“Lincoln”). This contract, the Lincoln Guaranteed Stable Value Account, meets the fully benefit-responsive traditional investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in these contracts at contract value. The yield earned by the fund with an adjustment to reflect the actual interest rate credited to participants was 2.77% and 2.54% for the years ended December 31, 2024 and 2023, respectively. The following represents the total contract value of this investment contract held by the Plan.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified rate of interest that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will not fall below zero percent.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the *Internal Revenue Code* or the failure of the trust to be tax-exempt under Section 501(a) of the *Internal Revenue Code*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan’s prohibition on competing investment options
- Other Plan Sponsor events that significantly affect the Plan’s normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan’s investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

Note 5 – Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan participants may choose to invest in funds managed by Lincoln National Life Insurance Company and these transactions, therefore, qualify as party-in-interest transactions. Fees paid to Lincoln National Life Insurance Company by the Plan for recordkeeping, investment management, and administrative services were \$50,732 for the year ended December 31, 2024.

Note 6 – Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 – Tax Status

Effective April 15, 2023, the Plan document was restated to a defined contribution pre-approved plan sponsored by Pinnacle Financial Services and received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Although the Plan has been restated, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
