Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Children's Therapy Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Children's Therapy Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to the Financial Statements

December 31, 2024

1. Summary of Significant Plan Provisions

The following description of the Children's Therapy Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan's provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Children's Therapy Services, Inc. (the "Company" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is administered by a committee within the Company. Ascensus Trust Company (the "Trustee") serves as the trustee of the Plan, holds the Plan assets and maintains the records of the participant data.

Effective July 1, 2024, the service requirement for vesting was changed to no longer require the 750 hours.

- b. **Eligibility** – Employees, who are not collective bargaining, nonresident alien and leased employees are eligible to participate in the Plan upon attaining age 18 and completing 6 months of service. Plan entry dates are the first day of the quarter following the date the eligibility requirements are met.
- c. **Contributions** – Participants may contribute through pre-tax deferrals, as well as rollover contributions. Participants can defer up to the limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan allows the Employer to make discretionary matching contributions. During the year ended December 31, 2024, the board of directors elected to make discretionary matching contributions to the Plan in an amount equal to a participant's contributions, not to exceed 2% of the participant's eligible compensation each payroll period. Employer contributions are subject to certain limitations.

Additional amounts may be contributed by the Company under the Plan's profit-sharing contribution provisions at the discretion of the Company's board of directors. During the year ended December 31, 2024, no profit-sharing contributions were made.

Participants direct the investment of their contributions into various investment options offered by the Plan.

- d. **Participant accounts** – Each participant's account is credited with the participant's contributions, employer matching contributions and allocations of employer profit sharing contributions and Plan earnings. Participant accounts are reduced with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant contributions, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Summary of Significant Plan Provisions (cont.)

- e. **Vesting** – Participants are fully vested in their own contributions, plus actual earnings thereon. Employer contributions shall be fully vested upon death, disability or upon reaching normal retirement age of 65. If participants terminate employment for any other reason, they are entitled to the portion of contributions made by the Employer according to the following schedule:

- f. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested account balance or \$50,000. Note terms cannot exceed five years unless the note is for the purchase of a primary residence. The note is secured by the participant's vested account balance and bears interest at a rate of prime plus 1%. Participants are limited to only one outstanding note. Principal and interest are paid ratably through payroll deductions.
- g. **Payment of benefits** – Upon retirement, termination of employment or disability, a participant or beneficiary in the event of death, may elect to receive a payment of benefits in a lump sum amount equal to the value of the participant's vested interest in his or her account. Additionally, a participant may receive an in-service withdrawal from any portion of their account upon the age 59 ½. If the participant's account balance is equal to or less than \$5,000, the balance will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant's consent before the participant's normal retirement age will be rolled over to an individual retirement plan designated by the Plan administrator.

The Plan allows hardship withdrawals, subject to account balance limitations and applicable laws.

- h. **Forfeitures** – The portion of a participant's account to which they are not entitled, as a result of being less than fully vested, shall be forfeited by the participant upon distribution. Forfeitures shall be used first to pay administrative expenses, reduce employer contributions, or reallocated to participant accounts. The Plan had \$4,888 and \$3,138 unallocated forfeitures as of December 31, 2024 and 2023, respectively.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Employer contribution portion of their accounts.

1. Summary of Significant Accounting Policies (cont.)

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** - Investments are reported at fair value. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. There was no allowance for credit losses as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – The Plan allows certain administrative expenses to be paid from Plan assets.

2. Investments Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the Trustee and obtained from management of the Plan as complete and accurate by a qualified institution, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule of assets held.

3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

3. Fair Value Measurements (cont.)

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

Cash equivalent: This investment is valued at cost, plus accrued interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain administrative expenses totaling \$11,000, were paid by the Company on behalf of the Plan for the year ended December 31, 2024. The Company does not expect reimbursement from the Plan for these expenses. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

All Plan investments are issued by Vanguard that qualify as exempt party-in-interest transactions under ERISA. Certain fees incurred by the Plan are included in net appreciation in fair value of investments. The Plan also made direct payments to a service provider that are included in administrative expenses on the statement of changes in net assets available for benefits.

5. Tax Status

The Company adopted a Non-standardized Pre-Approved Profit Sharing Plan with CODA Plan (the "Prototype Plan") sponsored by the Trustee. The Internal Revenue Service has informed the Prototype Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the "Code"). The Prototype Plan's opinion letter is being relied on by the Plan. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

7. Subsequent Events

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024, statement of net assets available for benefits and determined there were no other significant events to report through June 30, 2025, which is the date the Plan issued its financial statements.
