## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the  
Youth Villages Retirement Plan  
Memphis, Tennessee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Youth Villages Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Youth Villages Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Youth Villages Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Youth Villages Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Youth Villages Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Youth Villages, Inc. and affiliates (the Organization) who have one year of service, at least 1,000 service hours and are age twenty-one or older. The following types of employees are excluded from the Plan: union employees, non-resident aliens, and leased employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in a variety of Mutual Funds and Collective Investment Trusts. Participants may change their investment options and transfer previously contributed amounts between funds at any time. Investment realized gains (losses) and unrealized appreciation (depreciation) in investment fair value are measured and recorded by participant account.

Contributions

Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to Internal Revenue Code limitations. The Organization has an auto enrollment feature of 3% employee contributions on the date of eligibility unless the participant elects not to contribute. The Plan also has an automatic escalation feature of 1% each year until a maximum contribution rate of 6% is reached. Participant contributions may be made as tax-deferred contributions. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Organization has a Qualified Automatic Contribution Arrangement (QACA) non-elective contributions match of 3% of participant's compensation. The Organization also has a match contribution as determined by the Board of Directors of Youth Villages, Inc. and affiliates. For the year ended December 31, 2024, the match was 2% of participant's compensation.

Forfeitures

Forfeitures may be used to pay plan expenses or to offset employer contributions. Forfeitures, not used to pay plan expenses or to offset employer contributions, shall be allocated as contributions in accordance with plan document. As of December 31, 2024 and 2023, forfeiture balance was \$3,823 and \$7,460, respectively. For the year ended December 31, 2024, forfeitures used to offset employer contributions and pay plan expenses totaled \$504,852.

Participant Accounts

Each participant's account is credited with an allocation of the Organization's contribution, plan earnings, and forfeitures of terminated participants' non-vested accounts if any remain after amounts used to reduce plan expenses or employer contributions. Allocations are based on participant compensation and account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Account investments are participant-directed with diversified investment options from which to choose.

## Vesting

Vesting in the Organization's contribution portion of participant accounts is based on years of service as follows:

Effective January 1, 2021, there is a specialized vesting schedule for QACA Nonelective Contributions. Vesting in the Organization's QACA Nonelective Contribution portion of participant accounts is based on years of service as follows:

A participant must complete 1,000 hours of service to obtain a year of service.

## Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount, or partial withdrawals, equal to the value of the participant's vested interest in his or her account, or substantially equal installments over a period not to extend beyond the earlier of the Participant's life expectancy or the joint life expectancy of the Participant and the Participant's designated Beneficiary. Withdrawals by a participant while employed are limited to those requested due to the events of financial hardship as defined by the plan document or upon the attainment of age 65 from fully vested accounts defined by the plan agreement.

## Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Recordkeeping and other administrative expenses may be charged directly to the participants' accounts and are included in administrative expenses. Other investment related expenses are included in net appreciation of fair value of investments.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The financial statements of the Plan are prepared using the accrual basis of accounting.

The Plan's investments are stated at fair market value, as defined by the generally accepted accounting principles. See Note 3 for disclosure of fair value measurement.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of investment income, realized gains or losses, and the unrealized appreciation (depreciation) on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefits are recorded when paid.

#### Date of Management's Review

The plan sponsor evaluated the December 31, 2024 financial statements for subsequent events through July 24, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

### **NOTE 3 - FAIR VALUE INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under generally accepted accounting principles are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund.

*Collective trust funds:* Valued at the net asset value of the underlying assets reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 5 - PLAN TERMINATION

Although it has not expressed intent to do so, the Organization has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and Plan assets will be used solely to provide benefits for participants.

## **NOTE 6 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 stating that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which the Plan adopted, was designed in accordance with applicable IRC requirements. The Plan has not requested a determination letter of its own. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

## **NOTE 7 – RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Global Investors Trust Company. Principal Global Investors Trust Company is an affiliate of Principal Life Insurance company, the asset custodian as defined by the Plan, and, therefore, these transactions represent party-in-interest transactions. Certain plan expenses paid by the plan sponsor also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provision of ERISA and the Internal Revenue Code.

## **NOTE 8 – INFORMATION CERTIFIED BY THE ASSET CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian, Principal Life Insurance Company and Principal Trust Company, have certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment activity, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investments as shown in the schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental information.
