## INDEPENDENT AUDITORS' REPORT

To the CMC, Inc. 401(k) Retirement Plan and Participants  
Nicholasville, Kentucky

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CMC, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CMC, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

### Basis for Opinion

Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. ## **1. Description of Plan**

The following description of the CMC, Inc. (the "Company") 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective July 1, 1998, and was restated effective July 13, 2021. The Plan's recordkeeper and custodian is Empower Retirement, LLC.

### **Eligibility**

The Plan covers substantially all employees of the Company. The Plan also covers substantially all employees of Clay Corman Excavating, Inc. Employees are eligible to participate in the Plan immediately upon hire. Employees may enter the Plan on the first day of the pay period after fulfilling the eligibility requirements. Nonresident aliens and reclassified employees (a person the Employer does not treat as a common law employee on its payroll records, such as someone paid as an independent contractor or an out-sourced worker) are not eligible to participate at any time.

### **Contributions**

Each year, participants are permitted to contribute up to 100% of their total annual eligible compensation, as defined in the plan agreement, as a before-tax salary deferral contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes a weekly matching contribution for all participants equal to 100% of the first \$10 of compensation contributed by the participant. Contributions from the participant and the Company for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service regulations.

Contributions from plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation

### **Prevailing Wage Contributions**

The Company provides an employer contribution for each eligible participant who performs work under public contracts subject to federal prevailing wage laws. The most common prevailing wage laws that company employees cover are the Service Contract Act and the Davis-Bacon Act. However, employer contributions may also be made for eligible participants who work under contracts subject to any other federal, state or municipal prevailing wage law. There is no minimum age or length of service requirement, and employees are immediately eligible to participate as of their date of employment.

### **Participant Accounts**

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and the Plan Sponsor's contributions, an allocation of plan earnings or losses, and administrative expenses. Allocations are based on participant earnings, account balances, or participant transactions as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants direct their investment of their contributions into various investment options provided by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

**Benefits and Vesting**

The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested accounts, which includes participant and Company contributions and related earnings thereon. Earnings are allocated based on the individual participant's account balance in relation to total participant account balances. Participants are vested on a 3-year cliff for all contribution types as well as earnings on those contributions.

**Payment of Benefits**

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For vested account balances under \$5,000, the participant's benefit will be automatically distributed.

Participants may also be entitled to in service distributions for hardship, qualified reservists, deemed severance, or age 59 ½, subject to Plan provisions.

**Forfeited Accounts**

Forfeited balances of terminated participants' non-vested accounts are used to reduce future Plan Sponsor matching contributions or to pay reasonable Plan expenses. As of December 31, 2024, there were \$39 of forfeited non-vested accounts.

**Administrative Expenses**

Certain administrative expenses of the Plan are paid by the Plan. All other administrative expenses are paid by the Plan Sponsor.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting and present the net assets available for benefits and changes in those net assets. Consequently, certain additions and the related assets are recognized when received rather than when earned and certain deductions are recognized when paid rather than when the obligation is incurred. The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results may differ from these estimates.

## **2. Summary of Significant Accounting Policies (Continued)**

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The net appreciation (depreciation) in fair value for each investment option is included in investment income in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

### **Benefits Paid**

Benefit payments to participants are recorded upon distribution.

### **Management's Review of Subsequent Events**

The Plan has evaluated and considered the need to recognize or disclose subsequent events through July 7, 2025 which represents the date that these financial statements were available to be issued. Subsequent events past this date, as they pertain to the year ended December 31, 2024 have not been evaluated by the Plan.

## **3. Information Certified by the Plan's Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement, LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023 and investment related activity reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.

## **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments as follows:

**5. Fully Benefit – Responsive Investment Contracts**

The Plan has an insurance group annuity contract with Empower Annuity Insurance Company of America ("Guaranteed Interest Fund"). Empower maintains the contributions in a general account. The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis.

The contract was included in the financial statements at contract value of approximately \$34,940 as of December 31, 2024 and \$43,673 as of December 31, 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no unfunded commitments.

**5. Fully Benefit – Responsive Investment Contracts (Continued)**

The Plan may discontinue the contract at any time, upon written notice. In addition, certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**6. Tax Status**

The Plan is based on a non-standardized defined contribution pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service on November 14, 2022, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods currently in progress. The Plan's Form 5500 is open for inspection by taxing authorities, generally for three years after being filed.

**7. Party-in-Interest Transactions**

Certain investments in the Plan are managed by Empower Retirement, LLC, the custodian of the plan. Therefore, these transactions qualify as party-in-interest transactions.

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

The Plan pays certain investment advisory, Plan recordkeeping, and third-party administration fees to MCF Investment Advisors, Empower Annuity Insurance Company, and Empower Trust Company, which are parties-in-interest to the Plan.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to participant accounts will be fully vested and will be paid to the participants. In case of a partial termination, only those affected will become fully vested.

**9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. Prohibited Transactions**

The Company failed to remit to the Plan's custodian certain employee contributions for 2023 totaling \$3,238 within the time period prescribed by regulations of the Department of Labor. These non-exempt transactions may result in the imposition of a 15% excise tax, but do not affect the tax status determination of the Plan. These contributions were corrected during 2024.

**11. Subsequent Events**

Effective May 22, 2025, the Plan was amended to revise the match formula. The Company match was changed to match 100% of employee deferral amounts up to a maximum of \$20 per week.
