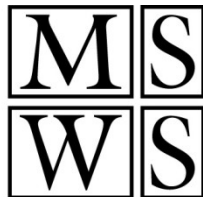

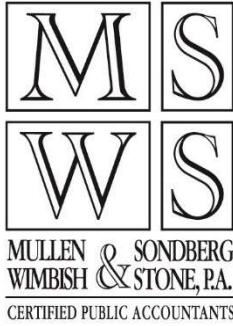

## INDEPENDENT AUDITOR'S REPORT

### **Opinion**

We have audited the accompanying financial statements of The Benedictine School for Exceptional Children Health and Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Securities Act of 1947 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and statements changes in benefit obligations for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of The Benedictine School for Exceptional Children Health and Welfare Benefit Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits and changes in benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

Note 1 - Description of the Plan

The following description of The Benedictine School for Exceptional Children Health and Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a self-funded group health plan that provides medical benefits covering eligible employees of The Benedictine School for Exceptional Children, Inc. (the Plan Sponsor). The Plan and related trust were established in November 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). On November 1, 2019 the Plan was amended to change the plan year end to December 31. The Plan was amended and restated on January 1, 2020 to update the medical benefits section for covered services and to add provisions related to benefit denials and claims procedures during the COVID-19 pandemic.

*Benefits:* The Plan provides group medical and prescription drug coverage for eligible employees of the Plan Sponsor. Employees of the Plan Sponsor and their dependents are eligible for benefits on the first of the month following 30 days of employment. Employees working 30 hours or more per week are eligible for medical benefits under the Plan.

Medical and prescription drug claims of participants and their dependents are processed by a third-party administrator, but the responsibility for payments to participants and providers is retained by the Plan.

*Stop-Loss Coverage:* The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

*Contributions:* The Plan Sponsor makes monthly payments to the Plan in amounts necessary for the payment of all claims, stop loss insurance and reasonable administrative expenses of the Plan, as determined by the Trustee. Employees are required to make payments to the Plan, as determined by the Trustee, to cover part of the cost of providing benefits.

*COBRA (Consolidated Omnibus Budget Reconciliation Act):* The Plan is required by law to offer continuation of benefits for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event. Each qualifying individual pays their premium directly to the administrator.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Note 2 - Summary of Accounting Policies (Cont.)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Income Tax Status

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes that the Plan, as amended, is designed and currently is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Cash Equivalents

Cash and cash equivalents represent deposits in checking and savings accounts.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. Employer contributions are also recorded in the year in which the participant contributions are withheld from the amounts paid. There were no participant or employer contribution receivables as of December 31, 2024 and 2023.

Payment of Benefits

Premiums paid by either the Plan Sponsor or the Trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as accrued liabilities in the accompanying statements of net assets available for benefits.

Stop-Loss

Premiums for stop-loss insurance are included in premium payments in the statements of changes in net assets available for benefits. Stop-loss refunds totaling \$374,162 and \$42,286 have been netted with claims paid in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Administrative Fees

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

Note 3 - Concentration of Cash Balances

The Trust maintains its cash and cash equivalents with a commercial financial institution, which aggregate balance, at times, may exceed the Federal Deposit Insurance Corporation (FDIC) insured limit of \$250,000 per depositor per institution.

Note 4 - Claims Incurred but Not Reported

Plan obligations for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators on a quarterly basis. A method was used that applies a factor (the reserve factor) to a credible best estimate volume measurement of paid claims to arrive at the estimate of claims incurred but not reported. Due to the short nature of this reserve liability, time value of money was not used to discount future payments. The amount of claims incurred but not reported in the statements of benefit obligations as of December 31, 2024 and 2023 was \$256,285 and \$252,330, respectively. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Note 5 - Surplus Distribution Expense

During the year ended December 31, 2024, the Plan received a surplus distribution credit of \$546,783. The surplus arose due to favorable claims experience under the group health insurance policy issued by CareFirst for the policy period January 1, 2023 through December 31, 2023. These funds represent excess funds not needed for benefit or administrative obligations. In accordance with the terms of the policy and applicable Department of Labor guidance regarding plan assets and ERISA requirements, the Plan Sponsor elected to apply the surplus, totaling \$546,783, as a premium credit to offset employer contributions for the plan year ended December 31, 2024. The surplus distribution was not allocated to participants and was not distributed in cash. The use of the surplus credit complied with plan provisions and fiduciary responsibilities under ERISA, and the credit was not used for any purpose other than to fund benefits or pay reasonable administrative expenses of the Plan. The surplus distribution credit was recorded as a surplus distribution expense in the accompanying statement of changes in net assets available for benefits. There were no surplus distributions during the year ended December 31, 2023.

Note 6 - Related Party Transactions

CareFirst provides administrative services for the Plan. Acisure and ISI of Maryland, LLC provides insurance broker services for the Plan. The Benecon Group provides accounting and administrative services for the Plan. ConnectCare 3 provides patient advocate services for the Plan. These transactions qualify as party-in-interest transactions. Total fees paid included the following for the years ended December 31:

During the plan year ended December 31, 2024, the Plan received a credit of \$546,783 from CareFirst, representing a distribution of surplus funds based on favorable claims experience under the Plan's group health insurance policy. The surplus funds were returned in accordance with the provisions of the group insurance contract and the Plan's governing documents, and were applied as a premium credit for the plan year ended December 31, 2024. This transaction constitutes a party-in-interest transaction as defined under the Employee Retirement Income Security Act of 1974 (ERISA), due to the involvement of the insurance provider, which is a service provider to the Plan. No cash distributions were made directly to participants. This transaction was conducted at arm's length and is not considered a prohibited transaction under ERISA Section 406, as it qualifies for an exemption under Section 408(b)(2) and related regulations.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Plan's Board of Directors has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Reconciliation of Financial Statements to Form 5500

Note 9 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. Except for the following, there have been no subsequent events through, July 24, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.

On January 1, 2025 the Plan changed their third party administrative services from The Benecon Group to CareFirst. On January 1, 2025 the Plan also changed the stop loss insurance policy carrier from HM Life Insurance Company to CareFirst of Maryland, Inc.

On April 7, 2025 the Plan transferred \$979,347 from the Plan's claim checking account to the Plan Sponsor, The Benedictine School for Exceptional Children, Inc. This cash transfer was made to close out the claim checking account with The Benecon Group due to the change in the third party administrator subsequent to year end.


