Opinion

Notes to Financial Statements

1. Plan Description

The following description of the Alaska Public Broadcasting Health Trust Health & Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is sponsored under a Multiple Employer Welfare Agreement (MEWA).

General

The Plan provides health and other benefits to all eligible employees of participating employers who have adopted the Plan (Participating Employers) and have at least two common law employees in the radio, television, or broadcasting industry in Alaska, and former employees of Participating Employers electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended, and the Health Insurance Portability and Accountability Act (HIPAA) of 1996.

Trust Agreement and Administration of The Plan

Prior to January 1, 2017, the Plan was an unfunded MEWA sponsored by Alaska Public Broadcasting, Inc. Effective January 1, 2017, the Plan executed a trust agreement and established a trust fund known as the Alaska Public Broadcasting Health Trust (Trust). The Plan and Trust constitute a Voluntary Employees' Benefits Association (VEBA) under section 501(c)(9) of the Internal Revenue Code of 1986. The trust agreement appointed a Board of Trustees to administer the Trust and the Board of Trustees appointed Alaska Public Broadcasting, Inc. (Plan Administrator) to perform day-to-day administration and operation of the Plan and Trust. Effective July 1, 2021, Alaska Public Broadcasting, Inc. merged with CoastAlaska, Inc. (CoastAK). The Plan appointed CoastAK as the new Plan Administrator for the Trust.

Benefits

The Plan provides medical, dental, vision, prescription drug, life insurance, and accidental death and disability benefits to full-time employees of Participating Employers and to their beneficiaries and covered dependents. An eligible participant is defined as a person who is hired by a Participating Employer. The participant must complete the employment waiting period of 30 days.

All benefits are fully insured. The Trust purchases insurance contracts for the insured benefits. Premiums are paid to the insurance company from the Trust.

Contributions

Participating Employers contribute to the Plan amounts that are determined by the Board of Trustees and agreed to by the Participating Employers to cover insurance premiums and expenses of the Plan. Once the amounts are established, the Plan Administrator invoices the Participating Employers for the employees enrolled in the Plan. The cost share of the amount that can be charged to participating employees is left to the Participating Employer's discretion, as long as the Participating Employer is contributing at least 75% of the eligible participating employee coverage. Premium contributions made by participants to the Plan are included in the accompanying financial statements as Participating Employer contributions.

Notes to Financial Statements

Participants may also contribute to a Health Savings Account as provided by the Plan Document. Such amounts are owned by the participants and may be used by the participant for any allowable health costs under the applicable regulations. As these are not used to pay the Plan's obligations, this activity is excluded from the accompanying financial statements.

Included in the monthly contribution amounts noted above is an administrative fee of \$15 per participant per month for the year ended December 31, 2024. This administrative fee is collected from Participating Employers and used by the Plan Administrator to defray third-party administrator fees and other expenses of the Plan.

Starting in 2020, upon enrollment into the Plan, new Participating Employers will pay an initial deposit of an estimated first month's premium payment to be held by the Trust and reimbursed at the end of the Participating Employer's relationship with the Plan after all outstanding liabilities are paid and amounts reconciled. On April 5, 2024, the Board of Trustees approved a motion that all current Participating Employers (who have not already paid an initial deposit) will now be required to pay a deposit of an estimated first month's premium payment to be held by the Trust and reimbursed at the end of the Participating Employer's relationship with the Plan after all outstanding liabilities are paid and amounts reconciled. Total deposits of \$117,170 and \$16,888 are recorded as Participating Employer deposits on the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Accounts Receivable

Accounts receivable represent unpaid contribution payments from Participating Employers or participant COBRA payments. The Plan has determined that no allowance for doubtful accounts is necessary, as all receivables were determined to be collectible.

Third-Party Administrator Fees

Third-party administrator fees are paid by the Plan and are included in administrative expenses on the statement of changes in net assets available for benefits.

Insurance Premiums

Insurance premiums paid to the insurance carriers are recognized in the period to which the coverage relates.

Notes to Financial Statements

Income Taxes

The trust established under the Plan is designed to be exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code. Accordingly, the financial statements reflect no federal income tax expense. A favorable tax exemption letter has been received from the Internal Revenue Service on July 24, 2017. The appointed Board of Trustees are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Trust.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

Management has evaluated subsequent events through July 25, 2025, the date the financial statements were available for issue. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements, except as noted below.

Effective January 1, 2025, the administrative fee that is charged to individual participants was increased to \$17.50 per participant per month.

3. Related Party and Party-in-Interest Transactions

The Plan appointed CoastAK as Plan Administrator for the Trust. The Plan Administrator is also a Participating Employer in the Plan. For the year ended December 31, 2024, CoastAK collected an administrative fee of \$7,500 from the Plan. Certain legal, insurance, accounting and auditing, and other expenses are paid from the Plan. These transactions are exempt from the prohibited transaction rules.

4. Concentration of Credit Risk

The Plan maintains deposits in a cash account, which may at times exceed federally insured limits of \$250,000. The Plan has not experienced any losses in such accounts. The Plan monitors the strength of the financial institutions with which it does business and believes it is not exposed to any significant concentration risk of its cash balances. As of December 31, 2024 and 2023, the Plan's cash balance did not exceed the federally insured amounts.
