Note 1. Description of Plan

The following description of the Manasquan Bank 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Manasquan Bank (Company), with the exception of union employees, certain nonresident aliens, and interns. Employees are eligible to participate in the Plan upon attainment of age 21 and completion of 3 consecutive months of service in which 83.3 hours have been completed each month. Participation in the Plan begins on the first day of the month coinciding with, or following, the date of satisfaction of the eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The trustee of the Plan is Reliance Trust Company, and the record-keeper is Automatic Data Processing, Inc. (ADP).

Contributions

Participants may contribute up to 90% of their compensation, as defined by the Plan, as Pre-tax or Roth deferral contributions not to exceed statutory limitations permitted by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing eligible rollovers from other qualified plans.

Effective January 1, 2024, the Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of their eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature does not provide for an annual increase in the percentage deferred.

The Company may make discretionary matching contributions, allocated each payroll period, equal to a uniform percentage of participant contributions up to a certain portion of participant compensation. Employees are eligible for matching contributions upon attainment of age 21 and completion of 3 consecutive months of service in which 83.3 hours have been completed each month. For the year ended December 31, 2024, the Company made discretionary matching contributions of 50% of participant contributions, including catch-up contributions, up to 5% of participant compensation.

The Company may make discretionary profit-sharing contributions, allocated annually, equal to a uniform percentage of eligible participant compensation as defined by the Plan. Employees are eligible for discretionary profit-sharing contributions upon attainment of age 21 and completion of one year of service. In order to share in the profit-sharing contribution, participants must be employed on the last day of the Plan year except for participants who have reached normal retirement age (65), disability, and death. For the year ended December 31, 2024, the Company made discretionary profit-sharing contributions of 2.5% of eligible participant compensation.

The Plan has elected "safe harbor" status and, therefore, the Company makes contributions equal to 3% of eligible participant compensation as defined by the Plan to comply with the safe harbor provisions of the internal revenue code. Employees are eligible for matching contributions upon attainment of age 21 and completion of 3 consecutive months of service in which 83.3 hours have been completed each month. This contribution is allocated to participants each payroll period.

Participant Accounts

Participants direct the investment of participant and employer contributions into various investment options offered by the plan. Each participant's account is credited with the participant's contributions and allocations of the company's contributions and plan earnings (losses) and may be charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined by the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their contributions and safe harbor contributions, plus actual earnings thereon. Upon reaching normal retirement, disability, or death, participant accounts also become fully vested. Vesting in the Company's matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have two loans outstanding at any time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% as defined by the plan. Interest rates on outstanding loan balances ranged from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions. All outstanding loan balances will become due and payable in their entirety upon severance of employment. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

A participants' vested interest in the Plan's assets are distributable generally upon termination, normal retirement age (65), disability, or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the plan document. At their election and upon attainment of age 59 ½, participants may receive an in-service distribution.

Participants may receive hardship distributions to satisfy certain immediate and heavy financial needs, which include expenses for medical care for themselves, their spouse, their dependents, or their beneficiaries; costs directly related to the purchase of their principal residence (excluding mortgage payments); tuition, related educational fees, and room and board expenses for the next 12 months of post-secondary education for themselves, their spouse, their dependents, or their beneficiaries; amounts necessary to prevent their eviction from their principal residence or foreclosure on the mortgage of their principal residence; payments for burial or funeral expenses for their deceased parent, spouse, children, other dependents, or beneficiaries; and expenses for the repair of damage to their principal residence that would qualify for the casualty deduction under the IRC. These distributions are not in addition to other benefits and will therefore reduce the value of the benefits received upon retirement.

Forfeitures

The portion of a participant's balance, which is not vested upon termination of employment, is forfeited, and remains in the Plan. Forfeited nonvested accounts are used to reduce future Company contributions and to pay Plan expenses. Approximately \$31,000 of plan forfeitures were used to reduce employer contributions for the year ended December 31, 2024. Forfeitures from participants approximated \$31,000 for the year ended December 31, 2024. There was no available balance of forfeitures as of December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, as permitted by the Plan document. All other administrative expenses are paid by the Company, which are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Note 3. Investment Certification

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: are stated at fair value based on quoted prices in an active market for each share held by the Plan.

Stable value collective trust fund: a stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the plan initiates a full redemption of the stable value collective trust, the issuer reserves the right to require 90 days' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Related-Party and Party-in-Interest Transactions

ADP is the record keeper for the Plan and therefore, these services qualify as party-in-interest transactions. Fees paid to ADP for record keeping and administrative services amounted to \$12,764 for the year ended December 31, 2024.

ADP receives revenue from certain investments in the Plan. ADP and the Company have agreed that if this revenue exceeds an agreed upon revenue rate, ADP shall make an amount equal to such excess available to the Plan to pay ERISA qualified plan administrative expenses. For the year ended December 31, 2024, an excess of \$72,589 was made available to the Plan and was used to pay the investment advisor. There was no remaining balance available to pay future expenses as of December 31, 2024 and 2023.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in mutual funds and common collective trust funds that invest in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.
