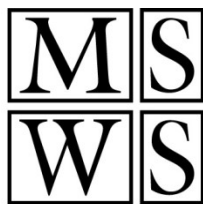

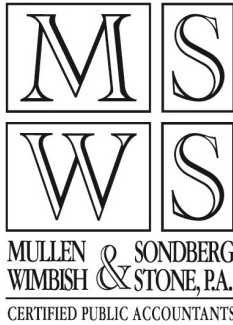

Note 1 - Description of Plan

The following description of the Family & Nursing Care, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that was established by the Company on January 1, 1998 to provide benefits to eligible employees. The Company is the parent company of two subsidiaries, Family & Nursing Care Classic, LLC (Classic) and Family & Nursing Care Select, LLC (Select). The parent and subsidiaries are all part of a controlled group covered by the Plan. The Plan covers all employees of the Company who are 21 years of age or older. Office employees of the Company, Classic and Select must complete six months of service and field employees of Select must complete one year of service to be eligible to contribute to the Plan. Plan entry dates are January 1st or July 1st which coincides with or immediately follows the date eligibility requirements are met. All eligible employees who are employed on the last day of the Plan year are eligible to receive discretionary matching and profit sharing contributions. The Plan is subject to the provisions of ERISA.

Contributions: Participants may elect to have the Company contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant's direction. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

The Company is allowed to make matching contributions as defined in the Plan and as approved by the Company. For the years ended December 31, 2024 and 2023, the Company matched 25% of each eligible participant's contribution up to a maximum of 6% of the participant's compensation. The Plan also allows for a discretionary profit sharing contribution in an amount determined annually by the Company. No discretionary profit sharing contribution were made for the years ended December 31, 2024 and 2023. Total contributions made by the Company for the years ended December 31, 2024 and 2023 were \$287,030 and \$259,651, respectively.

Note 1 - Description of Plan (Cont.)

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) Plan earnings, and charged with applicable fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the Plan administrator.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of employment. Upon termination of employment due to death or disability (approved by Social Security), a participant becomes fully vested in their account.

Payment of Benefits: Upon termination, the participant or beneficiary will receive the benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments, paid at least annually over a period not exceeding the joint and survivor life expectancy of the participant and beneficiary. The Plan allows for automatic lump-sum distributions of participant vested account balances which do not exceed \$7,000.

Administrative Expenses: The administrative expenses related to the Plan's Trustee are paid by the Plan. The Employer pays all other administrative expenses of the Plan.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,534 and \$33,114, respectively. These accounts may be used to reduce future employer contributions and pay administrative fees. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$32,409 and \$-0-, respectively. For the years December 31, 2024 and 2023, forfeitures of \$-0-, were used to pay administrative expenses.

Notes Receivable from Participants: Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan. These loans are secured by the vested portion of the participant's account and bear interest rates at 4.25% to 9.50%. Repayment of loans is provided through automatic payroll deduction.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase in benefits paid to participants. The Plan distributed the 2024 and 2023 excess contributions of \$36,292 and \$40,822, respectively, to the applicable participants prior to March 15, 2025 and 2024, respectively.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, the loan balances outstanding totaled \$303,907 and \$241,741, respectively. The Plan administrator has determined all noted receivable are fully collectible from the participant's vested account balances; consequently, no amounts have been recorded as an allowance.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Benefits paid, including corrective distributions, to participants amounted to \$1,096,612 and \$591,921 for the years ended December 31, 2024 and 2023, respectively.

Contributions and Related Receivables

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from the amounts paid. The Employer discretionary match is recorded in the year in which the Employer designated the contributions. All participant and Employer contributions are participant-directed. The plan administrator has determined that all participant and Employer contributions receivable are fully collectible; consequently, no amount has been recorded as an allowance for credit losses in the accompanying statements of net assets available for benefits. Total contributions receivables for the years ended December 31, 2024 and 2023 amounted to \$319,439 and \$259,651, respectively.

Note 3 - Information Prepared and Certified by Trustee

Investment Data

All investment data contained in the statements of net assets available for benefits, statements of changed in net assets available for benefits for the years ended December 31, 2024 and 2023 and the Schedule H, line 4i – Schedule of assets (held at end of year) for the year ended December 31, 2024 was summarized from information provided by Reliance Trust Company, the Trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained a certification from the Trustee that the information provided to the Plan administrator by the Trustee is complete and accurate.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, Line 4i – Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820-10 Fair Value Measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

The Plan has no Level 2 or Level 3 investments. As of December 31, 2024 and 2023 the Plan's Level 1 investments comprise of registered investment companies valued at \$12,700,811 and \$10,249,558, respectively.

Note 4 - Fair Value Measurements (Cont.)

Registered investment companies: Investments whose values are based on quoted market prices in active markets, and are, therefore classified with Level 1, includes funds with registered investment companies. Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

Common collective trusts: A common collective trust that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

(a) Common Collective Trust Funds are valued at the NAV of units of a bank collective trust. The NAV as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund (a diversified portfolio) less its liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended December 31, 2024 and 2023, there were no reportable transactions.

Note 6 - Related Party Transactions

The Employer provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan's auditor, who audits the Plan's financial statements are paid directly by the Plan Sponsor. These fees are not reflected in these financial statements.

Certain Plan investments are shares of mutual funds managed by ADP, Inc. ADP, Inc. is the third party administrator for the Plan and received fees in the amount of \$69,338 and \$44,380 for the years ended December 31, 2024 and 2023, respectively. HUB International is the investment fiduciary and provides investment advisory services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$30,756 and \$23,557, respectively.

Note 7 - Tax Status

Effective July 8, 2014, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on October 6, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the prototype received its opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Note 7 - Tax Status (Cont.)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

Note 9 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
