### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on these 2023 financial statements.

### 1. DESCRIPTION OF THE PLAN

The following description of the Georg Utz 401k Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, which includes a salary reduction feature that meets the requirements of section 401(k) of the Internal Revenue Code ("IRC"). The Plan, established in 2004, is sponsored by Georg Utz, Inc. ("Georg Utz", "Employer" or the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective February 1, 2024, employees are eligible to be enrolled in the Plan once they have attained the age of 18 and have completed six months of service. Prior to this adoption agreement modification, participants were required to attain the age of 21 and have completed six months of service in order to be eligible to participate. One month of service is defined as having worked one hour in a calendar month.

#### Contributions

Participants are permitted to make salary deferral contributions up to the current Internal Revenue Service ("IRS") deferral limits but not exceeding 90% of the participant's salary. The Employer contributes 3% on plan eligible compensation and a discretionary portion of the Company's profits as determined by the Board of Directors.

Effective January 1, 2024, the Plan created an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless an affirmative election not to participate in the Plan is executed. Employees included in the plan, but not yet participating prior to 2024, were also automatically enrolled in the Plan. Automatically enrolled participants have their contribution rate set at 6% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant. The initial automatic deferral amount will increase annually by 1% as soon as administratively feasible on the succeeding anniversary date up to a maximum of 10%.

Participants direct the investment of their contributions into various options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Plan earnings are based on the investments selected by the participants in their account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes Receivable from Participants

Each participant can obtain a note between \$500 and the lesser of 50% of the participant's vested account balance or \$50,000. The loan term may not exceed five years unless such loan is for the purpose of the participant's primary residence in which the loan may not exceed thirty years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate based on the prime rate plus two percentage points. Principal and interest are paid during each pay period through payroll deductions. A participant may only have one loan outstanding at a time.

### Vesting

Participants are vested immediately in salary deferral contributions and Company's safe harbor non-elective and discretionary profit-sharing contributions, as well as earnings on those contributions.

### Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump sum or installment amount equal to the value of the participant's vested account balance. Participants may also receive in-service withdrawals upon attaining age 59½, incurring disability or in case of hardship.

### Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$29 and \$23, respectively. The non-vested portion of former participants' accounts may be used to pay administrative expenses of the Plan or to reduce the amount of future employer contributions. Activity was insignificant for the plan year ended December 31, 2024.

### Administrative Expenses

Administrative expenses for maintaining the Plan are paid by the Company or plan participants, as defined in the plan agreement.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of the Plan's assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as deemed distributions based on the terms of the plan document.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Risks and Uncertainties

The Plan provides for investments in various types of investments. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially

affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Tax Status

The Plan is based on a preapproved plan document sponsored by Automatic Data Processing, Inc. ("ADP"), who has received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, that the plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for an opinion letter from the IRS. However, the plan administrator believes that the Plan was designed and is currently operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is July 23, 2025.

### **3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance) has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.
