Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Norway Savings Bank 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of Plan

The following description of Norway Savings Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution salary deferral plan covering substantially all employees of Norway Savings Bank (the Bank) who are age 21 or older and have completed two calendar months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan excludes union employees (as defined in Plan Section 1.25), leased employees, seasonal, and temporary employees.

The Plan provides for automatic enrollment. Once an employee meets the eligibility requirement, they are automatically enrolled at a rate of 3% of Plan compensation, unless the employee declines enrollment. The Plan's automatic contributions provision provides for an automatic escalation of contributions by 1% annually in February, up to a maximum contribution of 10%.

Contributions

Each year, participants may contribute up to 90% of annual pretax Plan compensation, not to exceed the maximum amount allowable under the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Plan contributes a non-discretionary match of 25% of the first 6% of the participant's elected deferral, including catch-up contributions, and a 401(k) safe harbor contribution whereby the Bank contributes 3% of Plan compensation regardless of the participant making a deferral.

The Plan offers a Roth elective deferral which allows for after tax contributions.

Effective January 1, 2013, the Plan added a discretionary nonelective employer profit sharing contribution to all eligible participants due to the amendment to the defined benefit retirement plan of the Bank to cease further benefit accruals. The contribution ranges from 3% to 17.1%. Supplementary contributions are available to employees of certain age and years of service. In order to share in the nonelective contribution, participants must be employed on the last day of the plan year and complete at least 1,000 hours of service.

Employee contributions are funded on a payroll basis; employer match and safe harbor contributions are also funded on a payroll basis. Discretionary nonelective employer profit sharing contributions are funded annually.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Bank's matching, safe harbor and nonelective contribution and allocation of Plan earnings and charged with an allocation of Plan losses and administrative expenses. Allocations are based primarily on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately vested in their contributions, rollover contributions, and the Bank's safe harbor contribution, plus actual earnings thereon. Vesting in the Bank's nonelective and matching contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants are 100% vested after five years of credited service. Forfeitures of non-vested account balances of terminated employees are used to reduce future nonelective and matching contributions of the Bank. During 2024, forfeitures of \$73,186 were used to reduce the Bank's matching contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. The Plan allows two loans at any time. The loans are secured by the balance in the participant's account and bear interest at a rate of prime, plus 1%, which is commensurate with local prevailing rates as determined by the plan administrator. Based on management's assessment of the employment status of the participants having outstanding balances and their payment histories, it has concluded the realization of losses on balances outstanding at year-end will be immaterial. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Participants may elect to receive the value of their vested accumulated plan benefits as a lump-sum distribution upon retirement or termination, in substantially equal installments, or as partial withdrawals. If an account balance is less than \$5,000 and a participant has not elected to have their vested accumulated plan benefits paid as a direct rollover to an IRA or another employer's tax qualified plan, the Plan administrator will transfer the balance into an IRA on behalf of the participant, unless the participant consents to a lump-sum distribution.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded in the period in which they are paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based on terms of the loan policy. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Bank and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Fees related to withdrawal charges are netted with benefit payments.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

4. Information Prepared and Certified by Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividends were obtained by management and agreed to or derived from the information certified by Reliance Trust Company, the trustee, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

5. Plan Termination

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

6. Tax Status

The Bank adopted a prototype profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020, which stated that the prototype plan as then designed was in compliance with the applicable sections of the IRC. The prototype plan has been amended since receiving the opinion letter. Management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party Transactions

During the year ended December 31, 2024, the Plan paid commissions and fees to certain parties-in-interest. Commissions of \$10,636 were paid to Merrill Lynch, the Plan's financial advisor, and \$68,783 in transaction-based charges was paid to ADP, the Plan's third-party administrator.

9. Subsequent Events

Management has made an evaluation of subsequent events through July 24, 2025, which was the date the financial statements were available to be issued and determined that any subsequent events that would require recognition or disclosure have been considered in the preparation of these financial statements.
