### 1. Description of Plan

The following description of Skowhegan Savings Bank 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all full-time employees of Skowhegan Savings Bank (the Bank) who are at least 18 years of age and have met service requirements specified by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute a portion of their compensation subject to Internal Revenue Service (IRS) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Eligible employees hired after January 1, 2022 are automatically enrolled in the Plan at 5% if they do not voluntarily enroll or opt out within 30 days.

The Bank makes safe harbor contributions in the amount of 3% of participants' eligible compensation.

The Bank contributes 100% of the first 5% of base compensation that a participant contributes to the Plan. The matching Bank contribution is invested as directed by the participant. The Bank may also elect to make discretionary contributions. No discretionary contribution was made in 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Bank's matching and safe harbor contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions, plus actual earnings on the contributions. Vesting in the Bank's contribution portion of participant accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. No loan shall be for a term exceeding five years, unless the loan proceeds are used for the purchase of a primary residence.

### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

Any benefits payable under the Plan to a participant who has retired, or a terminated employment for any reason other than death, shall be distributed to the participant as follows: (1) if the value of the vested account balance does not exceed \$1,000, the Plan Administrator may distribute the participant's vested balance in a lump-sum payment without the participant's consent; and (2) if the value of the vested account balance is more than \$1,000, but does not exceed \$5,000, then a lump-sum distribution will be made to the participant if the participant does not elect to have their vested balance rolled over into an Individual Retirement Account.

### **Forfeited Accounts**

Forfeitures of amounts attributable to the nonvested portion of employer contributions shall be used to reduce future employer contributions. Forfeitures were not material to the Plan in 2024 or 2023.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

The common/collective trust (the Trust) is comprised of guaranteed investment contracts and similar contracts issued by insurance companies, banks, and other financial institutions. The Plan can request withdrawals from the Trust daily; however, the Trust may defer honoring the request for a period of up to 12 months, subject to certain provisions of the Trust. All funds are valued daily and units of participation may be purchased or redeemed on the valuation dates at the net asset value (NAV) per unit. Participants can request redemptions at any time. The Trust strives to maintain at least 5% of its assets in high-quality money market instruments, cash, and cash equivalents.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. For notes receivable from participants in which the participant has a distributable event, such as employment termination, death, or disability, the notes receivable would be considered a distribution. The notes receivable is removed from the statement of net assets available for benefits and a deemed distribution of participant loans is recorded. For active participants who have not incurred a distributable event, but have delinquent loans, the notes receivable remains outstanding until a distributable event occurs. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### **Payment of Benefits**

Benefits are recorded in the period in which they are paid.

### **Administrative Expenses**

Investment fund management fees are charged to the Plan and are included in net appreciation in fair value of investments. During 2024, the Plan paid fees of \$29,239 to the Plan investment advisor for investment advisory fees, and \$5,300 to the Plan third-party administrator. The remainder of the fees paid from the Plan in 2024 were paid to the Plan trustee.

### **Subsequent Events**

The Plan has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described below:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability, and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted NAV of shares held by the Plan at year-end.

*Common/collective trust:* Valued using the market approach based on the NAV of the units held by the Plan at year-end. The NAV is provided by the trustee of the Trust and is used as a practical expedient to estimate fair value.

### 6. Tax Status

The Plan obtained its latest prototype opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan has been amended and restated since receiving the opinion letter; however, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Management has determined that the Plan has no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

### 8. Party-In-Interest Transactions

Plan investments are managed by Empower Trust Company, LLC (Empower). Empower provides trustee and plan administration services and, therefore, these transactions qualify as party-in-interest transactions under ERISA.
