(1) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General Description of the Plan

The following is a description of the Daigle Oil Company 401(k) Plan that provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The plan is a defined contribution plan covering substantially all full-time employees of Daigle Oil Company who meet certain age and length of service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Significant costs of administering the plan are absorbed by the Plan Sponsor. Expenses paid by the sponsor are not included in these financial statements.

Contributions

For 2024, participants may contribute up to \$23,000 (or \$30,500 if over age 50) of pre-tax annual compensation as defined in the Plan. The Plan also allows for ROTH contributions to be made with after tax compensation. Participants may also contribute amounts representing distributions or rollovers from other qualified plans. At the discretion of management, the Company may make a matching contribution of 30% of the employee contribution up to 15% of salary. Participants direct the investment of these contributions into the various funds offered by the Plan.

Participant Accounts and Vesting

Each participant's account is credited with participant and employer contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined in the Plan. Participants are immediately vested in their contributions plus applicable earnings on those contributions. Participants become fully vested in the Company contributions plus applicable earnings after six years of service. After the first year, they become vested 20% which then increases by 20% each year, thereafter, until they are fully vested.

Participant Loans

Participants may not borrow from their 401(k) accounts.

Payment of Benefits

Upon termination of service due to disability or retirement, a participant will receive access to the entire balance of their account. On termination of service due to death, the beneficiary may elect to receive the entire balance as a lump-sum or in installment payments. For termination due to other reasons a participant will receive the value of the vested interest as a lump-sum distribution.

The plan has the option upon termination, to distribute account balances of less than \$1,000.

Forfeitures

Amounts which become forfeited due to termination are available to reduce the Employer's matching contribution or plan expenses each year. During 2024, forfeitures of \$152 were used to reduce the administrator fees. As of December 31, 2024, forfeitures of \$12,636 were available to reduce the match or pay plan expenses.

Investment Valuation and Income Recognition

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following methods and assumptions were used to estimate the fair value of each class of investment assets. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

- Investment securities in registered investment companies are valued at their quoted market prices from an active market as of the reporting date.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

In accordance with GAAP, the guaranteed interest accounts are not included in the fair value hierarchy discussed above and have been valued at contract value (which approximates fair value) since they are fully benefit responsive. The contract value is the total of contributions made under the contract, plus earnings, less withdrawals and administrative fees. The contracts are most similar to bank CD's with a revolving interest guarantee. The interest rate is established on a semi-annual basis and is credited based on the daily balance at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate. During 2024 and 2023, the average yield earned and the actual interest rate credited to participants ranged from 2.25% to 1.18%. The terms of the contract require the transactions to occur at contract value with no conditions, limits, or restrictions.

Excess Contributions

The Plan requires annual non-discrimination testing to be performed for the Plan to be considered qualified. This testing revealed that there were excess contributions made in 2024 for highly compensated employees. The excess contributions for highly compensated employees plus the earnings on these amounts were returned to the applicable participants in 2025. The liability with a corresponding reduction to contributions for the excess contributions is accrued and recognized in the year that the testing was for and corrected by being paid out in the subsequent year.

Method of Accounting

The Plan uses the accrual method of accounting. Under the accrual method, revenues and expenses are recorded when they are earned or incurred.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Net Assets Available for Benefits

The net assets available for benefits as of December 31, 2024 and December 31, 2023 reflect the investments at fair value for the investments with registered investment companies and contract value for the investments in contracts with insurance companies. The majority of the Plan assets are allocated to the participants. The unallocated balances in forfeiture and expense accounts as of December 31, 2024 totaled \$13,072.

(2) TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan was restated in 2021, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan has implemented certain requirements by Division T of the Consolidated Appropriations Act of 2023 (SECURE 2.0), which are laws that change the Plan to further delay required minimum distributions, expand availability of the plan to certain part-time workers, increase the catch-up contribution limits for certain participants as well as various voluntary provisions which may or may not be elected by the plan sponsor. The plan is currently being operated in accordance with the mandatory provisions of SECURE 2.0 and the plan sponsor has until December 31, 2026 to decide on the voluntary provisions. Written amendments to the Plan to reflect these operational changes will be formalized at a later date in accordance with applicable law and IRS guidance.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Government. The plan files Form 5500 annually with the U.S. Government, and tax years 2022, 2023 and 2024 remain open to examination. There are currently no exams for any tax periods in progress.

(3) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

(4) RISKS AND UNCERTAINTIES

The Plan invests in various funds which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. More recent risks include, but are not limited to military conflicts in Europe, the oil and gas market, supply chain issues and inflation. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(5) CERTIFIED INVESTMENTS

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared by Transamerica (Custodian) and certified as complete and accurate by Reliance Trust Company (Trustee).

The Plan contracts with various service providers to manage its investments, provide recordkeeping and administration services and investment advice. Plan investments in the amount of \$11,022,204 are managed by Transamerica Life Insurance Company. Transamerica is also the recordkeeper for the Plan. The TPA Experts is the third-party administrator for the plan. Ameriprise is the Plan advisor and Reliance Trust Company is the Plan trustee. These service providers qualify as parties in interest, and fees paid to them from plan assets are considered party in interest transactions.

Fees charged to the plan by these service providers amounted to \$34,806 during 2024. The other expenses were absorbed by the plan sponsor and are not included in these financial statements.
