Independent Auditors' Report

To the Plan Administrator
North Platte Physical Therapy Services, Inc. Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the North Platte Physical Therapy Services, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the North Platte Physical Therapy Services, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

(a) General

The Plan is a defined contribution plan sponsored by North Platte Physical Therapy Services, Inc. (the “Company”) for the benefit of its employees and employees of Monument Physical Therapy, LLC who have completed 1,000 hours of service during the plan year and are age 18 or older. Once eligibility requirements are met, employees enter the Plan on the next January 1st or July 1st. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was most recently restated effective October 1, 2023. John Hancock Life Insurance Company (U.S.A.) (“John Hancock”) serves as the custodian of the Plan and Benefit Solutions, Etc. serves as the third-party administrator of the Plan.

(b) Contributions

The Plan provides for Company profit sharing contributions only. Profit sharing amounts may be contributed at the option of the Company’s Board of Directors. Employees must have completed 1,000 hours of service during the plan year to be eligible to receive an allocation of that year’s profit sharing contribution. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Employees are not allowed to contribute to the Plan. Effective October 1, 2023, the Plan no longer allows rollovers from other qualified plans.

(c) Participant Investment Account Options

The Plan currently offers various pooled separate accounts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

(d) Participant Accounts

Each participant’s account is credited with (a) the Company profit sharing contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Regardless of the vesting schedule, participants automatically become 100% vested in the event of death, disability, or the attainment of normal retirement age, as defined.

(f) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, or substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the participant or their beneficiary. The Plan also provides for in-service withdrawals for those age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

(g) Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$137,971 and \$82,065, respectively. These accounts will be used to reduce future employer contributions. Subsequent to year-end, the balance of forfeited nonvested accounts at December 31, 2024 was used to reduce the 2024 employer profit sharing contribution.

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Contributions

The Company's profit sharing contributions are recorded in the year in which participant compensation is earned.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments.

(3) Information Prepared and Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Pooled separate accounts, at fair value
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

(3) Information Prepared and Certified by the Custodian - Continued

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The underlying investments of the Plan held in pooled separate accounts are valued at quoted market prices in an active market, which represent the net asset value ("NAV") of shares held by the Plan at year-end and are classified as Level 1 investments, except for the pooled separate account investing in the John Hancock Stable Value Fund. The fair value is calculated as the number of units in the subaccount held on a particular date and multiplied by the unit value on that date, generally representing the value that would be paid out for participant initiated or benefit withdrawals. The daily NAV published by the John Hancock Stable Value Fund is a stable \$1 per unit. As a result, the pooled separate account investing in the John Hancock Stable Value Fund is classified as Level 2.

(5) Party-in-Interest Transactions

Plan investments are pooled separate accounts managed by John Hancock. John Hancock is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers, totaling \$82,298 for the year ended December 31, 2024. These transactions are party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(7) Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

(9) Subsequent Events

Effective January 1, 2025, in conjunction with a change in third-party administrator, the Plan was amended and restated with the adoption of a new pre-approved plan document.

The Plan has evaluated subsequent events through July 17, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
