Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of United Contractors Midwest, Inc. 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of, and for the years ended, December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE A | DESCRIPTION OF PLAN

The following description of United Contractors Midwest, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan was adopted effective January 1, 2002, as a defined contribution profit sharing plan covering all non-excluded employees of United Contractors Midwest, Inc. (the Company). Employees excluded from participation include union employees, nonresident aliens and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Administrative Committee consisting of persons appointed by the Board of Directors of the Company. State Street Bank & Trust Company, as trustee for the Plan, accumulates and invests contributions as directed by the Administrative Committee.

2. Contributions

Deferral Contributions - Each year participants may contribute up to the maximum dollar amount as determined by the Federal government of pretax annual compensation or designated Roth contributions, as defined in the Plan. The maximum deferral was \$ 23,000 for 2024 and \$ 22,500 for 2023, with the option of an additional catch-up contributions, for those 50 years of age or over, of \$ 7,500 for 2024 and 2023, respectively.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 7% of eligible compensation and their contributions are invested in a designated balance fund until changed by the participant.

Discretionary Employer Contributions - The Company has a right to make a discretionary contribution to the Plan on behalf of each participant for the Plan year. The Plan allows the Company to annually determine a discretionary amounts for nonelective contributions and matching contribution, which are derived from formulas specified in the Plan. The Company made discretionary matching contributions of \$151,219 and \$147,494 during the year ended December 31, 2024 and 2023, respectively. No nonelective contributions were made during the years ended December 31, 2024 and 2023.

2. Contributions

Safe Harbor Contributions - Matching contributions are made in an amount equal to 100% of the amount of the eligible participant's elective deferrals that do not exceed 3% of the participant's compensation and 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but that do not exceed 5% of the participant's compensation.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's discretionary contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant earnings (losses), contributions, or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are immediately vested in their salary deferral and safe harbor matching contributions plus or minus any earnings or losses thereon. Vesting in the Company's discretionary contributions, if any, plus or minus any actual earnings or losses thereon, is based on years of continuous service as follows:

5. Investments

Upon enrollment in the Plan, participants have a choice of a variety of professionally managed investment funds to invest their account balances. Investment elections can be changed daily and become effective immediately.

6. Notes Receivable from Participants

Participants may borrow from their salary deferral and rollover contributions from a minimum of \$ 1,000 to a maximum equal to the lesser of 50% of the total value of the participants' vested account balances or \$ 50,000 less the amount of the participants' highest outstanding loan balances in the previous 12 months. Participants can have no more than two loans outstanding at any time. Participant loans are secured by the balance in the participants' accounts and bear interest at 1% over the current prime rate. Principal and interest payments are paid through payroll deductions.

7. Benefits

On termination of service, a participant may elect to receive a lump-sum amount, installment payments, or partial cash payments equal to the value of the participant's vested interest in his or her account. However, if the participant's vested account balance is \$ 7,000 or less, payment will be made in a lump sum. The Plan will make involuntary cash out distributions of account balances of terminated vested participants of \$ 1,000 or less. It will also make involuntary eligible rollover distributions of account balances greater than \$ 1,000 but not greater than \$ 7,000. In-service distributions are permitted if the participant has attained age 59 ½. Safe harbor hardship withdrawals are permitted under the Plan for the following contribution types: elective deferrals, Roth elective deferrals, rollover contributions, vested matching contributions and vested nonelective contributions plus earnings.

8. Forfeited Accounts

Amounts that are forfeited will be first used to restore participant accounts upon re-hire, then used to offset Plan expenses and then used to reduce future Employer contributions to the Plan. At December 31, 2024 and 2023, there was \$ 1,956 and \$ 390, respectively, remaining in forfeited accounts. In 2024 and 2023, fees paid by the Plan were reduced by \$ 1,000 and \$ 229, respectively, from forfeited nonvested accounts.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

5. Payment of Benefits

Benefits are recorded when paid.

6. Plan Expenses

Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Certain investment related expenses are included in the net appreciation (depreciation) of investments. Recordkeeping fees are charged directly to participant accounts.

7. Subsequent Events

Management has evaluated subsequent events for recognition and disclosure in the financial statements through July 22, 2025, which is the date the financial statements were available to be issued. Through July 22, 2025, no subsequent events required recognition or disclosure in the financial statement.

NOTE D | FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

NOTE D | FAIR VALUE MEASUREMENTS

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of mutual funds is equal to the net asset value of the funds multiplied by the number of shares held by the Plan, primarily using quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed investment accounts consist of mutual funds, equities, unit investment trusts, and money market funds, which are valued at quoted market prices as determined by the Plan's trustee.

The Plan invests in a collective trust (Trust), which provides for various investment options. Fair values of the Trust are reported to the Plan based on the NAV of the units of the Trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

NOTE E | INVESTMENTS IN ENTITIES THAT CALCULATE NET ASSET VALUE PER SHARE

Instead, the purchases and withdrawals occur with the entity, and in certain circumstances, those transactions are entirely controlled and/or restricted by the entity. NOTE G | TAX STATUS

The Plan is intended to be qualified under Section 401(a) and tax exempt under Section 501(a) of the Internal Revenue Code. The Plan is a non-standardized pre-approved profit sharing plan with CODA and obtained its last opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended and restated since receiving the determination letter. The Plan administrator and the tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Company's Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H | RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Transamerica and its affiliates. Transamerica Retirement Solutions is the Plan recordkeeper and, therefore, these transactions qualify as party-in-interest transactions.

Transamerica Retirement Services provides certain administrative services to the Plan pursuant to a Pension Services Agreement between the Company and Transamerica Retirement Services. Under this agreement, an expense budget account has been established and is credited with revenue shared from participant accounts. Quarterly, this revenue is used to offset fees owed to Transamerica Retirement Services for its administrative services to the Plan. The Recordkeeping fees are charged directly to participant accounts and not deposited into the expense budget account. A portion of the advance expense payment is deposited into the expense budget account for use on other expenses, which may include the balance of the investment advisory fees.

NOTE I | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
