We have performed audits of the accompanying financial statements of Kuiken Brothers Company, Inc. 401(k) Profit Sharing Plan and Trust subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of plan

The following description of Kuiken Brothers Company, Inc. (“Company”) 401(k) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the Company meeting various eligibility requirements. Employees participating in the 401(k) portion may participate immediately upon employment. In order to be eligible to receive employer matching contributions and participate in additional profit-sharing amounts, employees must be age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan, subject to statutory limitations under the Internal Revenue Code. The Plan also allows participants to elect to make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a common trust fund, a bond mutual fund, various retirement target date registered investment companies and various other registered investment companies as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation until changed by the participant. The Company may, at its discretion, provide a matching contribution. The matching contribution is equal to the lesser of 50% of employees’ deferrals or up to 50% of 7% of pretax annual compensation, as defined in the Plan.

The matching Company contribution is invested in accordance with each participant’s investment options as selected for their own contributions. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors and are also invested in accordance with each participant’s investment options as selected for their own contributions. Contributions are subject to certain limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s matching contributions, as well as allocations of the Company’s profit sharing contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. And, effective January 1, 2019, participants are also vested immediately in the Company’s contributions.

Note 1 – Description of plan (continued)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by 50% of the non-forfeitable amount of the borrowing participant's accrued benefit under the Plan and/or other security and bear interest at rates determined, at the time of approval of the loan by the Plan's Advisory Committee, to be a commercially reasonable rate of interest (ranging from 4.25% to 9.50% for loans outstanding during the year ended December 31, 2024). Principal and interest is paid ratably through bi-weekly payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as benefit payments based upon the terms of the Plan document. In addition, no allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits: On termination of employment for reasons other than death and upon death after commencement of distributions, participants with vested account balances not exceeding \$5,000 will receive a lump-sum distribution and participants with vested account balances exceeding \$5,000 may elect to receive either a lump-sum, installment payments or periodic payments over a period of time. If death occurs prior to commencement of distributions and, unless waived or a participant and spouse are not married for the one year period ending on date of death, the Plan will use 50% of a participant's vested account balance to purchase a pre-retirement survivor annuity payable to the spouse for life. The remaining balance, if not exceeding \$5,000, will be paid in a lump-sum to the designated beneficiary. For remaining balances in excess of \$5,000, optional forms of payment to a beneficiary are available. In-service withdrawals are available to participants if certain criteria in the Plan document are met. Withdrawals are also available in certain financial hardship situations.

Forfeited Accounts: The Plan allocates participant forfeitures as offsets to employer matching contributions and certain administrative expenses for the plan year in which the forfeitures occur. Forfeitures for the year ended December 31, 2024 amounted to \$1,443.

Note 2 – Summary of significant accounting policies

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments in registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 – Summary of significant accounting policies (continued)

The Plan's interest in the collective investment trust is valued at the net asset value (NAV) of the units in the T. Rowe Price Stable Value Common Trust Fund, which is used as a practical expedient to estimate fair value.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 3 – Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Registered Investment Companies – Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Note 3 – Fair value measurements (continued)

The collective investment trust is valued at the net asset value (NAV) of the units in the T. Rowe Price Stable Value Common Trust Fund (the "Fund"). The NAV, as certified by T. Rowe Price Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the Fund less its liabilities, net of an adjustment from fair value to contract value for Fund investments in fully benefit-responsive contracts.

The practical expedient is not used when it is determined to be probable that the Fund will sell the investment for an amount different than the reported NAV.

In addition, the T. Rowe Price Trust Company files the Fund as a Direct Filing Entity on Form 5500. As a result, disclosure of the Fund's significant investment strategy is not required.

The following tables summarize investments at December 31, 2024 and 2023 valued using NAV as a practical expedient to measure fair value:

Note 4 – Information prepared and certified by trustee

Investments and notes receivable from participants aggregating \$57,791,081 and \$50,537,166 as of December 31, 2024 and 2023, respectively, and investment income and interest income on notes receivable from participants of \$6,709,419 for the year ended December 31, 2024, included in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan administrator and certified to as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

Note 5 – Related party transactions and party in interest transactions

Certain Plan investments are shares of registered investment companies managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services of T. Rowe Price Trust Company included \$9,025 in fees for the year ended December 31, 2024.

Note 6 – Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company's contributions.

Note 7 – Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. In addition, the Plan receives a quarterly redistribution of a portion of T. Rowe Price recordkeeping fees alone, from which the Plan uses the funds to pay periodic expenses within the Plan year. That amounted to \$31,656 for the year. The Plan can also elect to periodically distribute any of the remaining funds received to the participants on an equitable basis.

Note 9 – Subsequent events

The Plan has evaluated subsequent events through July 8, 2025, the date the financial statements were available to be issued. No significant subsequent events were identified by management.
