NOTES TO THE FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN:

The following description of the National EWP, Inc., 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL:

The Plan is a defined contribution plan covering employees of the Company who have 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

ADMINISTRATION:

The Company has contracted with Voya Financial to act as administrator. Administrative expenses that are not paid for by the Company are paid for by the Plan.

EMPLOYER CONTRIBUTIONS:

The Plan has a provision for the Company to make discretionary matching contributions to those completing the eligibility requirements. The matching contribution will be 100 percent of the first 4 percent of the participants' elective deferral.

PARTICIPANT CONTRIBUTIONS:

A participant may make pre-tax and roth (after-tax) contributions up to 100 percent of his or her annual compensation; however, such contributions cannot exceed the annual maximum currently allowed under Section 401(k) of the Internal Revenue Code. Contributions are withheld from each participant's compensation and invested in accordance with the participant's instructions. Participants may also roll over amounts distributed from other qualified plans.

PARTICIPANT ACCOUNTS:

Each participant's account is credited with the participant's elective deferral contribution and allocation of (a) the Company's contribution, if any, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING:

A participant is always fully vested in his or her own salary deferrals and the Company's matching contributions.

PAYMENT OF BENEFITS:

Upon death, disability or termination of employment, the participant or designated beneficiary will be entitled to receive payment(s) equal to the value of the participant's vested interest in his or her account. If the participant's account balance does not exceed \$5,000 prior to July 1, 2024 or \$7,000 after July 1, 2024, then the account balance may only be distributed in a lump sum payment, whether or not the participant or designated beneficiary consents to receive it. If the participant's account balance exceeds \$5,000 prior to July 1, 2024 or \$7,000 after July 1, 2024, the participant may elect a lump-sum payment, installment over a period of not more than your assumed life expectancy, or partial withdrawals.

NOTES TO THE FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF PLAN: (Continued)

FORFEITED ACCOUNTS:

Amounts contributed by the Company which are forfeited by participants as a result of the participants' separation from service prior to becoming 100 percent vested and also adjustments made to the participant accounts may be used to reduce employer contributions and/or pay Plan expenses. Beginning January 1, 2023, this Plan is covered under Safe Harbor and all accounts are immediately 100 percent vested. The forfeitures are due to adjustments and corrections made to the Plan. Pending application of the forfeitures, the Company may direct the Custodian to hold the forfeitures in cash or under investment in a suspense account. At December 31, 2024 and 2023, forfeitures amounted to \$2,651 and \$4,802, respectively. Forfeitures applied to reduce employer contributions was \$6,210 and \$2,013 at December 31, 2024 and 2023, respectively. Forfeitures applied to reduce plan administrative expenses at December 31, 2024 and 2023 were \$0. Forfeitures pending application at December 31, 2024 and 2023 were \$30 and \$3,556.

NOTES RECEIVABLE FROM PARTICIPANTS:

Generally, participants may borrow against their vested account balance at local prevailing prime plus 1 percent interest rates as determined by the Plan Administrator. Borrowings must be a minimum of \$1,000. The outstanding balance of all loans may not exceed the lesser of:

- \$50,000 reduced by the excess of the highest outstanding balance of loans during the one year period preceding the loan over the outstanding balance of all loans on the date the loan is made; or,
- 50 percent of the present value of the nonforfeitable individual account of the participant.

Loan terms range from 1 to 5 years for personal loans, but if approved, may be repaid over a longer period, if used for the purchase of a primary residence. Principal and interest are repaid ratably through payroll deductions, ACH, or check over the life of the loan.

Loan defaults are charged to the participant as a deemed distribution, subject to federal and state income taxes as well as penalties for early withdrawal.

Loans and interest income on loans are recorded using the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING:

The accompanying financial statements are prepared on the accrual basis of accounting.

USE OF ESTIMATES:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION:

Investments in mutual funds and the Insurance Company General Account are stated at fair value based on the quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. The Stable Value Fund, which is fully benefit-responsive, and the Insurance Company General Account is also reported at fair value for the years ended December 31, 2024 and 2023.

NOTES TO THE FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

CONTRIBUTIONS:

Employee contributions are recorded in the year in which the Company makes payroll deductions from participants' earnings.

BENEFIT PAYMENTS:

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES:

All expenses of maintaining the Plan are paid by the Plan.

NOTE 3 - INVESTMENTS:

INFORMATION CERTIFIED BY THE CUSTODIAN:

Certified information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company.

NOTE 4 - FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 4 - FAIR VALUE MEASUREMENTS: (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fixed Account - Valued at the credited interest rate and account balance at December 31, 2024 and 2023.

Common Collective Trusts (CCT) - Valued at the net asset value (NAV) by the Plan at year-end. The NAV is based on the market value of its underlying investments. The CCTs invest in a variety of large U.S. stocks, Non-U.S. stocks and cash. All of the underlying investments have observable Level 1.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FIXED ACCOUNT:

The Plan has a fixed account with Voya Retirement Insurance and Annuity Company (VRIAC). The Plan maintains the contributions in a general account, which is credited with declared rates of interest on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed account is included in the financial statements at fair value, however, recorded at contract value. For the year ended December 31, 2024 and 2023, there is no difference between fair value and contract value.

NOTE 6 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - TAX STATUS:

The Plan has not received a determination letter from the Internal Revenue Service, but the prototype plan on which the Plan is based received a favorable determination letter dated March 31, 2008. The Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan Administrator believes the Plan is no longer subject to income tax examination for years prior to 2020.

NOTES TO THE FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

NOTE 8 - RISKS AND UNCERTAINTIES:

The Plan offers a variety of investment options in any combination of mutual funds that are offered by the Plan. Investment securities are exposed to various risks, such as interest rate, overall volatility and credit risks. Due to the level of investment risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
