NOTE 1 - DESCRIPTION OF PLAN

The following description of the Loureiro Engineering Associates, Inc. 401(k) Plan (the “Plan”), sponsored by Loureiro Engineering Associates, Inc. (the “Company”), provides general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all full-time employees of Loureiro Engineering Associates, Inc., Loureiro Contractors, Inc. (a wholly-owned subsidiary), Tunxis Laboratories, LLC (a wholly-owned subsidiary) and Loureiro Building Construction, LLC (a wholly-owned subsidiary) who are not subject to the terms of a collective bargaining agreement and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Sponsor, Administrator, and Custodian - The Plan is sponsored by Loureiro Engineering Associates, Inc. Empower Annuity Insurance Company of America is the appointed custodian for the Plan (the “Custodian”) and acts at the direction of the Plan Administrator. Participants have the option to invest in certain Custodian maintained funds in accordance with the provisions of the Plan document and may elect to change their investment options daily.

Eligibility - Employees are eligible to enroll on the first day of the month coinciding with or next following 30 calendar days from the date on which the employee completes an hour of service.

Contributions - Participants may elect to defer up to 100% of pretax annual compensation, not to exceed the limits established by Internal Revenue Code (“the Code”) Section 402(g) (“voluntary contributions”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants, subject to the approval of the Plan Administrator, can also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollover contributions”). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation (effective January 1, 2025 the default auto enrollment percentage became 6%) and their contributions invested in a designated balanced fund until changed by the participant. For each plan year, Loureiro Engineering Associates, Inc. may make discretionary contributions on behalf of each participant, a percentage of the participant employee’s pretax contributions for the plan year equivalent to 100 percent of the first 3 percent of contributions and 50 percent of the next 3 percent of contributions not to exceed the amount contributed by the participant. The contribution is allocated among funds based on the participant’s most recent allocation percentages. In addition, the participant was originally required to satisfy certain criteria with respect to length of service in order to vest with regard to these matching contributions. Effective in April 2016, employer contributions are 100% vested at all times, provided that the participant is active.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions made to the Plan plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts and related earnings thereon was historically based on years of service. Effective in April 2016, active participants are immediately and fully vested in employer contributions.

Forfeitures - Participants who terminate employment but have not become fully vested forfeit the unvested balances in their accounts. In accordance with the Plan, the amount of the forfeitures is utilized to reduce future employer contributions. The balance in the forfeiture account at December 31, 2024 and 2023 is \$1 and \$25,100, respectively.

Payment of Benefits - Upon death, retirement, total and permanent disability or termination of employment, the participant shall be entitled to the vested amount of his/her account in accordance with the provision and payment method elections specified in the Plan. Additionally, active participants who have attained age 65 may request in-service distributions. If the participant leaves and returns to the Plan within a defined period of time, the non-vested portion is reinstated upon meeting certain criteria.

Notes Receivable from Participants - Participants have the ability to borrow up to 50% of their vested account balance up to a maximum of \$50,000 upon application and approval by the Plan Administrator, as defined in the Plan. The minimum loan amount is \$1,000. The loans are collateralized by the balance in the participant's account. The interest rate charged to participants is one percent above the prime interest rate established by commercial lending institutions. Principal and interest are paid ratably through payroll deductions. Loans may not exceed a repayment term of five years unless the loan is for the purchase of a primary residence as defined in the Plan document.

Hardship Withdrawals - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

Administrative Expenses - Investment management fees, loan origination fees, and distribution fees of the Plan are funded directly by the Plan. All other administrative expenses (audit and legal fees) are paid by the Company on the Plan's behalf.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The Plan financial statements have been prepared on the accrual basis of accounting.

Fair Value Measurements - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements.

Use of Estimates - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recognized when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon the participant having a distribution event.

Risks and Uncertainties - The Plan provides the participants with various investment options in any one or a combination of mutual funds which invest in stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Disclosure of Subsequent Events - Plan Management has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued. See Contributions policy for subsequent event disclosure.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2005, the Plan entered into a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company, now known as Empower Annuity Insurance Company of America (“Empower”). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Since the guaranteed investment contract is fully benefit responsive, contract value is the relevant measure because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to plan documents (including complete or partial plan termination or merger with another plan), changes to plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary), that cause a significant withdrawal from the plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974, or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without the consent of the issuer.

NOTE 5 - FAIR VALUE MEASUREMENTS

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

During 2024, there were transactions involving the investment of Plan assets in Empower sponsored offerings, which are managed by Empower Annuity Insurance Company of America, the Custodian, a party-in-interest as defined under Section 3(14) of ERISA.

Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed, Empower remits the excess to the Plan's trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, revenue of \$39,559 was received by the Plan and \$44,359 was paid by the Plan out of the expense account.

NOTE 7 - TAX STATUS

During 2016, the Plan adopted a Pension Consultants volume submitter plan, which was restated effective July 2021. The restated plan received a favorable opinion letter dated May 26, 2021. The Plan itself has not requested a determination letter under this new arrangement.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.
