This is the final Form 5500 because the trust was closed on July 25, 2025.

The Plan was terminated effective April 1, 2023. The Internal Revenue Service issued a favorable determination letter on December 29, 2023 (DLN 26007-434-00183-3). The Pension Benefit Guaranty Corporation was given notice of the plan termination on May 2, 2023. All plan assets were distributed to participants and beneficiaries via lump sum payments, annuity policies or PBGC missing participant program by the end of 2023.

Because the Plan was terminated in 2023 it is not subject to minimum funding requirements in 2025.

In 2024 the remaining trust assets were used to reimburse the plan administrator for administration fees incurred in 2023, leaving only a nominal amount in the trust account held at US Bank. The trust account remained open because on July 24, 2024 the PBGC selected the Plan for plan termination audit (PBGC Audit Number: A40424043).

On July 8, 2025 the PBGC advised the plan sponsor its examination did not disclose any violations of Title IV of the Employee Retirement Income Security Act (ERISA) or other applicable regulations, and that it has closed its files on the audit.
