Notes to Financial Statements

Note 1: Plan Description

The following description of BOA Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of BOA Technology, Inc. (the Company or Employer) who have completed three months of service and are age 21 or older. Employees who have met eligibility requirements are enrolled on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is sponsored and administered by the Company, acting by and through the Retirement Committee. Certain officers of the Company serve as trustees of the Plan. The Plan's assets are held by American United Life Insurance Company (AUL), a OneAmerica company. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may elect to have compensation deferred up to the maximum amount allowed by law, as defined in the Plan, on a pretax basis. The Plan also allows Roth contributions. Deferral contributions shall not exceed certain limits set forth by the Internal Revenue Service (IRS) (\$23,000 in 2024 and \$22,500 in 2023). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (up to \$7,500 in 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company makes Safe Harbor matching contributions equal to the sum of 100% of the amount of the participant's deferrals that do not exceed 3% of participant compensation, plus 50% of the amount of the participant's deferrals that exceed 3% of compensation, but not to exceed 5% of compensation for the plan year. The Company may also make discretionary matching and discretionary profit sharing contributions. The Company did not make any discretionary matching or profit sharing contributions for the year ended December 31, 2024. Rollover contributions are not matched.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with 5% pretax deferral of compensation unless they affirmatively elect not to participate in the Plan or they make an election for a different deferral type or amount.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company Safe Harbor and discretionary matching contributions, allocations of the Company's profit sharing contributions, plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Plan Description (Continued)

Vesting

Participants are immediately vested in their deferral and rollover contributions and the Company's Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. Vesting is based on a four-year graded schedule, where the vesting percentage is 25% after one year of credited service and increases an additional 25% each year thereafter, with 100% vesting after four years of credited service. Participants may also become fully vested in the Company's discretionary contributions upon the participant's death, disability, or reaching normal retirement age (65).

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in pooled separate accounts, and a stable value fund as investment options for participants. Participants may change their investment options at any time.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loan terms range from one to 30 years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as provided for in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Under certain circumstances, participants experiencing financial hardship or who have attained the age of 59 1/2 may withdraw a portion of their vested account balance prior to death, disability, retirement, or termination of employment, as defined in the Plan

Forfeited Accounts

At December 31, 2024 and 2023, there were no unallocated forfeitures held by the Plan. Forfeitures are used to pay administrative expenses or used to reduce employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans may be reclassified as benefits paid to participants based upon the terms of the plan documents.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025, which is the date the financial statements were available to be issued. Plan management has not identified any material subsequent events that require reporting or disclosure.

Note 3: Information Prepared and Certified by the Custodian (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, the custodian of the Plan, has certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Pooled separate accounts, stable value fund, and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Interest income on notes receivable from participants, and net appreciation in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- The schedule of assets held at end of year included as supplemental information.

This information has not been audited by the Plan's independent auditors.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds Held in Pooled Separate Accounts: Fair value is based on quoted net asset values of the underlying investments held by the pooled separate accounts. The underlying mutual funds held in the pooled separate accounts are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must publish their daily Net Asset Value (NAV) and transact at that price.

Note 4: Fair Value Measurements (Continued)

Stable Value Fund: Valued at the NAV of the fund as reported to the plan administrator by the trustees of the fund. The NAV is used as a practical expedient to estimate fair value. If the Plan were to experience certain events such as plan termination, the fund may impose a market value adjustment on withdrawals.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 5: Party-in-Interest Transactions

Certain plan investments are managed by AUL, who is the custodian, recordkeeper, and third-party administrator. Wipfli LLP performs the ERISA Section 103(a)(3)(C) audit for the Plan. Transactions with these parties qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. For the year ended December 31, 2024, the Plan made direct payments of \$6,044 to the custodian, which were not covered by revenue sharing.

Notes receivable from participants also qualify as party-interest transactions, which are exempt from the prohibited transaction rules at ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Plan's volume submitter plan sponsor obtained a favorable opinion letter from the IRS dated August 19, 2020, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in-progress.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
