### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Adient Aerospace LLC Savings and Investment 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Adient Aerospace LLC Savings and Investment 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

---

### Note 1 – Description of the Plan

The following description of the Adient Aerospace LLC Savings and Investment 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution 401(k) profit sharing plan covering all eligible employees of Adient Aerospace LLC (the Company), excluding employees who fall within an excluded class as outlined in the Plan provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Administration** – Fidelity Management Trust Company (Fidelity) is the custodian for the Plan.

**Contributions** – Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. Participants may elect to contribute, subject to statutory limitations, up to 100% of their eligible compensation. Participants age 50 or older are allowed to make catch-up contributions. Participants may elect to change contribution percentages to be effective the beginning of the next pay period after the request is received or as soon as administratively possible. The allocation of both their contributions and employer contributions to the funds may be changed at any time and become effective on the day of the change or the next business day based on the day and time the request for a change is made in relation to the stock market close of business. The Plan allows active employees to contribute to the Plan from pre-tax compensation, after-tax compensation for Roth contributions, or a combination of both pre-tax and after-tax compensation. The Plan also accepts certain rollover contributions. Participants are auto-enrolled in the Plan at 6%.

Under the terms of the Plan, the Company makes nonelective safe harbor contributions to the Plan as follows: a 100% match of the first 3% of eligible compensation deferred by each participant and a 50% match of each participant's deferrals of the next 3% of eligible compensation.

**Participant accounts** – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings (losses) from the funds in which the account is invested, and charged with an allocation of certain administrative and investment-related expenses and participant-specific charges, if applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are fully vested in their rollover, elective and safe harbor contributions allocated to their account, including accumulated earnings.

**Forfeitures** – Forfeitures are the nonvested portions of a participant's account that are lost upon termination of employment. Forfeitures occur when a participant receives a distribution of his or her entire vested account or, if the participant does not receive a distribution, after five consecutive one year breaks in service. Forfeitures are retained in the Plan and may be used to reduce future Company contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,430 and \$1,466, respectively. During the year ended December 31, 2024, forfeitures of \$1,089 were restored to participant accounts.

**Withdrawals** – Participants may elect to withdraw all or a portion of their pre-tax contribution accounts, Roth contribution accounts, safe harbor contribution accounts, and the vested portion of their discretionary contribution accounts at any time on or after the day they attain age 59-1/2. Withdrawals of rollover contributions may be made at any time.

**Notes receivable from participants** – Participants are permitted to borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested pretax account balance at the time of the loan issuance and may have no more than two loan outstanding at any time. Loans may be further limited in accordance with Plan provisions. The interest rate on new loans is the prime rate plus 1% as of the date of the loan. Interest rates on outstanding loans ranged from 3.25% to 9.50% at December 31, 2024, with loans maturing at various dates through January 2030.

Loan repayments are made through regular payroll deductions for a period of up to 60 months for general loans and over a longer period for loans used to finance the purchase of a principal residence. If a participant's employment terminates for any reason, and the loan balances are not paid in full by the termination date, the participant may continue to make monthly loan repayments until the loan is scheduled to be paid off. A loan will continue to be subject to default if a payment has not been made by the last day of the calendar quarter following the calendar quarter in which the scheduled payment was due, or the participant takes a full distribution of their account before the loan is paid off. If the loan defaults, the loan balance will become taxable income to the participant.

**Benefit payments** – On termination of service, if the vested value of a participant's account exceeds \$7,000, the participant may elect to receive a lump sum amount or a partial withdrawal, to purchase an annuity contract, to roll the account balance to another company's qualified plan or an individual retirement account, or defer distribution until a later date. If the vested value of a participant's account is \$7,000 or less, the entire vested balance in their account will be automatically distributed in a single lump sum payment.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties** – The Plan's investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

**Valuation of investments and income recognition** – The Plan’s investments are stated at fair value. The Plan’s custodian, Fidelity, certifies the fair value of all investments. If available quoted market prices are used to value investments. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. Investments in the Plan are valued as follows:

*Mutual funds and money market fund* – The Plan’s investments in mutual funds and the money market fund are valued at the net asset value (NAV) of shares held by the Plan at year end as quoted in an active market.

Purchases and sales of securities are recorded on a trade date basis, and dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Necessary and proper expenses of the Plan are paid from the Plan’s assets, except for those expenses the Company is required by law or chooses to pay.

**Subsequent events** – The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

Effective April 30, 2025, the plan sponsor, Adient Aerospace LLC, changed its name to Elevate Aircraft Seating LLC.

### **Note 3 –Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements (ASC 820)* established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** – Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

**Level 2** – Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in nonactive markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

**Level 3** – Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments by general types of assets measured at fair value on a recurring basis at December 31, 2024 and 2023. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

### Note 4 – Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the custodian of the Plan, has certified to the completeness and accuracy of the following:

- Investments at fair value and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

#### **Note 5 – Tax Status**

The Plan is based on a non-standardized pre-approved defined contribution profit sharing plan that received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was compliant with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter, however, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan's tax-exempt status has not been affected, and no provision for income taxes has been included in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

#### **Note 7 – Party-in-Interest Transactions**

The Plan invested in shares of mutual and collective investment funds managed by affiliates of Fidelity. Therefore, those transactions qualify as exempt party-in-interest transactions.

**Note 8 – Reconciliation to Form 5500** – The Form 5500 has certain items that differ from amounts shown in the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
