INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the 403(b) Thrift Plan of Donna Klein Jewish Academy, Inc., (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan for Donna Klein Jewish Academy, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is organized as a defined contribution plan under Section 403(b) of the Internal Revenue Code and covers substantially all full time employees of Donna Klein Jewish Academy, Inc. (the "School"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is administered by the plan's certifying entity, appointed by the Board of Directors of the School. The Plan was established effective January 1, 2003.

Eligibility

Generally, all full time employees of the School are eligible to participate in the Plan.

Contributions

Participants may generally contribute any % of pre-tax earnings, as defined in the Plan, up to an annual maximum of \$23,000 and \$22,500 for the 2024 and 2023 Plan year, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained the age of 50 and participants with at least 15 years of service with the School are permitted to contribute additional salary reduction amounts to the Plan subject to IRS limitations.

The School made a discretionary matching contribution equal to 1% of each participant's elective deferrals. Contributions were made uniformly to eligible participants who elected to defer compensation. Participants must be at least 21 years of age and have completed at least one year of service to receive employer base contributions. Participants direct the investment of their contributions into a variety of investment options (see Notes 5 and 7). Participants may change their investment options at their discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the employer's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their non-Roth vested account balance. Loan terms may not exceed five years, unless used to acquire the principal residence of the participant. The loans are secured by the balance in the participant's interest accumulation account (see Note 7) plus a loan reserve of 20% of the loan amount. Loans must bear a reasonable rate of interest, not to exceed the legal limit. The interest rate is determined by the Plan's certifying entity and is reevaluated every quarter. As of December 31, 2024 and 2023, interest rates on outstanding participant loans were 5.85% and 4.6%, respectfully. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the School's base contribution portion of their accounts plus actual earnings thereon is determined under the following schedule:

2	40%
3	60%
4	80%
5 or more	100%

A participant will also be 100% vested under any of the following circumstances:

- Death before retirement date.
- Disability before retirement date.
- Attainment of normal retirement age.
- Termination of the Plan.

In addition, a participant is immediately 100% vested in any amount which has been transferred or rolled over into the Plan from another qualified employee benefit plan.

Payment of Benefits

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account either in a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump sum.

Forfeitures

The non-vested portion of a participant's account is forfeited upon termination of employment with the School. Forfeitures remain in the Plan to reduce employer contributions. The Plan did not have significant forfeitures at December 31, 2024 and 2023 respectively.

Plan Termination

Although it has not expressed any intention to do so, the School has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America. In September 2009, the Financial Accounting Standards Board (“FASB”) implemented the Accounting Standards Codification (“ASC”) which establishes FASB ASC as the source of authoritative U.S. accounting and reporting standards for nongovernmental entities. Presented below is a summary of significant accounting principles followed in the preparation of the accompanying financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants / Participant loans

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The School pays substantially all expenses of the administration of the Plan. Any administrative expenses or costs associated with the investment of a participant's account and any costs or expenses associated with making a distribution to a participant are charged to that participant's account.

Income Taxes

The Plan is qualified under Section 403(b) of the Internal Revenue Code (the "Code") and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes the Plan is operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan continues to be qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been recorded in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Risk and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and statement of changes in net assets available for plan benefits.

Subsequent Events

The Plan has evaluated subsequent events through July 16, 2025 the date the financial statements were available to be issued.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

Effective August 1, 2024, the Plan changed its certifying entity for investment reporting purposes. Prior to this date, investment information was certified by Mutual of America Life Insurance Company. Beginning August 1, 2024, the Plan engaged Fidelity Personal Trust Company as the new certifying entity. As a result, investment information for the period from January 1, 2024 through July 31, 2024 was certified by Mutual of America Life Insurance Company, and information from August 1, 2024 through December 31, 2024 was certified by Fidelity Personal Trust Company. Accordingly, transactions relating to these two certifying entities are deemed party-in-interest transactions.

NOTE 4 – INFORMATION CERTIFIED BY THE PLAN'S CERTIFYING ENTITY

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, the certifying entity of the Plan for the period through July 31, 2024, has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2023 and the related net appreciation in value of investments and interest reflected in the accompanying Statements of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through July 31, 2024. Beginning August 1, 2024, Fidelity Personal Trust Company assumed the role of certifying entity and has certified the investment information for the period from August 1, 2024 through December 31, 2024.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management's own assumptions in determining the fair value of investments).

Registered Investment Companies / Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

General Account: Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Pooled Separate Account: Valued daily, each pooled separate account invests its assets solely in shares or units of an underlying mutual fund, and the investment objective of each sub-account corresponds to the investment objective of the underlying fund. The value of each pooled separate account is determined using inputs, such as the NAV of the shares of the underlying mutual fund held at year-end, adjusted for administrative expenses and other charges.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been provided and certified to as complete and accurate by the Plan's certifying entity.
