Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kerridge Commercial Systems Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kerridge Commercial Systems Retirement Savings Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kerridge Commercial Systems Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of Plan

The following description of Kerridge Commercial Systems Retirement Savings Plan (the “Plan”) provides only general information for the Plan sponsored by Kerridge Commercial Systems LLC (the “Company”). Participants in the Plan should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan became effective on January 1, 1996 as a trustee profit sharing 401(k) salary deferred plan. The Plan covers all resident, full-time employees of the Company who are at least 21 years old. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their pre-tax or after-tax annual compensation, subject to the contribution limits imposed by the Internal Revenue Code (“IRC”). The Company makes discretionary matching contributions. During 2024, the Company made a discretionary contribution of 4% of eligible compensation. The Company may decide to make an additional contribution at the discretion of the Company’s Board of Trustees, but is not required to do so. There were no additional contributions made by the Company during 2024. The Plan also permits rollover contributions from other qualifying retirement plans.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, and allocations of plan earnings. Allocations are based on participants’ compensation or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in the salary reduction amount contributed to the Plan. Vesting in the Company’s discretionary contributions is based on the years of continuous service. Participants are fully vested after completing six years of credited service.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$22,638. Forfeited accounts are used to restore forfeitures, reduce the employer contributions or to pay Plan expenses as permitted by the Plan’s provisions. During the year ended December 31, 2024, the Plan used \$14,007 of forfeited accounts to reduce employer contributions.

Payment of Benefits

Generally, the participant becomes eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. Effective January 1, 2024, participants can take withdrawals for domestic abuse. Early retirement is also available for those participants age 55 or with seven years of Plan participation, whichever is later. For retirement, death or disability, the participant may receive 100% of their account balance in a lump sum amount. Participants who terminate their employment will receive their vested account balance under the same options as above. If the vested balance is less than \$5,000, a lump sum distribution is made. Effective January 1, 2024, this amount increased to \$7,000.

Hardship Withdrawals

Upon approval by the plan administrator, a participant may withdraw all or part of their elective contributions for immediate and severe financial need. In accordance with Internal Revenue Service ("IRS") regulations, the participant must exhaust all other assets available prior to obtaining the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of all other loans from the Plan during the one-year period ending the day the loan was made over the outstanding balance of loans from the Plan on the date on which the loan was made or 50% of their vested account balances. Participants may only have one loan outstanding at a time. The notes are secured by the balance in the participants' accounts and bear interest at a fixed rate of prime plus 2% (9.50% at December 31, 2024) as determined on the date of the newly issued loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 and 2023 were \$12,679 and \$17,142, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United State of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all invested cash balances to be cash equivalents.

2. Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers. See Notes 6 and 7 for a discussion of the valuation of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized appreciation and depreciation in the value of investments are allocated to the participant accounts based on participant holdings in each fund.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain plan expenses are paid by the plan sponsor as provided by the plan document. Expenses related to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

3. Federal Income Taxes

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan document. This document received an opinion letter dated June 30, 2020, in which the IRS stated that the plan document was in compliance with the applicable requirements of the IRC. As allowed by the IRS, the Plan is relying on the opinion letter issued on the plan document for its own qualification. The plan document has been amended for changes required by the IRS since receiving the opinion letter. Plan management believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

5. Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”)’s Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”), the custodian of the Plan, and was not subject to audit for the years ended December 31:

6. Fair Value Measurements (Continued)

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 Inputs are based on significant other observable inputs such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when market prices are not attainable but other observable inputs are available to arrive at a fair value, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. The Plan has no Level 1, 2, or 3 investments.

Pooled Separate Accounts

Pooled separate accounts are valued using the Net Asset Value (“NAV”) provided by the administrator of the fund, based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The pooled separate accounts do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

Collective Investment Trust Fund

The collective investment trust fund is valued using the NAV of units of the collective investment trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

7. Collective Investment Trust Fund

The John Hancock Stable Value Fund (the "Fund") is a collective investment trust fund that invests in separate accounts to simulate the performance of a guaranteed investment contract through the guarantee of a specific interest rate. Fund transactions are executed at contract value and are benefit-responsive for all participant-directed transactions. The contract value represents contributions, plus interest, less participant-initiated withdrawals or transfers.

The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV per share class determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. The Fund records security transactions on a trade-date basis. Interest income is accrued at the Fund's crediting rate, which is generally based on the fair value, duration, and yield-to-maturity of the Fund. Realized and unrealized gains and losses on the underlying assets are typically amortized, usually over the duration of the underlying investments, through adjustments to the crediting future interest crediting rate, rather than reflected in the net assets of the Fund.

Participant-directed withdrawals, those made by a participant in a participating plan without advice, suggestion, guidance, or direction to do so by the plan sponsor, administrator, fiduciary record keeper or other plan service provider, are paid at the guaranteed value. However, if a withdrawal is made from the Fund as a result of an employer or plan sponsor-initiated event or if a withdrawal is requested due to a complete or partial termination or a participant plan in the Fund before the end of the contract, and the Fund's fair value equals or exceeds the guaranteed value, payment is made in the amount of the participating plan's guaranteed value. If the Fund's fair value is less than the guaranteed value, the amount paid is equal to the guaranteed value reduced by the amount of fair value deficit allocable to the participating plan.

In certain circumstances, all participant withdrawals may be deemed to be Participating Plan-Directed Withdrawals. A withdrawal will be deemed to be a Participating Plan-Directed Withdrawal if 1) the participant withdrawal is based on advice or direction; 2) the participating plan establishes an investment option that creates a competing fund; 3) a participating plan establishes a new plan or amends an existing plan and such plan covers participants in the participating plan and offers participants a competing fund; or 4) the participating plan makes a withdrawal for any reason, except for a participant-directed withdrawal.

8. Party-in-Interest Transactions

Plan investments are managed by John Hancock, the custodian as defined by the Plan. Fees paid by the Plan to the custodian and other parties-in-interest for contract administration, advisory and professional services amounted to \$87,233 for the year ended December 31, 2024. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with a party-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.

9. Risks and Uncertainties

The Plan invests in various investment securities as directed by its participants. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure in the financial statements through July 22, 2025, which is the date the financial statements were available to be issued.

In December 2022, Congress passed the Setting Every Community Up for Retirement Enhancement Act of 2022 ("SECURE Act 2.0") that continued the retirement system reform previously passed in 2020. Certain provisions of the SECURE Act 2.0 are effective at various dates through 2026, with the plan amendment for the adoption of SECURE Act 2.0 due by December 31, 2026.
