Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Champlain Valley Equipment 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Champlain Valley Equipment 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

(1) Description of Plan

The following description of Champlain Valley Equipment 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

- (a) General – The Plan was established on January 1, 1977 as a defined contribution plan covering all employees of Champlain Valley Equipment (the "Company") who have attained the age of 19 and completed one year of service, defined as 1,000 hours. In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan's provisions and applicable law.

Non-resident aliens, leased employees, and employees covered under a collective bargaining unit are not eligible to participate. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of the quarter coinciding with or next following their eligibility date.

Effective November 1, 2024, the Company acquired Empire Tractor, Inc. Former employees of Empire Tractor, Inc. were granted prior service crediting for eligibility and vesting purposes.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees oversee governance of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Trustees.

- (b) Employee Contributions – Participants may make pre-tax or after-tax Roth contributions to the Plan which may not exceed the maximum amount allowed under the Internal Revenue Service (IRS). New participants are automatically enrolled in the Plan at 3% after they meet the eligibility requirements, unless they opt out or choose a different deferral amount. Participants who have attained the age of 50 before the end of the year may contribute additional catch-up amounts as set by the IRS. Active participants may also contribute amounts representing rollovers from other qualified plans.
- (c) Employer Discretionary Matching Contributions – The Company may make a discretionary matching contribution based on a uniform percentage of eligible compensation determined by the Company. In order to receive the discretionary matching contribution, a participant must complete 1,000 hours of service during the plan year and be employed by the Company on the last day of the Plan year. The Company did not make any discretionary matching contributions for the year ending December 31, 2024.
- (d) Employer Discretionary Non-Elective Contribution – The Company may also make a discretionary nonelective contribution for each employee as defined by the Plan, calculated as a percentage of eligible compensation. In order to receive the discretionary non-elective contribution, a participant must complete 1,000 hours during the plan year and be employed by the Company on the last day of the Plan year. The Company's nonelective contribution was as follows for the year ending December 31, 2024: 5% for owners, 4% for non-owner managers, 2% for parts personnel, service personnel, and sales personnel, 3% for office personnel, and 2% for all other employees.

- (e) Participant Accounts – Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary matching and discretionary non-elective contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of the contributions into various investment options offered by the Plan.
- (f) Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contribution portion of the participant's account plus actual earnings thereon is based on years of continuous service. A year of vesting service is defined as 1,000 hours. A participant is 20% vested after two years of credited service, with an additional 20% per year thereafter until fully vested.
- (g) Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive distributions equal to the value of the participant's account balance. The participant may either choose a lump sum distribution or partial payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If a participant's vested balance is less than \$7,000, it is mandatory that the benefits be distributed from the Plan.

Participants may take in-service distributions once they reach age 59-½ or in the event of a hardship. Hardship distributions may only be taken from the participant's elective deferral account. Participants may also withdraw amounts attributable to rollover contributions at any time. A participant may not take an in-service distribution of less than \$1,000.

- (h) Forfeitures – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements and certain other adjustments. Forfeitures are used to reduce the Company's contributions or expenses. Forfeitures of \$3,847 were used to reduce the employer contribution receivable for the year ending December 31, 2024. Forfeitures available at December 31, 2024 and 2023 were \$3,823 and \$5,947, respectively.
- (i) Participant Loans – Participant loans are not permitted by the Plan.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

- (b) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (c) Risks and Uncertainties – The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
- (d) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is accounted for on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (e) Payment of Benefits – Benefit payments are recorded when paid.
 - (f) Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Additionally, certain investment management fees are paid by the Plan.
 - (g) Subsequent Events – The Plan evaluated subsequent events through July 28, 2025, the date the Plan's financial statements were available to be issued.
- (3) Information Certified by the Plan's Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all amounts and types of investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

(4) Fair Value Measurements

Generally accepted accounting principles in the United States of America establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). All mutual funds are classified as Level 1. These totaled \$6,256,211 and \$4,795,627 as of December 31, 2024 and 2023, respectively.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income Tax Status

The Plan is based on a prototype plan that has received a favorable determination letter from the Internal Revenue Service dated June 30, 2020 as a prototype non-standardized plan, which is acceptable under Section 401 of the Internal Revenue Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(7) Withdrawing Participants

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

(8) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.
