## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Phillips' Companies 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution, Matrix Trust Company, as of and for the years ended December 31, 2024, and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. Description of Plan**

The following description of the Phillips' Companies 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a multiple employer defined contribution plan covering eligible employees of Unique Homes & Lumber, Inc., Dirty's Bar & Grill, LLC, Unique Suites Hotel, LLC (through May 2024), and The Villas of Holly Brook Senior Living, LLC (collectively known as Phillips' Companies (the Company)) upon turning 18 years of age. The Plan excludes non-resident aliens and union employees.

The Plan has been amended throughout the years to comply with tax legislation and most recently restated effective January 27, 2023, with change in service providers. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions* – Each year, participants may elect to defer a portion of their compensation, as defined by the Plan. Current employees may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offered various mutual funds and a common collective trust as investment options for participants. The maximum contribution to the Plan in any year is determined by provisions in the Plan and the Internal Revenue Code (IRC) and Income Tax Regulations.

Effective January 1, 2022, the Plan elected to follow safe harbor rules and began making a safe harbor matching contribution equal to 100 percent of participant salary deferrals for the first 3 percent of compensation plus 50 percent of participant salary deferrals between 3 and 5 percent of compensation. For 2024, the safe harbor match is matched each pay period with a true-up determined at the end of the plan year.

*Participant Accounts* – Each participant's account is credited with the participant's contribution, if any, and allocations of (a) the Company's contribution, (b) forfeitures, (c) administrative expenses, and (d) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in any employer safe harbor contribution. Vesting of employer non-safe harbor contributions is based on years of service and a participant is 100 percent vested in these contributions after six years of credited service.

*Payment of Benefits* – On termination of service, distributions under the Plan may be made in lump-sums, substantially equal installments, or partial withdrawals. The Plan provides for an automatic lump sum distribution of account balances of \$5,000 or less. The Plan also allows for financial hardship withdrawals of all or part of the participant’s deferral contributions, if the participant can prove financial hardship and is unable to meet their financial needs another way. The Plan allows for in-service distributions from all fully vested account balances if the participant has attained age 59 ½.

*Forfeited Accounts* – Forfeited amounts are allocated to participant accounts to reduce the employer contribution or used to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$557 and \$19,666 respectively. During the year ended December 31, 2024, \$56,740 of forfeited amounts were used for employer safe-harbor contribution.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 (reduced by the excess, if any, of the participant’s highest outstanding note balance during the one-year period ending on the day before the date on which such note is made over the participant’s outstanding balance of notes on the date such note was made) or 50 percent of the participant’s vested balance. The minimum amount of a loan shall be \$500. Note terms range from 1 to 5 years and up to 30 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

## **2. Summary of Significant Accounting Policies**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Investment and Administrative Expenses* – The Plan’s expenses are paid either by the Plan or the employer, as provided by the Plan document. Expenses paid directly by the employer are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

*Payment of Benefits* – Benefits are recorded when paid for financial statement purposes.

*Subsequent Events* – The Plan has evaluated subsequent events through July 9, 2025, the date on which the financial statements were available to be issued.

### 3. Information Certified by Matrix Trust Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash and investments held as of December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Matrix Trust Company, investment custodian of the Plan.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Mutual Funds*: Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.
- *Common Collective Trust (CCT)*: The Reliance Trust Stable Value Fund held by the Plan invests in investment contracts and seeks to produce a stable return while avoiding negative returns. The net asset value is based on the fair value of the underlying investments held by the trust less its liabilities. Withdrawals resulting from an employer or plan sponsor-initiated event (e.g. a decision to terminate the Plan's participation in the trust) could result in a payment less than the guaranteed value if the contract's market value is less than the guaranteed value. An event limiting the ability of plan participants is not considered probable of occurring.

Management has determined the CCT qualifies for the net asset value practical expedient under FASB ASC 820, and, as such, the CCT is not categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no unfunded commitments, or significant redemptions or restrictions on the investment measured at net asset value per share using the practical expedient as of December 31, 2024.

## 5. Administrative Expenses and Party-in-Interest Transactions

A transaction with a plan service provider or a participant of the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid to Vestwell, ADP, and Matrix Trust Company. Of these fees, \$79,210 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Notes receivable from participants are considered to be both party-in-interest and a related-party transaction.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in all contributions.

**7. Tax Status**

On March 14, 2022, the Internal Revenue Service stated that the preapproved plan adopted by the Company is designed in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving this opinion letter, the plan administrator and the preapproved plan provider believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt. As such, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
