SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of Computercraft 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE A - DESCRIPTION OF PLAN

The following description of the Computercraft 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Computercraft Corporation (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service, whichever is less. A participant may elect to classify all or a portion of an Elective Deferral as a Roth Elective Deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The company contributes a flexible discretionary match where the company can in its sole discretion choose the percentage of a Participant's Compensation or a discretionary dollar amount.

Participant Accounts – Each participant's account is credited with the participant's contribution, the company's matching contribution and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their accounts among available investment options.

Vesting – Participants are vested immediately in their contributions plus actual earnings or losses thereon. Participants are vested in the company's non-elective contributions 25% after 1 year of service, 50% after two years of service, and 100% after 3 years of service.

Participant Notes Receivable – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants cannot have more than one loan outstanding. The loans are secured by the vested balance in the participant's account and bear a fixed rate of interest at rates ranging from 8.00% to 9.50%. Principal and interest are paid through payroll deductions.

Payment Of Benefits – A Plan participant or beneficiary may receive lump-sum distributions equal to the value of the participant's vested interest in his or her account through eligible in-service distributions, termination of services or under specific situations of financial hardship.

Forfeited Accounts – Forfeitures of employer contributions resulting from the termination of participants with less than fully vested rights under the Plan shall be used to reduce future contributions. During 2024 and 2023, \$0 of forfeitures were reallocated to pay certain plan expenses. At December 31, 2024 and 2023, approximately \$91,900 and \$53,500, respectively, of forfeitures were available for future use.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation And Income Recognition – Investments in registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in insurance contracts are reported at contract value. Contract value is the price participants would receive if they were to initiate permitted transactions under the terms of the Plan.

See note D for discussion of fair value measurements. See Note E for discussion of insurance contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Use Of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment Of Benefits – Benefits are recorded when paid.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Plan Expenses – The majority of Plan expenses are paid by the Company, outside of the Plan.

Subsequent Events – The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through July 25, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENTS

Empower Annuity Insurance Company and Empower Trust Company, LLC, the current custodians of the Plan, have certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and its related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles which define fair value and establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INSURANCE CONTRACT

The Key Guaranteed Portfolio Fund is a fully benefit-responsive contract that is backed by the general account of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rates are reset quarterly.

NOTE F - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Empower Annuity Insurance Company, which is a related party as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$67,604 and \$6,116, respectively.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE H - TAX STATUS

The Plan has adopted a qualified (tax-exempt) prototype plan sponsored by Retirement Planners & Administrators, Inc. The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE I - RISKS AND UNCERTANTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.



