## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
OSA International, Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of OSA International, Inc. 401(k) Plan, (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

## NOTES TO THE FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF PLAN

The following description of the OSA International, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan’s provisions.

**General and Eligibility.** The Plan is a defined contribution plan, covering all employees of OSA International, Inc and its affiliates (collectively, the “Employer”) who are not leased, a non-resident alien, or someone acquired in a code section 410(b)(6)(C) transaction and who have attained the age of 18. Employees are eligible to participate in the Plan on the first day of the calendar month coincident with or next following the completion of 83 hours of service in a one-month period. If the service requirement is not met in the first consecutive period of 12 months, then the requirement will revert to 1,000 hours of service in one year. Participants are also eligible for discretionary Employer matching and profit-sharing contributions after a completion of one year of service defined as 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Voya Retirement Insurance and Annuity Company serves as both the “Custodian” and the “Trustee” of the Plan. The Plan’s investment assets are held by the Custodian in a trust. The Trustee is a qualified institution pursuant to ERISA.

**Contributions.** Participants may elect to defer a portion of their compensation, as defined in the Plan Document, subject to amounts established by the Internal Revenue Code (the “IRC”). All participants who reach age 50 by the end of the Plan year may also make additional catch-up contributions, subject to amounts established by the IRC. The Plan also allows for rollover contributions.

The Employer, at its sole discretion, may make Employer matching or profit-sharing contributions to the Plan on behalf of each eligible participant who is employed as of the last day of the Plan year. The Employer did not elect to make any discretionary Employer matching or profit-sharing contributions for the year ended December 31, 2024. The Plan also provides for a Qualified-Automatic Basic Safe-Harbor non-elective contribution that is 3% of eligible employee’s compensation.

**Vesting.** Participants are immediately vested in their contributions, safe-harbor non-elective contributions and the income earned thereon. Employer matching and profit-sharing contributions, and the income earned on such contributions, vests 33.33% after one year of service, 66.66% after two years of service and are 100% each year thereafter.

**Participant Accounts.** Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s elective contribution, rollover contributions, any Employer contributions, and the account’s earnings or losses, and charged with an allocation of expenses.

**Forfeitures.** Forfeited nonvested discretionary contribution account balances are utilized to reduce Employer contributions to the Plan or pay Plan expenses. Forfeited account balances totaled approximately \$1,200 and \$600 as of December 31, 2024 and 2023.

**Investment Options.** Participants may direct the investment of their accounts into various investment provided by the Plan. Participants are allowed to change their investment options daily.

**Notes Receivable from Participants.** The Plan provides loans to participants from their vested account balance ranging from \$1,000 to \$50,000, subject to a limitation one-half their vested account balance. Interest is charged on the loan and is fixed at the time of issuance at a rate of prime (7.5% as of December 31, 2024) plus 1.00%. Interest payments are immediately reinvested in the individual participant’s funds. The loans are collateralized by the vested account balance of the participant receiving the loan. Participants may have no more than two loans outstanding at any time. Loans are repayable in periods up to five years, unless used to acquire a place of residence. Should a participant default on a Plan loan, as defined by the Plan loan policy, the loan would then be considered a distribution.

## NOTE 1 – DESCRIPTION OF PLAN (Concluded)

**Payment of Benefits.** On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Party-in-Interest Transactions.** Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. These services are provided on behalf of the Plan, and the Employer has no plans to obtain reimbursement of these expenses from the Plan. The Plan is liable for all administrative expenses that are not paid by the Employer.

**Recent Legislation.** In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The Internal Revenue Service ("IRS") has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting.** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Concentration of Credit Risk.** Substantially all the Plan's assets were held by the Trustee.

**Estimates and Assumptions.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

**Investment Valuation and Income Recognition.** Investments are reported at fair value, except for certain investments as disclosed in Note 8 which are required to be reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

**Benefit Payments.** Benefits are recorded when paid.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The following is a summary of the unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedule that was prepared by the Trustee, and furnished to the Plan’s administrator (“Plan Administrator”). The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate:

- Investments and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- Supplemental Schedule: All investment balances.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

FASB *Accounting Standards Codification (“ASC”) 820, Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Pooled Separate Accounts.** Valued at the net asset value (“NAV”) of units held by the Plan at year end. The NAV is based on the fair value of the underlying mutual funds held by the account less its liabilities and then divided by the number of units outstanding. The mutual funds held in the accounts are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the accounts are deemed to be actively traded. NAV is used as a practical expedient to estimate fair value.

**Money Market Funds.** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common Collective Trust.** A stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**NOTE 5 – PLAN TERMINATION**

While it is the Employer's intention to continue the Plan indefinitely, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA and the Plan Agreement, as amended. In the event of Plan termination, all participants would become fully vested.

**NOTE 6 – INCOME TAX STATUS**

The Employer adopted a Non-standardized, Pre-approved, Prototype Profit-Sharing Plan, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the prototype Plan Agreement used by the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is exempt.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 8 – FULLY BENEFIT-RESPONSIVE CONTRACT**

The Plan holds a traditional investment contract, Voya Fixed Account, which meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

**NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Employer remitted participant deferrals totaling \$19,405 to the Trustee later than required by the Department of Labor ("DOL") Regulation 2510.3-102 during the year ended December 31, 2024 ("Late Remittances"). The DOL considers Late Remittances to be prohibited transactions. The Employer identified late remittances that occurred on January 12, 2024 and corrected the remittances January 30, 2024. Participant accounts were credited with the amount of investment income which would have been earned had the participant deferrals been remitted on a timely basis. The related excise taxes will be remitted in 2025.

**NOTE 10 – SUBSEQUENT EVENTS**

Management has evaluated all known subsequent events from December 31, 2024 through July 8, 2025 the date the accompanying financial statements were available to be issued, and is not aware of any material subsequent events occurring during this period.
