Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lobar Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lobar Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in NOTE 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lobar Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lobar Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

1. DESCRIPTION OF PLAN

The following description of the Lobar Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

A. GENERAL

The Plan was established by Lobar, Inc. effective January 1, 1986. The Plan is a qualified defined contribution plan covering all employees of Lobar, Inc. not covered by a collective bargaining agreement, who have completed three months of service, and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. CONTRIBUTIONS

All employees eligible to participate in the Plan are automatically enrolled in the Plan, at a rate of 8% of compensation unless they specifically elect out. Participants may contribute up to 100% of annual compensation, as defined in the Plan. These elective deferrals may not exceed the annual dollar limits established by the Internal Revenue Service. These salary reductions can be pretax 401(k) deferrals or Roth 401(k) deferrals. Participants may also contribute, with the employer's written consent, cash or property in a rollover contribution from another qualified plan. Employer contributions are made at the discretion of the Board of Directors. Participants must complete one year of service and be actively employed on the last day of the plan year to share in employer contributions, unless employment was severed due to death, disability, or retirement.

Participants may direct all of the contributions to their accounts in any ratio desired into any of the available investment options. Participants may change their investment allocation at any time during the plan year.

C. PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, an allocation of the employer's contribution, and an allocation of the Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (CONTINUED)

D. VESTING

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 100% vested after three years of credited service, upon death, disability, or reaching full retirement age.

E. PAYMENT OF BENEFITS

The Plan provides for in-service distributions of vested accounts to employees who have reached age sixty (60). Additionally, Roth 401(k) deferrals and earnings thereon can be distributed after the expiration of the five year participation period. The Plan also provides for hardship withdrawals that may be requested for medical expenses, the purchase of a home, educational expenses, payments to prevent participant's eviction from a principal residence or foreclosure, payments for certain burial or funeral expenses, or repairs to a principal residence that would qualify for the casualty deduction under the Internal Revenue Code. The distribution can be taken from eligible funds in the participant's account balance.

Upon termination of service, a participant is entitled to receive the vested portion of his/her account. If the value of a participant's nonforfeitable account balance is \$1,000 or less, the Plan will distribute the participant's account balance in cash. Account balances in excess of \$1,000 but less than \$7,000 will also be distributed from the Plan. The participant may elect to receive the distribution in cash or roll it over into an individual retirement account (IRA) or the qualified plan of a new employer. However, if the participant does not return election forms in a timely manner, the balance will be automatically rolled over into an IRA in the name of the participant. If the value of the participant's nonforfeitable account exceeds \$7,000, the account balance will only be distributed upon receipt of consent from the participant. The distribution can be by way of cash or rollover into an IRA or the qualified plan of a new employer. Absent consent of the participant, the account will be held by the Plan until which time the participant reaches the age where required distributions must occur.

F. FORFEITED ACCOUNTS

Forfeited nonvested accounts may be used to satisfy employer contributions or pay administrative expenses. As of December 31, 2024 and 2023, the balance held in this account was \$3,250 and \$85, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$839 and \$1,361, respectively, were utilized to offset employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting.

B. ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (NOTE 4). Management determines the Plan's valuation policies utilizing information provided by Lincoln Financial Group, the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. PAYMENT OF BENEFITS

Benefits are recorded when paid.

E. SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 2, 2025, the date which the financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, Lincoln Financial Group, the trustee of the plan, has certified the following information, which has not been subject to audit by independent auditors, to be complete and accurate:

- Investment balances included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and in the notes to the financial statements.
- Investment income balances included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets held for investment purposes at end of year.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS (CONTINUED)

Mutual Funds are assets that have been measured at fair value. They are valued at the net asset value of the shares held by the Plan at year-end, quoted in an active market; therefore, the mutual funds were valued using Level 1 inputs. There have been no changes in the methodology used as of December 31, 2024.

5. GROUP ANNUITY CONTRACTS

The Plan maintains a fully benefit-responsive group annuity contract. The contract is with the Lincoln National Life Insurance Company (LNLC), an affiliated entity of the Plan's custodian, called the Lincoln Stable Value Account. These investments are measured at contract value which is the net assets available for benefits based upon the group annuity contracts. The contract value of the Lincoln Stable Value Account was \$447,390 and \$515,980 as of December 31, 2024 and 2023, respectively. Contract value consists of participant contributions, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance companies. Such events include: (1) premature termination of the contracts by the Plan, (2) Plan termination, (3) bankruptcy. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance companies may not terminate the contracts at any amount less than the contract value.

LNLC is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on an index rate specified in the contract or a declared rate, either of which may be changed quarterly and will never be below the guaranteed rate. The crediting rate for the years ended December 31, 2024 and 2023 was 2.25% and 2.05%, respectively.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. The Plan was involved in several permitted related party and party-in-interest transactions during the years ended December 31, 2024 and 2023. The Plan was invested in the Lincoln Stable Value Account and various YourPath Mutual Funds. Lincoln Financial Group was the custodian of Plan investments and therefore is considered a party-in-interest. The Company paid \$9,128 and \$8,000 of administrative expenses for the years ended December 31, 2024 and 2023, respectively.

8. TAX STATUS

The Plan document was written using a volume submitter plan developed by its third-party administrator. The Internal Revenue Service has determined and informed the third-party administrator by advisory letter dated June 30, 2020 that their volume submitter plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
