INDEPENDENT AUDITOR'S REPORT

To the Trustees
OSCPA Group Health Trust
Beaverton, Oregon

Opinion

We have audited the accompanying financial statements of OSCP A Group Health Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of OSCP A Group Health Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of OSCP A Group Health Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about OSCP A Group Health Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of OSCP Group Health Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about OSCP Group Health Trust's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets held for investment purposes is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

OSCPA GROUP HEALTH TRUST NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of OSCP Group Health Trust (the Trust) provides only general information. Participants should refer to the Trust Agreement for a more complete description of the Trust's provisions.

General

The Oregon Society of Certified Public Accountants (OSCPA), an Oregon nonprofit corporation, established a trust effective January 1, 2014 to hold a group health insurance policy that serves as a funding vehicle for employee welfare benefits. Oregon-based CPA firms that are members of the OSCP are eligible to become participating employers in the OSCP Group Health Plan (the Plan). All such firms participate on a voluntary basis.

The purpose of the Trust and the Plan is to provide employee welfare benefits through one or more group policies issued by insurance carriers. Currently, the benefits are limited to medical, vision, dental and long-term disability insurance. The Plan is classified as a multiple-employer welfare arrangement (MEWA). The Plan provided coverage for 654 and 673 individuals as of December 31, 2024 and 2023, respectively, including member firm employees and their dependents. The Trustees oversee governance of the Trust.

Payment of Claims

The Trust benefits are fully insured. Benefits are provided under group insurance contracts between the Trustees of the Trust and Providence Health Plan and Oregon Dental Service dba Delta Dental Plan of Oregon (the Insurers). Under the insurance contracts, the Insurers, not the Trustees, are responsible for paying claims; however, the Trustees and the Insurers share responsibility for administering the Plan's eligibility and enrollment requirements. The Trustees have given the Insurers discretionary authority to determine eligibility for benefits under the Plan and to interpret the terms of the Plan. The Insurers are the contract administrators for the benefits under their insurance policies, and they are responsible for determining to what extent claims are payable, paying claims, and handling any appeals.

Because no claims are paid by the Trust, no provision for claims incurred but not reported is included on the accompanying statements of net assets available for benefits.

Administrative Fees

Insurance premiums for covered employees are paid directly to the Insurer by participating employers. As compensation for its roles in administering the Trust processes, the Trust receives a monthly administrative fee. Effective in 2024, the administrative fee is a fixed, flat monthly amount agreed upon between the Trust and broker. This fixed amount was \$3,770 for the year ended December 31, 2024. Prior to 2024, the Trust received an administrative fee of 1 percent of total premiums paid by participating employers to the insurers on a monthly basis. Administrative fees due to the Trust from the Insurers for premiums paid in the previous year total \$3,770 and \$3,555 as of December 31, 2024 and 2023, respectively, and are included on the accompanying statements of net assets available for benefits as a receivable.

1. Plan Description, continued

Administrative Expenses

Expenses of maintaining the Trust are paid from Trust assets, including all professional fees, an administrative reimbursement charge to OSCP, and fidelity insurance costs, except for certain insurance endorsements that may not legally be paid from Trust assets and are paid directly by the OSCP. Fees paid directly by the OSCP are excluded from these financial statements.

Plan Administration

The Plan is administered by an eleven-member Board of Trustees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan contracts with a licensed health insurance broker, The Partners Group, to assist in selecting the Insurers, administering enrollment, and negotiating the rates to be paid by the participating employers.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Trust are prepared on the accrual basis of accounting.

Administrative fees

Administrative fees are recognized as revenue in the period earned, which is generally the period in which the underlying premiums are paid by participating employers. Certain variable amounts received from the broker in connection with premiums paid by participating employers that cannot be reasonably estimated, are recognized in the period determined and collection is deemed probable.

Certificate of Deposit

Certificates of deposit with original maturities in excess of three months are classified separately from cash and are recorded at cost plus accrued interest. Interest income is recorded on the accrual basis.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial asset held by the Trust that is subject to ASC 326 is administrative fee receivable.

The Trust adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. Cash and Investments

Cash consists of funds deposited in a local depository non-interest-bearing checking account. Balances in this account are currently insured by the Federal Deposit Insurance Corporation up to \$250,000. The account balance did not exceed this insured limit at any time during the years ended December 31, 2024 and 2023.

In 2022, the Trust opened a certificate of deposit with Umpqua Bank (formerly Columbia State Bank), the Trust's primary financial institution. The certificate of deposit held by the Trust carried an interest rate of 0.06 percent for a 12-month term. In 2023, the Trust renewed the certificate of deposit which carried an interest rate of 3.445 percent for a 13-month term ending April 30, 2024. In 2024, the Trust renewed the certificate of deposit which carried an interest rate of 3.830 percent for a 13-month term ending May 30, 2025.

4. Related Party and Party-in-Interest Transactions

Administrative fees are paid to the Trust by the Insurers, based on a percentage of premiums paid by participating employers, for administering the premiums of the participating firms and participants, as discussed in Note 1. These transactions qualify as party-in-interest transactions as defined by ERISA.

The Plan's contracted insurance broker does not receive compensation directly from the Trust, but receives compensation from the Insurer based on a percentage of premiums.

Two executives of OSCPAserve as Trustees of the Trust. No Trustee receives direct compensation from Trust assets for their services; however, some trustees may be participants under the normal terms of the Plan.

The Trust pays OSCPAs a direct cost reimbursement for administrative and management services provided to the Trust by OSCPAs employees under a written arrangement approved by the Trustees in 2015. At December 31, 2024 and 2023, the amounts due to OSCPAs under this arrangement were \$11,073 and \$17,399, respectively.

All of the Trust's related party and party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

5. Plan Termination

Although the Trustees have not expressed any intent to discontinue contributions into the Trust and terminate the Trust Agreement, they may do so at any time subject to the provisions set forth in ERISA.

Should the Plan and the Trust terminate, under no circumstances may any Trust assets transfer to the OSCP or to any participating employer. Any assets remaining after satisfying the liabilities of the Trust must be used to provide medical, dental, or other approved benefits to Plan participants.

6. Tax Status

The Trust is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust and Plan's net income are exempt from federal and state income taxes. The Trustees believe that the Trust and the Plan, as amended, continue to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

U.S. GAAP requires the Trustees to evaluate tax positions taken by the Trust and recognize a tax liability (or asset) if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Trust is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Trust may invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Reclassifications

Certain 2023 amounts were reclassified to conform to 2024 presentation. These reclassifications had no effect on previously reported net assets available for benefits or changes in net assets available for benefits.

9. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.


