Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements (Continued)

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.



1. Description of Plan

The following description of the Kreischer Miller Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the plan document describing employee benefits for a more complete description of the Plan's provisions.

General and Amendments

The Plan is a defined contribution profit-sharing plan covering all employees who have attained the age of 21 and have completed one month of service. Employees become eligible on the first day immediately following satisfaction of the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan trustees are responsible for oversight of the Plan. The plan trustees also determine the appropriateness of the Plan's investment offerings and monitor performance.

The Plan was amended effective April 13, 2020 to expand the sources available for hardship distributions and to permit such distributions in the event of certain disasters. The Plan was further amended effective May 11, 2020 to eliminate the fixed matching contribution, and to implement a discretionary matching contribution thereafter. On April 7, 2021, the Plan was amended to reinstate the fixed matching contribution and to change the participant entry date from the first day of each quarter to the first day of each month.

The Plan was amended effective January 1, 2016, to bring the plan into compliance with the Pension Protection Act of 2006 and other regulatory changes.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Employees may elect to make contributions as either pre-tax or post-tax (Roth) contributions. The employer contributes 50% of the first 4% that a participant contributes to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. In addition, participants may make additional voluntary, post-tax contributions in excess of elective pre-tax or Roth deferrals. Contributions of distributions from other qualified plans and voluntary, after-tax contributions are not eligible for the employer match.

The terms of the Plan provide that the employer may make a discretionary contribution each plan year. To participate in this discretionary contribution, a participant must have provided one month of service to the employer in the plan year and must be employed on the last day of the plan year. There was no discretionary contribution made by the employer in 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contribution, an allocation of discretionary employer contributions, if any, an allocation of plan earnings and certain transaction expenses related to participant transactions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years. The loans are secured by the vested balance in the participant's account and bear interest at rates consistent with Section 4975(d)(1) of the Internal Revenue Code (IRC) and other legal requirements. The rates are to remain fixed throughout the duration of the loans. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits

Upon termination of service, a participant with an account balance in excess of \$1,000 may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments. A participant with an account balance of \$1,000 or less will automatically receive a lump-sum payout.

Participants who have made voluntary after tax contributions, may, after age 50, request an in-service distribution of the voluntary after tax contribution plus any earnings.

Forfeited Amounts

Forfeitures of non-vested account balances of former participants remain with the Plan and are used to reduce employer contributions or to pay administrative expenses otherwise payable by the Plan. At December 31, 2024 and 2023, there were \$42,818 and \$40 of forfeited, non-vested accounts, respectively. Plan forfeitures of \$29,148 and \$14,969 were used to reduce the employer matching contributions during the year ended December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan payments and the plan administrator deems the participant to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of the Plan are paid by both the Plan and the Plan's sponsor. Costs of the Plan paid by the Plan and by the Plan's sponsor were \$81,972 and \$11,612 for the year ended December 31, 2024. Investment-related expenses are included in the computation of net appreciation of fair value of investments.

Subsequent Events

The Plan had performed an Evaluation of subsequent events through July 18, 2025, the date the financial statements were available to be issued. See Note 9.

3. Investments Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.130-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the custodian, has certified the following as complete and accurate:

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the assets or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

(4) Fair Value Measurements, Continued

Collective investment trusts: The Plan invests in certain collective index funds, managed by flexPATH Strategies, LLC, within the Great Gray Collective Investment trust formerly called the Wilmington Trust Collective Investment Trust. These underlying collective trusts are valued based upon the net asset value (NAV) of units of the collective trusts as reported to the Plan by the trusts. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value. The units of each share class of the collective trusts are valued daily based on closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trust, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different instruments could result in a different fair value measurement at the reporting date.

5. Related Party Transactions

Certain Plan investments are managed by T. Rowe Price. T. Rowe Price Trust Company, a wholly-owned affiliate of T. Rowe Price, is the custodian of the plan assets and, therefore, transactions with T. Rowe Price qualify as party-in-interest transactions under ERISA that are exempt from prohibited transaction rules. In addition, the Plan's sponsor has elected to pay certain administrative expenses of the Plan. Expenses paid by the Plan's sponsor represent fees for administrative expenses.

6. Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Company has adopted a Pre-Approved Profit-Sharing Plan sponsored by T. Rowe Price Trust Company. The Pre-Approved Profit-Sharing Plan received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the Plan's qualified status. The Pre-Approved Profit-Sharing Plan opinion letter has been relied upon by this Plan. The IRS has ruled the Pre-Approved Profit-Sharing Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Subsequent Events

Effective January 1, 2025, the Plan was amended to add Bradley J. Runyen, PC, Katrina R Samarin PC, Elizabeth F. Pilacik, PC, and Kathryn J Stewart PC as participating Employers to the Plan.

Effective January 1, 2025, the Plan was amended to remove Lisa G. Pileggi as a participating Employer to the Plan.
