### 1. Description of Plan

The following description of the Central States Industrial Equipment and Service, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Central States Industrial Equipment and Service, Inc. and Stainless Products, LLC (the Company). To be eligible to participate in the Plan, employees must have completed two months of service and be age 20.5 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective June 23, 2023 all plan assets were transferred from Newport Trust Company to Ascensus Trust Company.

**Contributions:** Participants may contribute a percentage of their annual wages by way of salary reductions as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may make discretionary matching contributions to the Plan. The Company matched 50% the participant's salary reductions of up to 10% of the participant's compensation for the years ended December 31, 2024 and 2023. The Company may also make a discretionary contribution to the Plan, allocated to each participant as a uniform percentage of compensation. The Company did not make a discretionary contribution to the Plan during 2024 or 2023. Contributions are subject to certain IRS limitations.

**Participant accounts:** Each participant's account is credited with (a) the participant's contribution, (b) the Company's elective and matching contributions, if any, (c) Plan earnings, (d) fees and (e) forfeitures. Net income and asset revaluations are allocated to each participant based upon the earnings of the investments selected by the participant or based upon the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant is fully vested after six years of credited service.

**Payment of benefits:** Participants who terminate service and have account balances of \$1,000 or less will receive an automatic distribution of that balance. Participants with account balances that exceed \$1,000 may elect to receive a lump-sum amount equal to the value of the vested interest in their account. Participants with account balances that exceed \$5,000 may also elect to receive annuity payments or installments for a fixed period not to exceed their assumed life expectancy.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 4.25% - 9.50% which is commensurate with prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Forfeitures:** Forfeitures may be added to any employer discretionary or matching contribution and allocated in the same manner or be used to reduce employer matching contributions. Forfeitures in the amount of \$50,003 and \$40,000 were used to reduce the employer matching contributions for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, remaining forfeitures in the amount of \$38,184 and \$51,554, respectively, were available to be used.

## 2. Summary of Accounting Policies

**Basis of accounting:** The Plan's policy is to prepare its financial statements on the modified cash basis of accounting; consequently, certain revenue and the related assets are recognized when received rather than when earned and certain expenses are recognized when paid rather than when the obligation is incurred. This basis has been modified to record investments at fair value.

**Estimates:** The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of benefits:** Benefits are recorded when paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### 3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

### 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

### 5. Separated Participants

At December 31, 2024, there were no participants who had terminated from active service with the Company with an account balance of \$1,000 or less who were due to receive an automatic distribution of that account balance in accordance with the plan document.

### 6. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan Asset Custodians, Newport Trust Company (for the period January 1, 2023 to June 23, 2023) and Ascensus Trust Company (for the period June 24, 2023 to December 31, 2024).

### 7. Related-Party Transactions and Party in Interest Transactions

Certain employees of the Company serve as the Plan's trustees. The trustees do not receive any compensation for services rendered to the Plan.

The Plan incurs expenses related to general administration and recordkeeping. The Plan sponsor pays certain accounting and auditing fees relating to the Plan.

### 8. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and common collective trust funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end. The funds held by the Plan are deemed to be actively traded.

The methods previously described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 9. Tax Status

The prototype document adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax. The Plan has been amended and restated since receiving the determination letter. Plan administration believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 10. Subsequent Events

In June 2025, the Plan transferred its assets and recordkeeping to Fidelity Investments and Fidelity Management Trust Company was named trustee of the Plan. With this change, the Plan adopted a new plan document which changed the age of eligibility from 20.5 to 18 and the threshold of automatic distribution of separated participants from \$1,000 to \$7,000.

Management has evaluated subsequent events between the end of the most recent fiscal year end and July 25, 2025, the date the financial statements were available to be issued.
