Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Heat Transfer Research, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Heat Transfer Research, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. December 31, 2024

1. Plan Description

The following description of the Heat Transfer Research, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Heat Transfer Research, Inc. (the "Company"), who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 70% of annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan sponsor may make discretionary matching or nonelective contributions to the Plan. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and the employer's contribution. Allocations are based on participant earnings or account balances, as defined. Each participant is entitled to the benefit that can be provided from his or her vested account.

Vesting

Participants vest immediately in all contributions plus actual earnings thereon.

Forfeited Accounts

Forfeited accounts may be used to reduce future administrative expenses or plan sponsor contributions. At December 31, 2024 and 2023, the balance of forfeited non-vested accounts was \$175 and \$166, respectively.

Notes receivables from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000. There is a maximum of one outstanding and pending loans allowed. Loans have a maximum maturity of 5 years for most loans and 15 years for the purchase of a primary residence. 1. Plan Description

The following description of the Heat Transfer Research, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Heat Transfer Research, Inc. (the "Company"), who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 70% of annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Notes receivables from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000. There is a maximum of one outstanding and pending loans allowed. Loans have a maximum maturity of 5 years for most loans and 15 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest on loans is to be repaid through payroll deductions.

Payments of benefits

Plan benefits are available upon attainment of 59 ½ years, hardship, termination of employment, death, disability, or retirement. Participants with a vested account balance greater than \$5,000 may also elect to defer payment of his or her account.

The Plan also allows for in-service withdrawals in limited circumstances, as defined by the Plan.

Fees for the administration of notes receivable from participants are charged directly to the participant's account.

The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

8. Plan administration

Certain administrative functions are performed by officers or employees of the plan sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid by the Plan.

9. Risks and uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
