### 1. Description of the Plan

The following brief description of the Advanced Pathology Solutions, PLLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan is a defined contribution plan and is sponsored by Advanced Pathology Solutions, PLLC (the Company), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The original effective date of the Plan was January 1, 2015, and restated on January 1, 2022. Effective January 1, 2024, the Plan was amended to change the Plan name from Advanced Pathology Solutions, LLC 401(k) Plan to Advanced Pathology Solutions, PLLC 401(k) Plan.

#### *Eligibility*

All employees are eligible for participation upon attainment of age 21. For participant deferrals and safe harbor matching contributions, there is no service requirement, and enrollment is allowed immediately upon reaching eligibility. For other Company contributions, there is a 1-year service requirement and enrollment is allowed on the first day of the 1<sup>st</sup> and 7<sup>th</sup> months of the Plan year after eligibility is met. Long-term part-time employees who met eligibility requirements under SECURE 2.0 are also eligible to participate in the Plan.

#### *Contributions*

Each year, eligible employees may elect to contribute up to 100% of their eligible compensation to the Plan, not to exceed the limit in Section 402(g) under the Internal Revenue Code (IRC). Eligible employees who have attained age 50 before the close of the Plan year are allowed to make catch-up contributions up to the maximum allowed by the IRC. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. A current description of the investment funds may be obtained from the Plan administrator.

The Company has elected to make a Company safe harbor matching contribution of 100% of the participant's deferrals up to the first 3% of compensation, plus 50% of the participant's deferrals up to the next 2% of compensation. The Company may also make discretionary Company contributions. No such discretionary Company contributions were made for the year ended December 31, 2024.

#### *Participant Accounts*

Each participant's account is credited with the participant's salary deferral contributions, allocations of any Company safe harbor matching contributions and any discretionary Company contributions (collectively, Company contributions), and his/her share of the Plan's income (loss). The Plan's income (loss), with respect to each investment fund, is allocated based on the proportion that each participant's account balance invested in such fund compared to the total of all participants' account balances invested in such fund.

#### *Vesting*

Participants are immediately vested in the value of their salary deferrals, Company safe harbor matching contributions, and rollovers, plus related investment earnings.

During 2024, the Company sold a division of the business which resulted in a partial plan termination. Those effected participants became fully vested in all funding sources and were allowed the option to take a full distribution or remain in the Plan.

#### *Payment of Benefits*

Participant accounts may be withdrawn upon retirement, death, disability, or termination of employment. Participants may elect to have distributions paid in a lump-sum and are either paid directly to the participant or rolled over to another qualified retirement plan. Installments are permitted only for required minimum distributions. The Plan also allows for in-service withdrawals upon attainment of age 59½ or upon incurring a disability, along with withdrawals in the event of a financial hardship.

#### *Forfeitures*

The Plan allows forfeitures to be used to reduce Company contributions or pay Plan expenses. During the year ended December 31, 2024, forfeited funds in the amount of \$633 were used to offset Company contributions. Unused forfeitures available for use at December 31, 2024 and 2023 were \$8,149 and \$0, respectively.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investment income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Payment Benefits*

Benefit payments to participants are recorded upon distribution.

#### *Plan Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Fees related to administration of distributions are taken out of the gross distribution to the participant. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, John Hancock Life Insurance Company (U.S.A) (John Hancock), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described below:

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

#### *Basis of Fair Value Measurement (cont.)*

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Accounts* - The fair value of the pooled separate accounts is based on the net asset value (NAV) of the account calculated based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The Plan's investments at fair value as of December 31, 2024 and 2023 are made up entirely of pooled separate accounts, which is measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2024 and 2023 that are classified in the fair value hierarchy.

### 5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by Frost PLLC (Frost). The Internal Revenue Service (IRS) has opined and informed Frost by a letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

### **5. Tax Status (cont.)**

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan administrator will facilitate the distribution of account balances under the provisions of the Plan and trust agreement until all assets have been distributed.

### **7. Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The recordkeeping and custody functions for the underlying investments held by the Plan are performed by John Hancock. Usual and customary fees were paid for investment management services. Plan investments are also managed by John Hancock. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

### **8. Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through July 16, 2025, which is the date the financial statements were available to be issued and has determined that no significant events occurred after December 31, 2024, but prior to issuance of these financial statements, that would have a material impact on its financial statements.
