- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the DriveTrain Group Holding Corporation Employees' Savings Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

General: The Plan is a voluntary, contributory, defined contribution plan available to all eligible employees of Drive Train Group Holding Corporation and its subsidiaries (the "Company") that are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee: Bank of America, N.A. ("Trustee") is designed as the trustee of the Plan.

Contributions: Plan participants may contribute to the Plan on a before-tax and/or after-tax basis through regular payroll deductions. Eligible participants may elect to contribute 1% up to 30% of base pay on a before-tax basis and/or 1% up to 30% of base pay on an after-tax basis; however, the total may not exceed 60% of the base pay and is also subject to certain Internal Revenue Code (the "IRC") limitations. Participants age 50 and over are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualifying defined-benefit or defined-contribution plans.

As described in the plan document, supplemental Company contributions equal to a percentage of wages (to be determined annually at the discretion of the Company's Board of Directors) can also be contributed into the Plan. The Plan allows for discretionary employer matching contributions, as determined periodically by the Corporation's Board of Directors. Matching contributions are based on deferrals up to 4% of eligible compensation per payroll period and are allocated only to participants actively employed in the plan on the last day of the applicable payroll period. On March 13, 2024, the Board authorized a temporary reinstatement of the employer match, effective April 1, 2024. Subsequently, employer matching contributions were suspended through the remainder of 2024 as of April 30, 2024, for salaried employees and May 5, 2024 for hourly employees.

Participant Account and Investment Options: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, any supplemental Company contribution, an allocation of the Plan's earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Various investment options are offered under the Plan. All amounts in participant accounts are participant directed.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on years of continuous service. Generally, a participant becomes 40% vested after completing two years of service as defined in the Plan. Their vested percentage increases 20% per year for years three through five and becomes 100% vested after five or more years of credited service. However, due to reductions in the Company's labor force during 2009, a partial plan termination was deemed to have occurred. As a result, all affected participants were considered 100% vested in their full account balances when terminated.

Notes Receivable from Participants: Participants may have one general-purpose loan and one residential loan from the Plan at a time. Participants may borrow from their accounts a minimum of \$500 for a general-purpose loan and \$1,000 for a residential loan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years for general-purpose loans, or up to 25 years for loans used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, the Plan generally distributes benefits as a lump-sum amount. Distribution options include direct rollover to another tax-qualified plan or an individual retirement account. For termination of service for other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution. Vested benefits of \$5,000 or less will be distributed as a single lump-sum payment as soon as practicable following the event entitling distribution. Hardship withdrawals and certain in-service withdrawals are also provided for under the terms of the Plan.

Forfeitures: In the event a participant terminates prior to becoming fully vested, the nonvested forfeitures are available to be used to reduce employer contributions and pay administrative expenses of the Plan. Forfeitures available for future use at December 31, 2024 and 2023 were approximately \$684 and \$4,018, respectively. For Plan year 2024, \$10,680 of forfeitures were used to pay administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Expenses of the Plan: The Company pays certain expenses of the Plan and provides certain administrative services at no cost to the Plan. If not paid by the Company, administrative expenses become a liability of the Plan. In 2024 and 2023, the Plan paid investment management and administrative fees. Certain management fees charged to plan mutual funds are deducted from income earned on a regular basis and are netted with the investment returns on such investments. All other expenses were paid by the Company.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties: The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated investment income (loss) and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Bank of America, N.A, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan follows the provisions of Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") No. 820, *Fair Value Measurements*. ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted process that are observable for the asset or liability; or inputs that are derived principally from or corroborated by the observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in methodology in 2024 and 2023.

* The Plan uses net asset value (NAV) as a practical expedient to determine the fair value of its investment in the Invesco Trust as of December 31, 2024 and 2023. The Invesco Trust seeks to preserve principal investment while providing a competitive level of income over time that is consistent with the preservation of capital. The Invesco Trust allows for daily liquidity with no additional days of notice required for redemption. It is the policy of the Invesco Trust to use its best efforts to preserve principal, although there is no guarantee that the Invesco Trust will be able to maintain or grow its value. NOTE 5 - INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated August 26, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended and restated since receiving the determination letter. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan as amended and restated is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

NOTE 6 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions set for in ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Bank of America, N.A. acts as the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Bank of America, N.A. qualify as party-in-interest transaction. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through the related mutual funds, rather than a direct payment. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 8 - SUBSEQUENT EVENTS

The Plan Administrator evaluated its December 31, 2024 financial statements for subsequent events through July 28, 2025, the date the financial statements were available to be issued.
